# **Reserve Grand Champion**



Every year at EAA AirVenture Oshkosh, hundreds of aircraft arrive to be entered into competition for the highly sought-after Lindy Awards. Named after legendary aviator Charles Lindbergh, the Lindy Awards are given out to only the best of the best.

Aircraft can be entered into one of six categories: Homebuilts, Warbirds, Vintage, Ultralights, Seaplanes, and Rotorcraft. Aircraft can only be entered in one category per year, and are not eligible for the same or lower tier awards if it has won in the past.

Lindy Award judging takes into account how an aircraft looks, of course, but the degree of craftsmanship involved plays an important role as well. Award-winning aircraft don't just look pretty, they are carefully built, restored, and/or maintained by owners who take great pride in them.

For the 2017 competition, Chapter 18's own Jim Kidd brought his beautiful Skybolt and walked away with a Silver Lindy for the outstanding representation of a Plans Built aircraft. It was a labor of love for Jim to build his bi-plane and we can expect to see him vying for the Gold Lindy at Airventure 2018.



# **Reserve Grand Champion**



In 1995, Jim purchased a set of plans from Hale Wallace of the Steen Aero Lab, who eventually became a dear friend, confidant, and building coach. Construction began in early 1997 with the purchase of materials to construct the "built up" wing ribs. The project would eventually take over 18 years to complete. The first 12 years was spent finding time to fabricate, weld, glue, assemble, and craft every part and component of the plane, while raising 3 children and supporting their competitive hockey teams. All painting, finishing, and assembly and unique detailing, was done with the dream of creating a very special airplane clearly in mind.

When the final rigging was done (a pretty big deal on a bi-plane) it was accomplished with the use of a water level. All measurements and settings: wing tip to wing tip level, angle of incidence and airframe square were held within 1/16th inch.

This accuracy and attention to detail was rewarded when no lateral stick movement was necessary when the Skybolt came off the ground on the first flight. No additional adjustments have been required to date.

The Skybolt is now a Silver Lindy winner and there will be gold in this plane's future. Good luck, in 2018, Jim







Homebuilt Camping

One of the most popular ways to experience EAA AirVenture is to camp, often by setting up a tent under the wing of your own airplane. It's common knowledge that the airport becomes the busiest on earth, during the event. At Wittman Field, there were 17,223 aircraft operations in the 10-day period from July 21-30, which is an average of approximately 123 takeoffs/landings per hour. Many members of Chapter 18 participated as EAA Volunteers to ensure that many of these aircraft safely found their way to areas designated as Homebuilt Parking or Camping.

































### ATC Privatization Could Cost \$100 Billion

ATC privatization as proposed in the 21st Century Aviation Innovation, Reform, and Reauthorization Act (H.R. 2997) would add nearly \$100 billion dollars to the federal deficit over the next 10 years, according to updated figures released this week by the nonpartisan Congressional Budget Office.



This latest estimate, increased from a \$20 billion budget deficit estimate made just a few months ago, is yet another reason why this proposal is not only bad for general aviation, but bad for the nation overall. EAA and its members have been actively engaged in the fight against ATC privatization, which would hand control of the nation's airspace to a private, nonprofit corporation governed by a board dominated by the airlines and other commercial and financial

interests. With no congressional oversight, the board would be accountable to no one; devastating general aviation, your freedom of flight, rural and GA airports, and the fly-ins and aviation activities you enjoy.

In addition, Fox News last week published an editorial criticizing the proposed legislation, saying H.R. 2997 has little semblance to private enterprise, with "no entrepreneurs, and no competition, and no prices," and that ATC privatization would instead be a government-mandated monopoly.

Despite promises from lawmakers that ATC user fees will not be introduced, \$100 billion in funding would need to come from somewhere. That cost burden would likely fall to general aviation pilots and

other small users of the system with little representation on the privatized board, in addition to the flying public through higher airline ticket prices.

Although H.R. 2997 did not have enough support for a full House vote prior to Congress' August recess, proponents are still hard at work gathering support to move the bill to the floor when Congress reconvenes in September. 
