### **FAA Announces Aeromedical Reform Rule**

New law takes effect May 1

January 10, 2017 - Years of effort by EAA and AOPA culminated on Tuesday morning as the FAA announced regulations that will implement the aeromedical reform law passed last July. The regulations will be published Wednesday as a final rule, to take effect May 1, 2017. According to the FAA, no changes have been made to the language in the law.

Because it is final, the rule will not go out for a typical public comment period. The FAA also said it would publish an advisory circular describing the implementation of the rule later this week.

"This is the moment we've been waiting for, as the provisions of aeromedical reform become something that pilots can now use," said Jack J. Pelton, EAA CEO/chairman. "EAA and AOPA worked to make this a reality through legislation in July, and since then the most common question from our members has been, 'When will the rule come out?' We now have the text and will work to educate members, pilots, and physicians about the specifics in the regulation."



### An email received by Tim Meyer a few weeks ago

Dear Tim,

This is to express our family's thanks and appreciation for the beautiful floral arrangement from Chapter 18 for the funeral of our beloved father, Tony Wojnar. I know Dad would feel honored and humbled that he was remembered in that way. Dad was involved with Chapter 18 from the very beginning, as he worked directly for Paul Poberezny beginning in 1953 at the Wisconsin Air National Guard during their "day jobs". I noticed that his name is not on the Chapter 18 charter. but probably because he was on a trip with the ANG on the night of that meeting. Naturally, Paul recruited people who worked for him as some of the first EAA volunteers, and Dad was among them. He did things like painting the background for the sign announcing the future site of the EAA headquarters and museum in Franklin, and moving the surplus military jets from Mitchell Field to the EAA site. When he would work on EAA's airplanes in the ANG hangar to prepare them for display, he would take me along.

I was too young to go with Dad as the meetings lasted way beyond my bed time, but he always talked about the Chapter 18 meetings he attended at Hales Corners airport and Sweeney's Silver Dollar in Hales Corners. He was chapter treasurer in 1970. Dad and I produced the 1978 Grand Champion Classic at Oshkosh in 1978, my Aeronca 7AC.

I could go on and on, but let me just say that my father and Paul were, and always will be, my heroes (and I told them that). I have attached an article that probably helps explain why Dad and I have been so close to EAA, although we have not been very active in Chapter 18 lately.

It was a very thoughtful and much appreciated gesture for Chapter 18 to send the floral arrangement. We are very grateful for that.

### Chapter 18 Minutes from the November "2016" Meeting

Announcements: Hops and Props will take place at EAA museum on March 4th, 2017. The December board meeting will take place at EI Fuego on December 13th and is open to all. The October dinner meeting will be held at the Machine Shed again next year and Dave Hoefgen will coordinate the event. Several certificates and pins were presented to Chapter officers, tech counselors, Young Eagle coordinators and newsletter editor.

Jeff Point displayed the rudder for his Breezy which he has just finished painting using the Stewart System. He expects to have the wings painted before the end of December. Bill Stilley reports that his KitFox is now at Capitol DR. airport and has the wings mounted. He is now testing the fuel system.

**Flying Reports:** Don Patterson reported flying his RV-7A to Hilton Head and to Kitty Hawk. The return flight to East Troy took 5-1/2 hours. Jeff Wisneski reported on buying an Avid NK-4 in North Carolina and flying it back with Nick Heffron. Due to weather and a flat tire, it took 12-1/2 flight hours to return to Milwaukee. At this time, he is doing some minor maintenance on the plane.

New Business No new business was discussed.

The treasurer's report was approved as published. Minutes from the September meeting were accepted as published.

Break was taken and then followed with the EAA Chapter videos program.

Tuesday's announcement finalized the highly anticipated measure that was signed into law last July as part of an FAA funding bill. That was the ultimate success of a long effort by EAA and AOPA to bring significant aeromedical reform to pilots flying recreationally and eliminate the time and expense burdens on those holding third-class medical certificates.

The law guaranteed that pilots holding a valid third-class medical certificate issued in the 10 years before the reform was enacted will be eligible to fly under the new rules. New pilots and pilots whose most recent medical expired more than 10 years prior to July 2016 will be required to get a one-time third-class exam from an FAA-designated AME.

The FAA was required to implement the law within 180 days of its signing, or this Thursday (January 12). Since AirVenture 2016, FAA senior leadership has been assuring EAA that the 180-day deadline would be met. Despite the release of the regulations as a final rule, EAA will be reviewing the language carefully to ensure it fully reflects the language and intent of the law.

EAA has updated its Q&A and will continue to update them to provide the latest information. EAA is also working with its aeromedical and legal advisory councils to provide resources that will help members and their personal doctors understand the provisions of the new regulations.


