EAA Chapter 211 Meeting Minutes – 2015-12-04

Attendance: 26

Call to order and Pledge of Allegiance – 19:35

The Dec. 4 Chapter 211 meeting was called to order by President Tom Marotta.

Attendance and Visitors:

A total of 23 members were in attendance at the November meeting. There were no visitors.

Event and Meeting Dates:

The next regular meeting will be January 8, 2016.

The Christmas gathering with Chapter 504 will be on December 12. It was noted the 6:00p.m. gathering will take place in Gordon Gilcrest's hangar at the Paul C. Miller-Sparta Airport. It was also explained that Chapter 211 will be furnishing meat, coffee, soft drinks and water for the gathering and members should bring a dish to share and table service (and Holiday spirits if so desired)!

Previous Meeting Minutes:

A motion was made, seconded and unanimously passed to accept the November 6, 2015 meeting minutes.

Treasure's Report and the Past Month's Expenses and Receipts:

We had receipts/donations of \$14.00 (coffee fund) and expenses of \$231.21 The expenses include \$33.46 of supplies, newsletter costs and cookies, and \$197.75 from the summer picnic. The checkbook balance is \$3441.81. Petty cash balance is \$45.35. This gives us a total Chapter 211 current meeting fund balance of \$3,487.16. As a note, we will have our annual EAA Chapter dues and insurance expense of about \$450.00 due in mid December and the Christmas gathering expenses. Last year at this time we had a fund balance of about \$3950.00. Motion to approve was made and seconded to accept the treasure's report and was unanimously passed.

Chapter Membership and Dues:

We ended the year with 49 members (48 paid members). It was noted that next years dues are due! It was explained, that on the envelopes provided to simply print (CLEARLY) your name and EAA membership number along with \$22 (or \$25 if member wants newsletter mailed). In addition, members please note any corrections or new information you want added to our "data-base".

Elections and Next Year Broad of Directors:

The 2016 officers are President Dan Whisman, Vice President Warren Roosen, and Bob Vink. Bob Kenrick and Dale Hagen (if time permits) have been elected Broad members for next year. We thanked outgoing Tom Marotta, Walt Clawson and Earle Bares for their service during the last two years.

Technical Reports:

Jack Brewer noted the FAA will make a presentation at Sparta on the December 12th. Gary Van Farowe talked about the need to thoroughly inspect your airplane heating system for upcoming months. Get a carbon monoxide indicator for your cockpit (I guess this advice would also apply to your home). He also talked about the wing corrosion problem on the Cessna 177 wing spar and the need for inspection. Corrosion is always a problem to check in any metal structure. Tom Marotta discussed his continuing starter problem (the "new" starter did not match up to the flywheel correctly).
