EAA Chapter 211 Meeting Minutes - 2015-11-06

Attendance: 26

Call to order and Pledge of Allegiance - 19:35

The Nov. 6 Chapter 211 meeting was called to order by President Tom Marotta.

Attendance and Visitors:

A total of 25 members and family along with 1 visitor were in attendance at the November meeting. We welcomed visitor Ethan Beswick from Holland. Ethan is in the process of starting to build an airplane (RV-9).

Event and Meeting Dates:

The next meeting will be December 4th. The Christmas gathering will be on December 12th.

Previous Meeting Minutes:

A motion was made, seconded and unanimously passed to accept the October 2^{nd} , 2015 meeting minutes.

Treasure's Report and the Past Month's Expenses and Receipts:

We had receipts/donations of \$17.05 (coffee fund) and expenses of \$15.10 (newsletter) which gives us a total Chapter 211 current meeting fund balance of \$3,718.37. The checkbook balance is \$3639.56. Petty cash balance is \$78.81. (It is noted that picnic expenses have not yet been included.) Motion to approve was made and seconded to accept the treasure's report and was unanimously passed.

Chapter Membership:

We now have 49 members this year. Many of you still owe us your EAA membership number. We noted that 2016 membership dues are payable at next meeting.

A "get well, we miss you" card was sent to Chet Uncapher. Various members have talked to Chet and he appears to be getting somewhat better. Non-the-less we wished him well and do miss his and Patty's attendance at the meetings.

Technical Reports:

Jack Brewer did not have any technical reports. Gary Van Farowe was not in attendance. Tom Marotta talked about his Sky-Tec starter. Even thought it was out of warranty, Sky-Tec ultimately replaced it, as it should not have failed where it did. Jack also talked about the old Montague airport (now closed).

Young Eagles:

Chapter 211 member Kevin Golsch is our YE Coordinator. We had preregistered 27 kids (17 from the Dawn Patrol) and had 4 pilots/airplanes scheduled for these Young Eagle flights, but the planned date of October 17th and the rain date of October 24th were both canceled due to weather and other conflicts. It was also noted that out of the 27 kids that were pre-registered, only 8 kids actually ended up being scheduled to fly on the event date(s).

Elections:

A lengthy discussion took place on the need for members to serve on Board of Directors of our Chapter. President Tom Marotta opened the floor for nominations and/or volunteers for the 2016 Board of Directors. Tom explained that we need three people who will serve a two-year term of office. He stated that the first year the three members will be Directors and then the whole Board (at that point in time) will decide which office each of the three new Directors will eventually fill during their second year (President, VP, or Secretary/Treasurer).

Tom further explained that as a Director you would be serving with the 2016 officers - President Dan Whisman, Vice President Warren Roosen, and possibly Bob Vink, Secretary/Treasurer. Tom explained that because the workload is divided amongst the six people it's not totally time consuming. Scott DeGaynor talked about new people getting involved in the local Chapter as a Director and/or Officer and that it's a rewarding experience.

After discussion Bob Kenrick and Dale Hagen (if time permits) volunteered. Motion was made, seconded, and approved by members to elect Bob and Dale. We are still in need of a third person. It was also brought to our attention that Bob Vink may not be available to be Secretary/Treasurer next year (as he has not attended any of the Broad meetings this year). Earle Bares indicated if that is the case, he maybe willing to fill in (if no one else volunteers).

IMC Clubs:

Tom Marotta reported the EAA has acquired IMC Clubs. The IMC Club's mission is to facilitate organized hangar flying that focuses on building flight proficiency. More than 100 IMC Club chapters meet monthly. EAA has had a longstanding commitment to aviation safety and the ability to offer IMC programming to members using existing chapter network presents a tremendous opportunity.

This agreement will provide resources for new and improved program offerings that will enhance and expand the impact of the IMC concept. As part of a transition:

- Existing IMC Club members will become EAA members (beginning immediately)
- Existing IMC Club chapters will either form a new EAA chapter or be integrated into an existing EAA chapter (first quarter of 2016)
- All EAA chapters will have the ability to begin offering IMC programming (late spring 2016)

Program: Project Reports

We had some interesting project reports from Paul Dannenburg and Scott DeGaynor.

Paul showed examples of some hydraulically drawn sheet metal parts. He started by first cutting the stainless steal sheet metal part out in the shape required, with extra material on the OD (to use as a flange). He made a corresponding thick-plate-mounting with a pipe-fitting input for the hydraulic fluid. He used an O-ring seal and secured the sheet metal to the mounting along the flange edge with lots of fasteners. He then pumped hydraulic fluid into the bolted together unit until the anticipated shape was formed. It looked very good.

Scott talked about fuselage airflow over his Bede 4 and showed many pictures of same from a camera mounted on wing.
