2019 in review

2019 has been a very successful year for the airport. All county owned hangars have been 100% occupied all year long. This is great because our airport revenue sources are hangar rents, land leases. fuel flowage fees, landing fees and commercial operating permits. To continue

growing our revenue source we have to continue developing available airport property to allow additional aeronautical and non-aeronautical leases, build additional aircraft hangars, and revise our rates and charges to produce more revenue while staying competitive in the airport market.

Some of the highlights for 2019 were:

\*We ended all types of farming on airport property. This one change improved the levels of wildlife activity on the airport while allowing us to comply with Blackman Township zoning ordinances for light industrial.

\*We hired Debbie Thompson to replace Julie Williams as administrative assistant. She has been a great addition to the airport team!

\*Four of our local pilots, including the chair of the board, got awarded the highest honor for pilots that the FAA awards – the Wright Brothers Master Pilot Award.

\*The Airport Restaurant & Spirits saw a change in ownership. After many years at the airport, Dianne Weems decided to retire and sell the restaurant. The new owner, Tony Riddle has started to remodel the restaurant and we expect many changes in the future, including the addition of a restaurant patio in 2020.

\*We entered into a 3-P (private public partnership) with Jackson Executive Transport to redevelop the aging hangar 204. The hangar should be completely redesigned by September 2020.

\*We finally received, and approved, the update to the airport layout plan. This gives us a good picture of future development areas on the airport.

\*We designed, and redesigned, bided, and awarded the terminal apron project. In September the FAA finally awarded the money for the project, which is now scheduled to begin in May of 2020. One benefit resulting from this delay is that the redesign of the apron gave us the room to add a patio to the restaurant. The patio section of the restaurant is expected to open by September 2020.

\*We were able to replace the control tower roof and HVAC system. The roof job is done but is still awaiting final inspection. The HVAC should be running by the end of the week.

\*A new private hangar is being built, and because of our competitive land leases, we are hopeful to get one or two more in 2020.

\*Private hangars were inspected. A result of the


inspections is that several hangars are being updated and repaired, as required by the lease agreements.

\*We had to replace a plow on one of the pickup trucks, and major repairs were required of the on the Oshkosh plow truck and the John Deere tractor. Airport personnel are doing a great job of maintaining, and when able, repairing our aging equipment.

# JXN 2019 Update from Juan Zapata—expanded coverage


We had another successful year for 2019. All county-owned hangars were 100% occupied for the whole year. 100% hangar occupancy is great because we are maximizing our rental revenue for the airport. Airports have very limited sources of revenue – in the case of Jackson, we rely on revenue from hangar rentals, lease payments, fuel flowage fees and landing fees to help us operate the airport. 100% hangar occupancy also means

that we can start looking into the possibility of future hangar development at the airport.

**ALPUpdate** - We were also able to get our Airport Layout Plan (ALP) updated to reflect not only existing conditions at the airport but also shows us thepossible future layout of the airport. The diagram below reflects future configuration changes. A proposed addition is the extension of taxiway "F" all the way to taxiway "A". The proposed future corporate hangar development will be on the west side, and the extension of taxiway "F" will allow for easier and faster traffic flow.



Crane Spotted on the Airport –



No, not the Sand Hill type, but the MetalType! We were able to get a new roof and HVAC system on the control tower building. The roof was 1970's vintage, with many patches, and the HVAC was a 1985 model. Our new roof should keep the third floor and the air traffic controllers dry for many years to come!

**Terminal Apron** – The terminal apron project had some delays that prevented reconstruction to start as originally scheduled in 2019. The new construction start

date is May 26, 2020, right after the EAA's Pancake Breakfast & Fly-in. The delay was beneficial for us in that, because of the redesign requirement, we will now be able to add a patio to the airport restaurant. By September 2020, we expect to open up the new patio with outdoor seating! The diagram shows the expanded apron area. The project will take 90 days so please plan ahead if you are based on the west side of the airport.

## **Calling All Pilots – Manned and Unmanned**



The Federal Aviation Administration (FAA) on January 13, 2020, will launch improvements to the way it tests all applicants for an FAA airman certificate for all certificated pilots (including drone pilots).

One of the most important changes is the requirement that all applicants obtain an FAA Tracking Number (FTN) by creating an Integrated Airman Certification and Rating Application (IACRA) profile prior to registering for a knowledge test.

• The FTN allows the applicant and any certifying officer the ability to pull up airman information in a consistent format, leaving little room for errors associated with an applicant's name. Previously, name inconsistencies could lead to returned files and lengthy delays

in the certification process.

• IACRA is the web-based certification/rating application that guides the user through the FAA's airman application process.

The FAA will host four webinars beginning next week to explain the new testing system, including the FTN requirement. Please select one of the dates below to register for a Webinar.

- You must <u>download the GoToWebinar software</u> on your computer, smartphone/tablet app.
- On the day of the webinar you can access the session via the join link in your confirmation email, or using your 9digit Webinar ID.
