## The Regulatory Minute

14CFR91.25 is the "get out of jail free card," so to speak, for us pilots and mechanics. This is the Aviation Safety Reporting Program. It is coordinated by NASA and is an independent system from the FAA to allow pilots and mechanics to report errors, improvement recommendations, to name a few. A good case may be where you taxied onto the incorrect taxiway at a controlled airport. This could result in a penalty by the FAA, but, if you report it within 10 days, in most cases it may help you have a penalty waived if your first offense, assuming the act was not severe, criminal, to name a few. Use it! Remember—the FAA may not use this system as a basis for penalizing you—so don't be afraid to report a mistake. Website to make a report: <http://asrs.arc.nasa.gov/>
