Regulatory Minute

There is no such “thing” as a CFI certificate for hot air balloon pilots. If one is a commercial hot air balloon pilot, he/she is also an approved instructor for hot air balloons. Also, hot air balloon pilots, even at the commercial level, do not require medical certificates--just a pilot certificate and a government issued ID.
