Regulatory Minute

The pilot in command is responsible for determining the airworthiness of an aircraft. This includes knowing the annual is valid, ELT is inspected, and the transponder to name a few. The owner/operator is the one responsible for maintaining the aircraft. Something to think about the next time you fly as PIC in an aircraft (or, for that matter, even as the passenger).
