Subject: EAA Chapter 326 Board Meeting Minutes

Proceedings:

- Randy called the meeting to order at 3:30 pm
- Brief discussion on TeenFlight they are waiting for kit shipment before starting up again for the year
- Treasurer's Report was not available at the meeting, however here are the numbers:
 - o \$9,452.55 in checking and \$1,476.85 in savings with \$0.30 interest for September
 - o Amazon Smiles program deposited \$9.31 to checking in September
- Our WA Non-profit Corporation Annual Report filing due 10/31
 - Joe mailed it a few weeks ago
 - According to WA State, all standard processing is currently 55 business days, no further action is required at this time.
- Officer elections discussion
 - Bylaws state that elections are every year, but the chapter has typically ordered elections every other year.
 - Randy, Joe, Leo (by phone), and myself agreed to continue in our Officer roles for 2023
 - It was suggested that the bylaws be reviewed/amended
 - National website has boilerplate bylaws
 - Last year WA state issued a report about special wording in non-profit bylaws
 - National recommends reviewing them as well
 - o Brice volunteered to review the bylaws in addition to Randy
 - Last updated in October 21st 1969
- The chapter needs to start considering officers for 2024, even though elections are over a year away.
 - Start mentoring new leadership to take over
 - Identify candidates
- Joe mentioned that dues collection has started for 2023
 - o It is requested that all dues be paid by end of this year
 - o Randy will send an email to all members

- o 180 names in the roster
- o 64 members with paid dues
- Paypal has a non-profit offer for lower fees
 - Joe or Randy will look into setting that up, though the savings will be minimal
 - Andy Karmy's name is still on the PayPal account. This needs to change
 - Both Randy and Joe have access to PayPal
 - Decided for now to leave the PayPal account alone regarding the non-profit status

 - Discussed purchasing cooked ham and turkey
 - Suggest to chapter at November meeting

Badge Making

- Norm retired from making badges need replacement
- Supplies are in the cabinet
- Smitty reminded the committee to give out coffee cups to new members
- Suggestion made to clear out the badge board of those no longer with the chapter at the end of the year
- Young Eagles discussion
 - Send individual requests to YE coordinator
 - Ask pilots who is interested in individual flights
 - o The three headsets we bought were used during the last rally
 - Suggestion made to purchase more
 - Question posed to the board to hold more than one rally per year, decision was to stay with a single rally
 - Lisa the airport manager was given a pair of headsets that she wants to donate to the chapter
- Marv noted that the trailer has at least one tire with the tread separating
 - 4 new tires are needed
 - Other maintenance is likely needed washing, packing bearings, etc.
 - Discussed whether Les Schwab or other tire stores had a deal for non-profits decided that
 we have the money to pay for new tires without trying to get a nonprofit discount. Joe will
 ask S&S Tire about a nonprofit discount.
- David brought up saving for a Hangar
 - It may take 10 years but he stated we need to start planning for it now
 - Smitty has put in a request to the Thun Field Master Plan for a multi-use piece of property where a hangar can be built for chapter use, museum, pilots lounge, etc.
 - Marv stated that he felt that we do not have the member base to fundraise or support a hangar
 - Suggestion made to send out email to fundraise for the hangar
 - No final determination made
- David suggested it was time to figure out what we want to do for the PNW aviation conference

- Print business cards to hand out, David showed a prototype that everyone agreed looked good. David to look into printing more
- Suggested updating YE presentations for the conference
 - Picture board
 - Time and date fliers
 - Videos or slide show of past event
- Randy commented that we need to make sure it promotes our local chapter and not the national organization or any member business interest
- It was suggested to have some hands-on activity to promote home building
 - Riveting practice
 - Composite layups?
 - Maybe build one or two Van's tool boxes
 - It was suggested that this may be more than we want to do at the conference
 - There was a concern for safety and how to manage that
- Ask members for slide shows of their project builds
- Bring airplane parts, even damaged or rejected ones to pass around and discuss
- Maybe just use flat sheets and angles like TeenFlight/Alaska Days
- o Balsa gliders were considered, but at \$1 per, might be too expensive
 - And there are not a lot of kids at the show
- Randy will send out ideas to the Chapter
- David also suggested we update our audio-visual equipment with a Bluetooth compatible projector and a 120" pull down screen that can be mounted at the front of the room that can be shared with the CAP
 - He will look into what he can find at surplus stores
- Our July speaker, Russ Roberts, donated several copies of his book *Unlearning to Fly: Navigating* the *Turbulence and Bliss of Growing Up in the Sky* to our chapter. All donated books were
 purchased by members in attendance, generating \$179 for our chapter!
 - This was recognized with an email "Thank You!" sent to Russ for his presentation and generous book donation.
