It has been quite an EAA 327 month!

a beautiful Saturday morning, had lunch, and raised over \$500 for the Chapter.

The RV-12 is youth build project is now officially an airplane, N-744AN. Bill Kyle, an FAA DAR, or designated airworthiness representative, came to inspect our project and declared it airworthy with no deficiencies. I have flown it as test pilot for 6 hours now, gotten through Phase I flight testing, and given rides to several youth and adult build participants. We all have big RV-grins on our faces! It is a blast to fly, so much fun.

Taras Slyyka diagnosed a small leak of oil from the gearbox seal, so we'll be taking it to the Rotax service center for warranty work. Paint is on the horizon, and figuring out the plane's future.

We would like to have it available locally for rides and to generate funding for youth scholarships. If that doesn't work out, the plan is to sell it and use the proceeds for the same purpose.

Our May meeting will be on the usual third Tuesday of the month May 18th. Doug and Nancy DuPlessis will be doing the light dinner before the meeting. Come at 6:30 for eating and fellowship.

The general meeting starts at 7 and our program is a 99's member and friend of Elaine and Bill Fitch. She is Minnetta Gardinier who will talk about her flight to Greenland in her single engine airplane.

Joe Sener organized and ran a Flying Start Program at the Jet Center conference room on May 15th. There were five aspiring pilots and twelve including CFT Erin Cram and others attending. Some synergy developed with some expressing interest in becoming members and others wanting to support our youth education programs.

Our plan is to offer Eagle rides to the adults who participated when the weather clears. We recruited a few participants in the radio control Build 'n Fly program with the Tri-State Modelers.

As far back as I can remember, I have been fascinated with airplanes and airports. I found myself wanting to go on vacations not for the vacation part, but for flying in an airplane and wandering through airports.

Several years ago, I took a Young Eagles flight at an event in Clinton, and I knew this was the way of

my future and I set my sights toward the sky.

In October of 2019, I began my ground school coursework at Kirkwood College in Cedar Rapids, driving down with my Dad every Tuesday night for 10 weeks of three-hour classes. As I neared the end of my coursework, I started private pilot training in Clinton with Tanner Rau with P&N Aviation. We flew as often as we could, and I started to accumulate hours.

Due to some airplane issues in Clinton, I transferred my instruction to Derek Harsen in Marion (C17) and have been taking instruction there since then. In the past few months, I have been working really hard to obtain my Private Pilot's license and completing all the necessary requirements for reaching my long time goal of being able to fly. Recently, I have been working the instrument portion of the certification with my flight instructor.

Lately, I have been busy working on Slow flight, Steep Turns, Stalls, ADF navigation, and landing at the Marion airport all while under the hood. I am 16 and the requirement for getting my license is 17. During this gap from now to November (when I turn 17), my flight instructor wants me to get started with the Instrument Rating. This summer I plan practice RNAV and ILS approaches into Cedar Rapids.

To date I am just short of 80 hours and have achieved all of the requirements for my private pilot's license; as I recently successfully passed the written FAA exam.

My goal is to attend school at UD and work my way to the airlines, with American Airlines on the top of my list. Flying has been a great release for me and I take every opportunity to fly when it is presented to me. I can't think of a better way to spend my weekends than in the cockpit of an airplane as I work toward my future.

In my free time, I have been working with my drone. Last summer, I obtained my Part 107 license with the FAA which lets me fly unmanned aircraft such as drones commercially. Having this license lets me make a little money and lets me do something that I enjoy as well. I have been working with Realtors and other commercial business to get aerial pictures of properties before they list them on the market.

Young Eagles Day & Youth Protection Training

I'd like as many pilots who are able, to get Youth Protection Training to qualify as Young Eagle Pilots. Many hands make less work.

To find out if you're qualified, www.eaa.org website, click on Chapter Resources, Managing Your Chapter & finally EAA Chapter Member Look Up.

Here are the requirements:

- All participating pilots must hold an appropriate airmen's certificate (sport pilot or greater).
- Pilots must possess a current medical certificate (if applicable).
- Pilots must be current EAA national members.
- Pilots must be current to carry passengers in the aircraft they plan to use.
- Pilots must have a current flight review.
- Aircraft Passenger Liability Insurance is required for the aircraft used (owned, rental or borrowed).
- The Young Eagles registration form must be completed before the flight, complete with parent or guardian signature.
- The aircraft used for the flight must be in airwor-thy condition (experimental OK)
- Must complete EAA Youth Protection training & background check.

As an EAA member, pilots participating in the Young Eagles Program are eligible for an additional \$1 million of passenger liability insurance coverage, if they carry a minimum of \$100,000 per seat liability insurance.

To get Youth Protection Training & a background check (no charge) go to www.EAA.org and sign in.

Go to "My Training" &/or "Go to Course" link on top of the page. You'll need to take the Youth Protection Training and the Background check. It takes about a half hour and you'll hear from EAA in a week or two. I don't see if anyone fails so don't worry!
