501 (c) 3: Myles was thanked for all the work he put in on the project. The current status is fully reinstated. Retroactive back to May 15, 2010. Able to file for \$100. Classified as a public charity. There are donation letters available for contributions. On a different note, a CD was rolled into the chapter's general fund because of the low interest rate. The Scholarship Fund for 2013 now stands at \$3100 with a small rollover of contributions from 2012

Future Fund Raising: Stan Specht is the chapter fund raising chairman. A fund raising letter will be forth coming. Dave mentioned that Jean-Pierre Verdier suggested checking on the State Education Grants as a possible fund source.

Chapter Leadership Academy: Terri shared her experience at the academy. Young Eagle Report: Terri shared that the season is over for the flights. It was a very successful year. Thanks went to all the pilots and ground crew that helped.

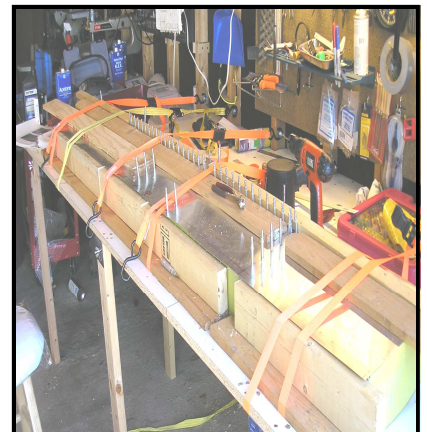
EDITORS NOTE
