Construction Projects Improve Airport Operations and Safety

During the summer months Jeffco Airport has completed several construction projects to improve the facilities at the airport. The construction and improvement projects were made possible by two grants, AIP 10 and 11, totalling \$2.75 million from the FAA.



The new maintenance/operations building was completed early this summer.

Operations Building

The 12,000 square foot maintenance/operations building has been completed.

The new facility will house snow plows, fire equipment and other maintenance vehicles.

Runway 2/20

Airport expansion projects AIP 10 and 11 have been completed, which included a complete resurfacing and partial reconstruction of runway 2/20 as well as new lights on the runway and taxiway "Bravo".

Runway 29R

The funds have also been used to construct a Safety Area off the east end of runway 29R and to purchase 31-acres of clear zone for 29R.

Looking Ahead

Plans are currently in the process for AIP 12, which will include the overlay of the north FBO ramp areas including the new Turbo West Hangar 4 and the Denver Air Center ramp areas. Drainage improvement projects are also planned. The FAA grant, totalling \$1.64 million for these projects is expected to be received by the end of September.

Design work is also continuing for plans to build a replacement runway for 29L. The new runway will be longer, wider and lighted for night time use.

Jeffco Airport continues to make improvements to its existing facilities in order to provide a safe flying experience.
