Treasurer Roy Maneely reported that there are still calendars for sale for \$5.00 each and patches for sale also for \$5.00 each. Please pay your 1993 dues ASAP.

The Fly-In at Denver International Airport (DIA) is still on schedule. Apparently this is one of a very few things that is still on schedule for DIA. Printed elsewhere in this newsletter is a letter from the FAA advising all pilots that the FAA is conducting flight inspections within ten nautical miles of DIA. These inspections and tests of the navigational systems require set courses, and the FAA advises that it would be prudent to avoid the area. The FAA also reminds pilots that the construction area has upwards of five thousand construction workers in the area at any one time, and that FAR91.119 requires a minimum altitude of 1,000 ' AGL. The FAA goes on to remind all pilots that flight activity is not authorized at DIA until its' opening.

Mark Yelich reported that the airport manager is moving into the new terminal at the end of March. He also reported that the Antiquers were chatting about our proposed fly-in in June to "break in" the new terminal. Mark will coordinate further activities with the Antiquers and the other chapters.

# **Rocky Mountain Regional Fly-In**

Bill Mitchell reported that the Fly-In committee is looking into hail damage insurance. There has been damage insurance in the past for damages caused by people. (Editors Note: reviewing the information forwarded to me by Mark Yelich I discovered that this years air show is dedicated to a past member of Chapter 43, Guy Sheeon. Guy lost his life in a flying accident on February 25, 1990. It may have been said before, but it sunk in this time).

Chuck Ogden reported that the posters, business cards, and information packages will be out of the printers sometime this month. Attached is a copy of the poster, and an information handout.

# SAFETY CORNER

NOTE: THE FOLLOWING REPORTS ARE NOT COMPLETE INVESTIGATIONS, CONSULT WITH THE GENERAL AVIATION ALERTS FOR FURTHER INFORMATION

Brad reported on an IA certification meeting that he attended. Some of the accidents described included:

A pilot was sucked out through the front windscreenof the pressurized craft he was flying. The investigation showed that the 10x32 screws securing the screen had been replaced with 8x32 screws.

Brad reviewed the homebuilt section of the General Aviation Alerts as follows:

On Avid flyers - one side of the tailwheel springs loosens on one side causing some interesting ground handling problems.

Little Beavers RX - pulley problems on the rudder and elevators. Replace with 3.5" pulleys and 1/8 inch cables.

KR-2s - landing gear bolts pulling out.

Lazar - seats failing.

Q200 - Rudder and bellcrank cables loose.

RANs S-9 - carbon monoxide when flown with canopy.

VARI-EZ - landing light in wing melted resin, into fuel cell, ignited.

Glassair - lock up front gear due to missed stops on retract mechanism.

Lancair - front spinner bulkhead warn through, replace .032 with .050.

Christiansen Eagle - rudder bolts half worn through.

RV-4 fuel pump springs fail (same as Cherokee)

Removing the harmonic balancer on automobile engines that require them has been shown to cause a catastrophic failure of the crankshaft.

Kitfox - 3 blade ground adjustable Invoprop failed (8x32 screws in 10x32 holes).

Long EZ - cowlings filling with water when setting out unprotected.

Note for John, Dean, Jim, and the rest of the T-18 builders/flyers. There were no T-18s in this report.

SUBJECT: New Denver International Airport Flight Precautions

CANCELLATION: October 30, 1993

Construction is ongoing at the new Denver International Airport, and flight checks of the runways, lights, and navigational aids will begin January 6, 1993. With such a large project, we do not expect flight inspection to be completed until the end of September 1993.


The nature of these flight inspections requires our FAA aircraft to operate at low altitudes within 10 nautical miles of the new Denver International Airport. During a flight check, the aircraft is unable to deviate from a set maneuver thus allowing very limited flexibility to avoid other aircraft. It would, therefore, be prudent for other aircraft to avoid the area.

Pilots should also be aware that there are upwards of 5,000 construction personnel working on the new airport site at any given time. This means that much of the area is considered as congested (FAR91.119), which requires a minimum altitude of 1,000 AGL.

For your information and to assist in your flight planning, printed on the back of this letter is a sketch of where the new Denver International Airport is located.

Be advised that flight activity is not authorized at the <u>NEW DENVER</u> <u>INTERNATIONAL AIRPORT</u> until its opening, which is scheduled for the Fall of 1993.




