



I represent and warrant that I am the Minor Participant's parent or legal guardian and that I have the authority to enter into this Agreement on behalf of the Minor Participant. In consideration for being allowed to take part in the Chapter Activity, the Minor Participant and I agree as follows:

Assumption of Risk. The Minor Participant and I understand that participation in some activities involves risks, and that we can obtain more detailed information about the above Chapter Activity from the Activity Leaders. Injury, including serious injury or even death can result from many causes, including without limitation improper use of tools by the Minor Participant or others, defective tools, improper or inadequate instruction or supervision, dangerous weather or terrain, structural failure, arguments or fighting, failure of the Minor Participant or others to follow instructions and behavior standards provided by the Activity Leaders and other Chapter volunteers, and other physical, mental and emotional challenges. The Minor Participant and I (for ourselves, our heirs, family members, personal representatives and assigns) understand that participation in the Chapter Activity is completely voluntary, and hereby assume all risks and full responsibility for any injury or death arising from taking part in the Chapter Activity.

Agreement to Waive Liability and Not to Sue. The Minor Participant and I (for ourselves, our heirs, family members, personal representatives and assigns) hereby <u>release and discharge</u>: (a) The Chapter and the Activity Leader(s) identified above; (b) Experimental Aircraft Association, Inc. ("EAA"); (c) EAA Aviation Foundation, Inc.; (d) any medical institution, including without limitation any ambulance service that provides services in an emergency; and (e) the officers, directors, members, employees, medical personnel, agents, divisions, affiliates and volunteers of each of those entities (collectively, the "Releasees") from, and agree not to sue the Releasees or any of them for, any and all claims against any of the Releasees for any injury or death arising from the Minor Participant's participation in the Chapter Activity.
