Bob visited this beautiful site every Memorial Day to watch the warbirds with big radial engines do the traditional fly-by and missing man formation. We held a memorial service for Bob at the EAA hangar on October 10, 2020.

CHAPTER ELECTION - This week, Wednesday evening starting at 7 PM, is our last meeting at the hangar before the Christmas Dinner on December 15. And according to our bylaws, it is also that time of the year when we elect officers and directors who serve a one-year term starting January 1, 2022. We published a "slate of candidates" and sent the ballot out in a MailChimp email on November 2. If you have not yet voted, you have until November 16 to cast a vote. You might think "it's no big deal". If nothing else, it is a small way to show your support of Chapter 512 and the officers who do their best to run it. Please come to the meeting to show your support.

CHAPTER SCHOLARSHIPS - We are making a big difference in young people's lives through our chapter scholarship program and the Ray Aviation Scholarship program. Last year, we applied for and won a scholarship for one of our chapter members, Andrew Gordon, who earned his Sport Pilot Certificate before he joined the Air Force in July 2021. With new knowledge and discipline, he just completed his training in the Air Force as an air traffic

controller! That is a great accomplishment that our chapter and his parents are very proud of.



With the success of our first Ray scholar under our belt, we applied for a second Ray Aviation Scholarship this year and were selected for a \$10,000 scholarship. We had three applicants but only one scholarship. The decision was not easy, but we awarded Jaeger Ruckman the Ray scholarship. Two additional \$1,500 Sonny Atkins scholarships were awarded to Nathan West and Aidan Andrews.

Then, unexpectedly and to our astonishment, the EAA Ray Aviation Scholarship program reached out to chapters who already had Ray scholars and asked if they could administer another scholar for the year. The chapter responded yes, yes, yes! and Aidan was selected, applied for, and was awarded the Ray scholarship for year 2021-2022. The chapter received a congratulatory letter that Aidan's scholarship was approved for funding on November 9. Aidan will start flight training this month with the goal of solo within 90 days, FAA written exam in six months, and his check-ride completed in less than one year.

The challenge for all student pilots in California is the high cost of flight training. Even if you have a scholarship, you want to stretch those dollars to get the maximum amount of flight training for every dollar. So where and how will these young aviators learn to fly? The answer is right here at the Placerville airport, just like I did eight years ago in my Cessna 150.

LOCAL FLIGHT TRAINING - When the chapter awarded money for flight training in 2020, there were no CFIs with aircraft on the field since the FBO closed shop several years earlier. We had to send the student pilots to Cameron Park. The biggest barrier to local flight instruction is the high cost of commercial aircraft insurance. At three time the cost of a normal business and pleasure policy, insurance accounts for one third the hourly rate. But now we have a Cessna 150 parked on the ramp for the use of chapter students!

Will Mathews is the CFI giving basic instruction to Jaeger and Nathan so they can obtain their private pilot certificates. This is not a chapter airplane nor is it a club airplane. With the acquisition of the plane in August, I started a business called Great Planes LLC for instruction and rent to young chapter members to advance their flight training. The plane has

limited use, if not exclusively dedicated to youth flight training at Placerville.


On November 10, Jaeger Ruckman soloed the 150 after less than 16 hours of instruction. Congratulations!

What is the future for Great Planes? My hope is to continue to graduate new pilots and offer a primary trainer to chapter members. The plane arrived at the field in early August and was used as a static display at the October Young Eagle rally.

CHAPTER IMPROVEMENTS – The new stairway to the loft is nearly completed. Dale and Jim will put a final coat of paint and place yellow caution tape on each step to improve visibility to finish the job. Additionally, Tim tore down the old loft rail and with the assistance of Dale and Jim, new posts were fastened to the floor and a cap rail placed between posts. Tim followed with a high wire act by stretching 1/8-inch stainless steel wire spaced 3.5 inches the full nine yards! Yes, just over 27 feet from end to end.

Board Member Reports

Jim Wilson – President

■ Chapter election

- 25 people have voted to date. Close of election is Nov 16. Results will be presented at the Nov 17 General Meeting.
- Currently the Chapter By-Laws require the Nominating Committee to present a list of candidates at the October General Meeting and the election of new officers to occur at that same meeting. It was proposed that we consider revising the By-Laws to spread the nominating and election process out over a broader timeframe.

Chapter Renewal

 At the end of each year, all chapters must renew their charters and purchase insurance for the coming year. Part of that renewal is deciding whether or not to donate to the Peter Burgher Chapter Development Fund, and if so, how much? In 2020 we donated \$50. The Fund provides dollar for dollar matching funds for the sole purpose of supporting EAA Chapter development by providing tools to enhance training and chapter growth. Our Board voted to donate \$50 again this year.

■ Chapter Annual Survey

• EAA National has sent out (or will be sending out) a survey to determine our "Net Promoter Score". The question is, "How likely is it that you would recommend your chapter to a friend or colleague?" We need at least 20% of our membership (15 out of 73 members) to respond to this survey. We will bring this topic up at the Nov 17 General Meeting.

■ Pancake Breakfast

- Next year's Pancake Breakfast schedule will be from April through Oct 2022.
- We discussed the possibility of holding a hoagie style lunch similar to that held at the Yuba City fly-in. This could be in conjunction with a Pancake Breakfast (pancakes 8-11, hoagies after 11) or on a separate date, like a Federal holiday. We will have further discussions at future meetings.

Processing Payments

- Currently, the Chapter By-Laws require two signatures, the President's and the Treasurer's, on checks for over \$500. Jim Wilson's aircraft is being used for scholarship flight training. Scholarship funds are in the Chapter's accounts. Jim's company, Great Planes LLC, invoiced the Chapter for \$1,156.48 to cover Jaeger Ruckman's flight training. In order to avoid conflict-of-interests, or any semblance of impropriety, we discussed altering the By-Laws to allow the Vice President to also be a counter-signer.
- As an interim solution, the Board voted to transfer funds to Jim to cover his invoices.

■ Ray Aviation Scholarship Status

- O Jaeger's first flight was on Sep 12 in C-150. By the end of Oct, he had 13.5 total hours.

- Aidan received his congratulatory letter with training agreement on 11/9.
- We will schedule a meeting with the scholarship coordinator, his CFI, Aidan, and a parent to sign the training agreement letter.
