Brian Jones reported that EAA National has contacted EAA 533 about a Tri-Motor Event. The plane will come to ELM Thursday through Sunday September 1 – 4, Labor Day weekend. The Tri-Motor needs to be housed in an 80' x 80' hangar with a 60' door. EAA 533 will need to get sponsors. Following discussion, David Baker made a motion to go ahead with the Tri-Motor event, pending hangar access, Dick Welles seconded, and upon vote, motion carried.

Dick Welles will be moving his Cessna 150 back to Corning-Painted Post in a few weeks. He noted that he used Higher Graphics for decals in the plane.

Brian Jones has priced new boilers: \$3,500 without installation. Dick Welles commented that he had a Peerless boiler installed on his property.

Roof repair: David Baker did speak with Marty about a good sealer.

Hangar door cables: Brian Jones found a supplier for cable at 35 cents per foot. We will need around 180'. Andy Diffenderfer said we could use his engine hoist.

Kevin Polovick brought a box of Wes McKinney's new sweatshirts for a donation to EAA 533.

There being no further business, upon motion of Mike Depue, second by Dick Welles, and vote, the meeting was adjourned at 6:53 PM. Movie night follows the board meeting.
