Meeting called to order at 7:03 PM by President Brian Jones. Minutes of the previous meeting were read by Kevin Hooey. Upon motion of David Javarey, second by Dick Welles, and vote, the minutes were approved as read.

#### **Treasurer's Report:**

John Flanagan presented the Treasurer's Report. The fire insurance premium was paid: \$814.00.

Checking Account \$25,861.09 CD \$11,259.17 Total \$37,120.26

Brian Jones will submit the 2022 Chapter Renewal, and provide John with the amount due so a check can be issued. John noted that the annual Spaghetti Dinner attendance was down 50%. The speaker, Scott Hauser, manager of the Towanda airport, made an excellent presentation. It was noted he had problems with the A/V

equipment at the hangar, and at some point the chapter should look into an upgrade. Upon motion of David Javarey, second by Dick Welles, and vote, the treasurer's report was accepted as presented.
