Meeting called to order at 7:05 PM by President Brian Jones. Sharon Flanagan read the minutes of the previous board meeting. Upon motion of Kevin Hooey, second by David Baker, and vote, the minutes were approved as read.

Treasurer's Report:

John Flanagan presented the Treasurer's Report:

The 2022 Chapter Renewal was paid: \$894.00. The current NYSEG bill, just received is \$756.00. Upon motion of Mike Depue, second by Dick Welles, and vote, the report was accepted as presented.

Brian Jones reported that he completed and submitted the chapter's 2022 renewal form to Oshkosh.

Discussion followed on the hangar fire insurance policy. Kevin Hooey obtained quotes from the current carrier, Allegany Co-Op Insurance Company, to update the coverage.

After reviewing the guotes, Dick Welles made a motion to accept the quote for a limit of \$750,000 at an annual premium of \$2,930.00. The motion was seconded by David Baker, and upon vote, the motion carried. Dick Welles, Scholarship Coordinator, reported that he completed the 2022 Ray Scholarship Chapter Application. Approval of the application will allow EAA 533 to offer a \$10,000 Scholarship to a successful applicant. Currently, there are 4 applicants waiting, all junior members of Harris Hill Soaring Corporation. The 2021 Ray Scholarship winner, Jack Vakiener, soloed in August 2021, and has currently logged 20.5 hours. He will do his written exam this winter. EAA 533 has received \$4,000 so far for the scholarship. It was noted that Ray Scholarship recipients can keep \$1,500 of the \$10,000 that is not used for the flight training. Dick Welles noted that he will provide the thank you letter from the 2020 scholarship winner, Lucas Pratt, to the organization.
