**SECRETARY'S MINUTES FOR OCTOBER 2022**

1. Meeting called to order at 6:32 P.M.
2. Darren let the visitors introduce themselves.
3. Aaron Terry was our speaker talking about the F35. See articles later in the newsletter.
4. We all took a break at 7:20 P.M. and restarted at 7:40 P.M.
5. Darren talked about some upcoming events. The next Young Eagles (YE) events is scheduled for November 19, 2022 here at Glendale. Cheri is expecting between 60 and 70 students. She would like to have at least 10 aircraft for the event. She passed around a ground crew/pilot sign-up sheet. It is also the semi-annual pot luck afterwards. The next YE event is at Stellar Airpark on the first Saturday of December 3. As usual they provide all the fixings and we prepare breakfast. We have a donation jar wit proceeds going to our chapter. We will need between 6 and 8 people to prepare pancakes, eggs, and sausages. Then serve them with orange juice. Hopefully Copperstate Fly-In will happen in February again. They are always looking for volunteers.
6. Our Christmas party is again at Dillon's BBQ off the 101 and 59<sup>th</sup> on December 13.
7. Secretary report. Monthly donation, need speakers for next year. We will need volunteers for hangar build. If you want a copy of the video from the Tuskegee Airman meet and greet Dave Biddle was in the hospital with cracked vertebra. He has to wear a plastic clam shell as a brace. They sent him to a rehab place and he slept for the first 6 days and the 7<sup>th</sup> he had Tom Velvick pick him up and take him home. Please sign in and update your email if necessary. Darren asked for presenters on their build project.
- 8 John sent an email to Tad Daughter with the Treasurer report. Our current balance in savings is \$111,275.00 with \$4402 in the checking account, we received \$54.00 from Amazon Smile and a PayPal balance of. \$2839.00 The total is \$114,516.00. According to John we have 81 paid and 15 not paid members. Additional donation of \$700.00 for the hangar.
9. Three airplane donations for sale. The Bradley Aerobat, Sonex A, STOL King.
10. Cheri sent around a sign-up sheet for the Nov 19<sup>th</sup> Young eagles event. There is a need for ground crew and pilots. The pot luck will not be in the restaurant as it is going through a renovation.
11. Carlos H. gave an update on the hangar progress. We got several \$600,000 bids which were rejected. Jim Lamson will be our General Contractor in charge of getting sub-contractors for each step in the build process. He is much more flexible with the build. Concrete and Ground prep bid. Got a bid of 24,000. The first item is ground preparation, Utilities feed-ins got a bid of \$16,000. The FAA requires a form FAA 7460-1 - Notice of Proposed Construction or Alteration which was submitted. It takes four to six weeks for approval. Carlos estimates that the above construction will be around \$137,000. Then we can start hanging steel for the building. Darren noted that there will be additional costs after the building is up. We have a quarterly lease payment, Insurance, and Utility bills. Once the hangar is built we can have many programs, activities, and educational activities that we can hold.
12. Darren noted that all of the T-hangers are full. We can get donations for build space or indoor parking of airplanes.
13. Carlos with the help of Mike Hauser rescued three 3 foot doors and eight foot metal studs plus insulation from his office remodel. He thinks there is enough for the two rest rooms and the tool shed. The members have experience with dry-wall hanging from Darren's shed. We may have to wire brush steel and repaint due to some rust spots..
14. A Member has been restoring an airplane and he needs to borrow a two axle trailer to move it. Cheri noted that that \$50 dues comes out to about \$4.17 per month.
15. Some suggestions to raise the additional funds are more breakfasts, build a plane projects, go fund me page, consider raising dues, another poker run, how about a garage sale with all the members donating items. Phillips Aviation gives a discount for those with their credit card. Fry's has a rewards program also.
16. November is election of officers month. Alex Bodak is collecting written nominations for all officers. Get them to me no later than November 5<sup>th</sup> so that I can put them into the newsletter and then vote on them at the November 8<sup>th</sup> meeting.

17. Tad Daughters 1 and Carlos H second for adjourn meeting at 8:35 P.M.

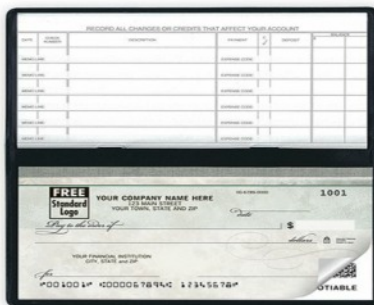

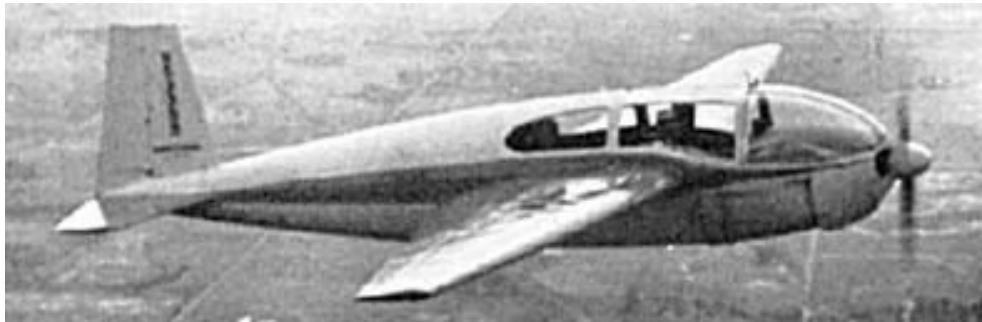

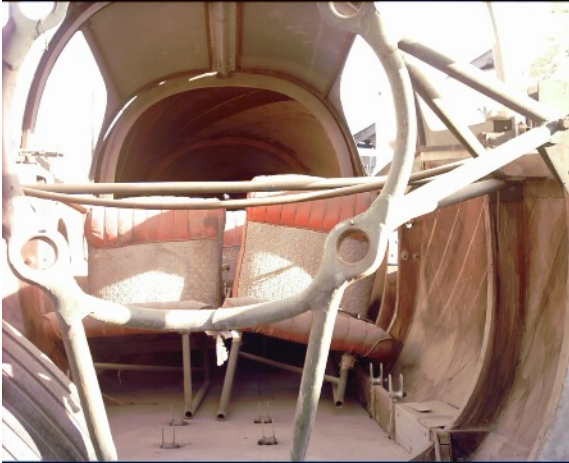

2. An Arion Lightning is a project ready for a quick completion. It is an E/A-B.

It was originally intended to be a speed mod test aircraft (short wing Lightning). It does have one speed mod integrated into the airframe which is a gap seal on the underside of the wings.

It has a "0" time USA distributor overhauled Jabiru 3300A engine. It is a Gen3. It has 30 gallon tanks. The burn rate on the Jabiru is ~5 gph, so you have over 5 hours of flight time with a reserve.

It has several used components from other aircraft. It has a new Sensenich ground adjustable propeller. There is an extra wiring harness pre-run in the event that we decided to install a supercharger. The supercharger is still in the testing stages, so not available.

Avionics include:

1. GRT Horizon 10.1 EFIS
2. GRT EIS 6000 engine and flight management system
3. Reiker slip indicator
4. Trig TT22 Transponder
5. MGL V16 radio 10/5W w/Vega Control Head
6. GRT 2020 GPS with a uAvionix Echo/UAT for in/out ADS-B
7. GRT Roll and Pitch servos
8. ACK ELT

Remaining to be finished:

1. Final installation and test of avionics components
2. Completion of smaller heim joint to the roll servo control rod
3. Optional installation of a canopy key lock
4. Installation of wheel pants and landing gear fairings on completion of initial flight testing
5. Completion of a build manual
6. Completion of final install of engine electrical (hook-up)
7. DAR inspection and issuance of a Special Flight Worthiness certificate for an E/A-B.

The airplane is ~850 pounds, so it can be flown under light sport rules.

This aircraft kit is at the Geronimo Experimental Aircraft build center in Marana, AZ. The price is \$99,900.



## **AIRPORT OF THE MONTH - ROOSEVELT LAKE-GRAPEVINE**

Roosevelt is a census-designated place (CDP) in Gila County, Arizona, United States. The population was 28 at the 2010 census. The CDP is located on the western edge of Gila County, on the south side of Theodore Roosevelt Lake, a reservoir on the Salt River. The western boundary of the CDP is the Maricopa County line. Arizona State Route 188 runs through Roosevelt, leading southeast 31 miles (50 km) to Globe, the Gila County seat, and northwest 48 miles (77 km) to Payson. Arizona State Route 88, the Apache Trail, has its northern terminus just west of Roosevelt at the Theodore Roosevelt Dam. The highway, which is unpaved for much of its distance, is a National Scenic Byway and leads southwest 45 miles (72 km) to Apache Junction at the eastern edge of the Phoenix area. The Roosevelt CDP is bordered to the southeast by Tonto National Monument.

### **Aviator’s Code of Conduct**

**Preamble:**

The Arizona Pilot’s Association (APA) and The Recreational Aviation Foundation (RAF) are partnering to advance backcountry aviation in Arizona, and every pilot plays a part in our success. Each of us is an ambassador to the non-flying public, and to the land managers responsible for the airstrips we enjoy. Please do your part by practicing these few rules. We want to be the friendliest and most helpful recreational users these land managers work with!

**Pilots will abide by all State and Federal regulations regarding the use of aircraft.**

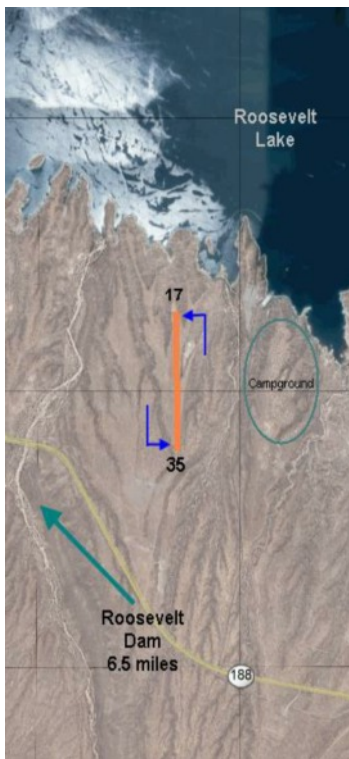
- Act with all possible courtesy to those on the ground who are hunting, horseback riding or observing wildlife, by maintaining reasonable distance and altitude.
- Know wildlife refuge boundaries as well as seasonal areas of wildlife congregation to avoid inadvertent low level over-flights.
- Avoid putting potential stress on wildlife.
- Get appropriate permissions when required, prior to using an airstrip.

**Pilots will practice good wilderness and backcountry flying ethics.**

- Keep the noise signature of the aircraft to a safe minimum.
- Practice “leave no trace” camping. Fly it in, fly it out.
- Avoid very early morning departures unless safety of flight demands a deviation.
- Be courteous to other users in the area.
- Do not use these airstrips for training purposes or just to say “I’ve been there.”
- Keep the aircraft clean of noxious weed seed to prevent the spread of weeds to backcountry airstrips.
- Participate whenever possible in work events to maintain these airstrips.

## FEATURED AIRSTRIP: GRAPEVINE, AZ



Each month we highlight an airstrip that the RAF has positively impacted. We hope that you will get out and enjoy these airstrips. This month's Featured Airstrip is Grapevine (88AZ) in Arizona.

Grapevine airstrip is located on the Tonto Basin District of the Tonto National Forest, 43 miles east of Scottsdale and is just 1400' from the south shore of Roosevelt Lake, the largest body of water in central AZ. First constructed in the 1950's and asphalted in the 1980's by the Bureau of Reclamation and ultimately closed in 1997 by the FS. 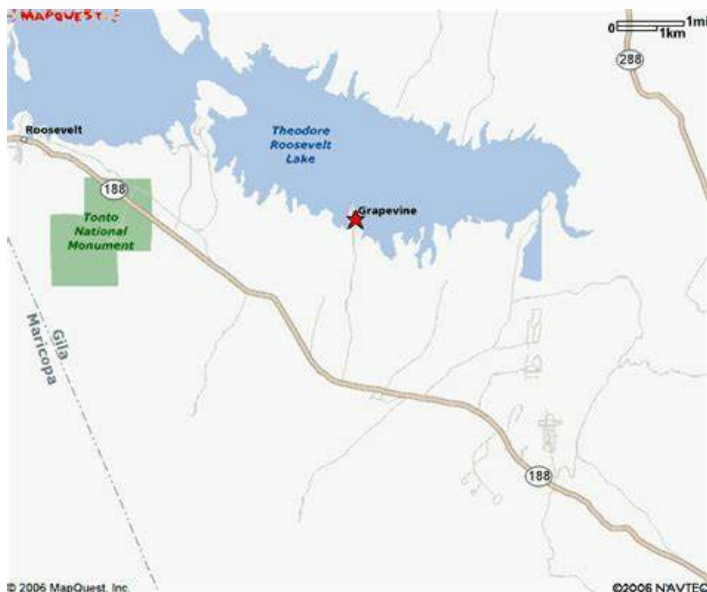

following our success at Pleasant Valley and with a positive recommendation by that District Ranger, the RAF and APA negotiated a volunteer work weekend with District Ranger Kelly Jardine in order to clear years of tree and shrub growth along the runway edges. With 80+ volunteers and three days, the airstrip was made usable again. Group gatherings are held on the third weekend of the month, with the APA providing a Port-A-John at midfield and a host for your convenience from September through May. We continue to work with DR Jardine and Forest Supervisor Neil Bosworth to regain full time use of this airstrip, which we are hoping will happen when our National MOU is completed between the RAF and USFS.

Grapevine is unique among backcountry airstrips in that it is asphalt, 40' wide and 3,400' in length. This attribute making it a favorite destination for aircraft less adapt to serious backcountry airstrips. Don't be fooled by this as a visit here will place you in one of the most beautiful examples of Sonoran Desert beauty, and solitude, including towering Saguaro cactus, and prickly pear cactus, Ironwood, and Paloverde trees, along with a plethora of desert animal life. The area is closed to others, including automobile traffic, so while only a 20 minute flight east of Phoenix, you'll enjoy complete solitude, other than a few other pilots. With the appropriate state fishing license and a short walk to the lake, there are plenty of large and small mouth bass to be had down at the shore. 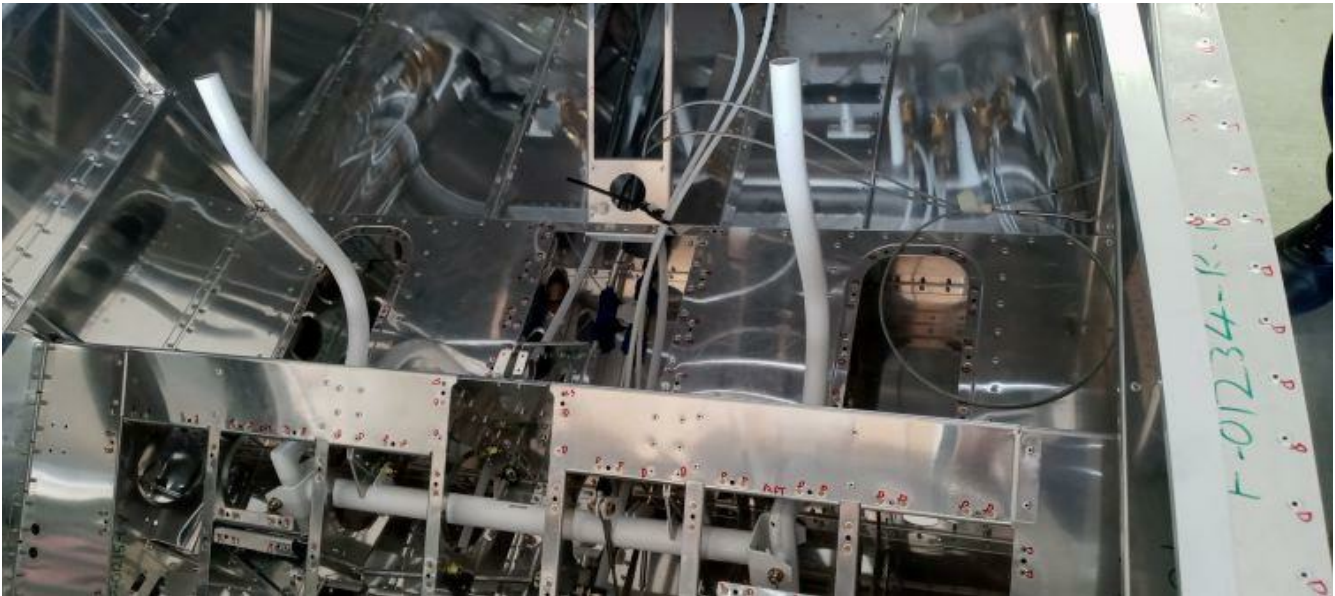

I got TWO kit deliveries this month after 4 months of nothing. The Avionics kit came (Single side Dynon), then 2 weeks later I got the Finish kit. Not much to do for the Avionics but store it. There were a couple of small brackets that came with the avionics because they vary depending on the system installed, I got them installed. I did not want to install the wiring harness to minimize the possibility of damage while the fuselage was completed.

For the fuselage kit- I started with the flight controls. Installed the rudder and stabilator cables, then the sticks and push rods that connect to the flaperon torque tubes. The final alignment with the flaperon connections will be done later when the wing is connected. (the wings are removable, with the torque tubes mating to the flaperons with a blade and slot arraignment.)

The tail fairing installation instructions were in the original Empennage kit, with a note that the fairings come in the finish kit, so I am fitting them now. They do not come CNC machined and match drilled like the aluminum parts, so there is a lot of fitting and trimming to get the parts in place and to clear properly the rudder and stabilator. Next will be the landing gear install, but there are some parts on back order for that.

The FAA is again seeking feedback from the public in regard to an Airworthiness Directive (AD) that was issued in August 2020 regarding the fracture of cross-flow cylinder assemblies in some Continental 500-series engines.

A new airworthiness concern sheet states that the agency is concerned that the corrective action in the initial AD is not fixing the issue.

“The FAA has received multiple reports from the field of cracked cylinders despite prior compliance” with the AD, the new bulletin states.

The impacted engines include variants of the 520 and 550-series Continental engines with cylinder heads produced on or after Nov. 1, 2014, with serial numbers before AC18KB277.

Aircraft models to have used the 500-series engine over the years include [Beechcraft Barons](#) and [Bonanzas](#), the [Mooney Ovation M20R](#) and the [Cirrus SR22T](#) among many others. The recently announced Tecnam P2021 STOL will use the Continental 520.

The FAA is seeking feedback within 30 days of its Oct. 25 issuance from those who complied with AD 2020-16-11.

It requires cylinder head inspection and removal of the casting material build-up on the radius edge of identified cross-flow cylinder heads to reduce the potential for fracture initiation.

“The FAA needs additional input from the field in order to better understand whether any additional actions are necessary at this time,” the airworthiness concern sheet states.

The original AD was issued after reports of in-flight engine failures due to fractured cross-flow cylinder assemblies in the Continental engines.

“The unsafe condition, if not addressed, could result in failure of the engine, in-flight shutdown, and forced landing,” the original AD states.

“Continental remains committed to safety and will continue to work closely with the FAA during this ACS process, as we have since this radius blending issue was identified,” a company representative said in an email. “Since the bulletin’s inception, Continental has not received any reports of cylinders cracking in the field after the action steps have been properly performed as outlined in the MSB. We encourage all affected engine owners to follow the detailed work instructions and visual guides depicted in the MSB and promptly respond to the FAA. If you or your mechanic have any questions concerning the technical content in the bulletin or the action steps, please contact Continental’s team of dedicated technical professionals.” From GlobalAir News Vol 20 Number 90.

**OFFICER RESPONSIBILITIES**

## Article VII Chapter Officers

The Chapter Officers shall be: President, Vice President, Secretary, and Treasurer. The office of Secretary and Treasurer may be combined. The Chapter Officers shall be elected at the regularly scheduled November Chapter Membership Meeting and shall hold office for one (1) year, beginning January 1 of the following year and ending December 31.

## Article VIII Duties of the Chapter Officers

The following duties shall be performed by the Chapter Officers: The Chapter Officers may be called upon, or at their own discretion and in conjunction with direction from the Chapter Board of Directors, perform additional duties for the betterment, improvement, and well being of the Chapter.

## Section 1. The President shall:

1. preside over the Chapter and Board of Directors Meetings.
2. be the Chief Executive Officer and Chairperson of the Chapter Board of Directors.
3. have, subject to the advice, direction, and control of the Chapter Board of Directors, general charge of the Chapter business.
4. jointly execute with the Chapter Secretary or Treasurer all contracts and instruments which have first been approved by the Chapter Board of Directors.
5. call any Special Meeting of, {he Members of the Chapter Board of Directors and/or general Chapter Membership.
6. personally represent the chapter and coordinate matters with EAA local, state, regional! and national committees, councils etc.

## Section 2. The Vice President shall:

1. be vested with all the powers and authority of the Chapter President and shall perform the duties of the Chapter President in the case of the Chapter President's absence, disability, or inability, for any reason.
2. perform such duties connected with the operations of the Chapter at the suggestion or direction of the Chapter President.
3. The Chapter Vice President may annually recruit a certified public accountant or an appropriate group of Chapter Members to verify that the financial records of the Chapter are in order. The Board of Directors can determine how they want the report to be delivered, written or oral.

## Section 3 The Secretary shall:

1. have the responsibility to take and publish minutes of all meetings including the results of all elections and voting decisions.
2. be responsible for publishing notice of all regularly scheduled or special meetings.
3. keep a Chapter Membership Book, Roster or Record s\owing the name of each Chapter Member.
4. be responsible for maintaining the currency and security of the original copies of the Chapter Bylaws, Non-profit incorporation documents, tax exemption documents, Federal Employer identification Number (FEIN), and any other documents, books, papers, and records as the Chapter Officers or Chapter Board of Directors direct.
5. jointly execute, along with the Chapter President, all contracts and instruments that have been first approved by the Chapter Board of Directors.
6. in cooperation with the Treasurer, provide updated status and required correspondence with EAA.
7. perform all other duties incident to the Office of Chapter Secretary, subject to the control of the Chapter President and the Chapter Board of Directors.

**OFFICER RESPONSIBILITIES CONTINUED.**

Section 4. The Chapter Treasurer shall:

1. execute all checks authorized by the Chapter Board of Directors. By resolution of the Chapter Board of Directors, the Chapter may require joint signatures on all checks drawn on Chapter accounts.
2. receive and deposit all funds in a financial institution recognized by the Federal Deposit insurance corporation (FDIC) (for U.S. chapters), and approved by the Chapter Board of Directors.
3. report to the membership and account for all receipts, disbursements, and the balance of funds on hand.
4. ensure the Chapter obtains and maintains a Federal Employer identification Number (FEIN).
5. actuate maintenance of all insurance records, including the proper application, binding, and premium payment for all necessary insurance required by the Experimental Aircraft Association, incorporated
6. in cooperation with the Secretary, provide updated status reports and required correspondence with EAA.
7. Perform all other duties subject to the control of the Chapter President and the Chapter Board of Directors.

**ARTICLE IX. CHAPTER BOARD OF DIRECTORS**

1. The business and property of the chapter shall be conducted and controlled by the Chapter Board of Directors.
2. The Chapter Board of Directors shall consist of the following:
  - a. Class I Director: Directors shall be the Chapter President, Vice President, Secretary, and Treasurer.
  - b. Class II Director: Directors shall be three (3) to nine additional members elected to the position of Class II Director.
  - c. The term of office for Class I Directors shall be one (1) year. The term of office for Class II Directors shall be three (3) years.
3. The Chapter President shall preside over the Chapter Board of Directors as its Chairperson.
4. Meetings of the chapter Board of Directors may be called at any time by the chapter President or by a two-thirds (2/3) majority of the chapter Board of Directors.
5. Notice of Meetings of the Chapter Board of Directors, stating the location, time, and purpose of the meeting shall be mailed, e-mailed, faxed, telephoned, or personally given to each Member of the chapter Board of Directors at least 48 hours prior to the time of the meeting. If all of the Members of the Directors are present at a meeting, any business of the organization may be transacted without previous notice of the meeting.
6. A simple majority of the chapter Board of Directors, at least two (2) of which shall be Class I Directors, shall constitute a quorum of the chapter Board of Directors.
7. Each Member of the chapter Board of Directors shall serve as
