

By 10 a.m. the wind was beginning to increase and it was time to head for Lake Elmo. We always try to be back at our hangar by 11 a.m. to avoid the turbulence and roughness of the afternoon air. (Karen hates bumps!) The flight home was one of the smoothest rides of this summer season.

On the way back to Lake Elmo, we flew over miles of ripening corn, plowed fields, and Bailey's Nursery near Woodbury.

#### Final Thoughts for a smooth ride:

- 1. Look for the "Big Blue H". Best rides usually occur when a high pressure weather system is over the area.
- 2. Fly early in the day. The air gets rough in the afternoon.
- 3. Puffy clouds in the sky indicate a bumpy ride. Smooth air is usually found above the clouds, if your plane can climb that high.
- 4. Don't fly when winds are expected to exceed 20 M.P.H. on the ground. Turbulence often accompanies high winds.
- 5. Keep the cabin cool for passenger comfort.

The open positions official responsibilities as documented in our charter are:

The **Vice President** shall be vested with all the powers and authority of the President and shall perform the duties of the President in the case of the President's absence, disability, or inability, for any reason. The Vice President shall also perform such duties connected with the operations of the Chapter at the suggestion or direction of the President.

The **Secretary** shall have the responsibility to take and publish minutes of all meetings. The Secretary is responsible for publishing notice of all regularly scheduled Membership and Board of Directors Meetings. Additionally, the Secretary is also responsible for publishing notice of Special Membership Meetings. The Secretary, with the assistance of the Membership Chairperson, shall keep a Membership Book, Roster or Record showing the name of each Member. The Secretary shall also be responsible for maintaining the currency and security of the original copies of the Chapter Bylaws, Non-profit Incorporation documents, tax-exemption documents, Federal Employer Identification Number, minutes of all meetings, and any other documents, books, papers, and records as the Officers or Board of Directors direct. The Secretary shall jointly execute, along with the President, all contracts and instruments that have been first approved by the Board of Directors. The Secretary shall perform all other duties incident to the Office of Secretary, subject to the control of the President and the Board of Directors.

Note that under the Vice President, "shall also perform such duties connected with the operations of the Chapter at the suggestion or direction of the President." are currently to provide programming as needed for our regular monthly meetings.

Attendance to any meeting for any of these roles is not required but encouraged especially for board meetings as a quorum is required for actions to be binding.

#### **Aviation Day:**

Jack Miller has facilitated a couple of debrief meetings to collect insights and reports from members and participants and will use that information to make improvements for next year.

There have been some great ideas to enhance the event, but most of them cost money. The conclusion is that we would like to develop some sponsorship in order to fund those ideas. We would have a budget equal to whatever sponsorship we are able to get. Businesses could sponsor in exchange for advertising on t-shirts, fliers, etc. We would like to get sponsorship for \$2,500 to fund the event and we would like to net \$2,500 from the event. (This year we netted about \$1,200). Sponsorship money would go toward more signs and advertising and t-shirts that would be worn by the volunteers and include advertising for the sponsors.

We would be looking for sponsors who could donate goods (like sausage, pancake mix, coffee). We would also like to find sponsors who would donate funds. We need to continue to improve our organization and continue to improve the management of the volunteers. The idea is that there would be instruction cards for each activity so that each volunteer receives a card detailing what they would be doing in that area. Jack will send the planning checklists to committee chairs and asking them to review their list and update as needed.

The team also agreed to have more planning meetings that will begin November 10, 2015. The meetings can also be on a conference call so that people who are not able to attend in person would still be able to participate. The team will want to get started now on requesting support as most businesses are doing their budgeting for 2016. Brainstorming a list of businesses that might be good sponsors is a top priority. Suggestions should be shared with Jim or Jack. We want to remember that a big part of the event is the community outreach with the opportunity to make friends and help to build support for 21D and general aviation.

#### **Building upgrades:**

We need to look at our siding, re-painting has been required almost every year. The suggestion is to go to a maintenance free siding that would not require painting. We need to investigate options and get some estimates so that we can do it in the spring.
