

Notes from Cape Juby

With summer in full swing, I hope everyone is getting into the air and enjoying views of Michigan that one can only see from above. You should be getting fired up for Mason Aviation Days, which aren't too far away. Let's hope for good weather and safe flying all around.

I got this email from Vickie V. that mentioned the chapter would be handing out flyers for MAD from a trailer pulled by Dave Groh's jeep in the Mason 4th of July parade. Now what in the world does MAD stand for, I thought. Then somebody else had trouble with it, so I played around with words to highlight what it meant. I hope nobody got mad about it, and then again, I hope everyone got MAD *from* it!

While summer is that idyllic time when we appreciate the beauty of friends, good weather, great airplanes, and on occasion an outstanding thunderstorm, we are facing a storm of another sort in Congress. If you have not heard about the firestorm surrounding the fight in Congress over user fees for aviation, you need to do so, and do so right now. As I mentioned in some earlier Notes, the push behind user fees is coming from airline executives, who want you and I to pay for the ATC system that they use nearly exclusively, so they can put more money into their own pockets.

Remember the names Richard Anderson (formerly co-CEO at Northwest and now on the Board of Directors at Delta), Doug Steenland (CEO at Northwest), and Andrea Fischer Newman (Senior VP for Government Affairs at Northwest, and member of the Board of Regents at the University of Michigan). They are the source of this effort; they initiated it, and they are orchestrating it.

On my way back to France on June 6th, aboard a Northwest A330, I picked up the magazine in the seat back and opened to an article titled "Smart Skies". It was written by Andrea Fischer Newman. In the article, she says that the ATC system has reached its limits, and unless it is overhauled, delays will increase. "The FAA predicts that in the next 10 years, 10,000 corporate aircraft will be built, and they estimate that U.S. air traffic will triple by 2025. If the system is not modernized, flight delays will increase by as much as 62% in just the next 7 years."

She goes on to say that "Currently, the FAA receives about 94% of its funding from commercial airlines, primarily through the taxes that you pay on your tickets, and just 6 percent from general aviation. That might make sense in a world where airlines used that much of the system, but not in the real world, where airlines use only about 68% of ATC services. Every ticket you buy helps to subsidize corporate aviation."

What Ms. Fischer Newman overlooks is the fact that when 1000 airplanes are in the air and 100 of them represent corporate aviation, the percentage of people being moved is skewed heavily toward the airlines. For example, if the average airline flight were carrying 90 people, and the average corporate or personal flight were carrying 8 people, those 1000 airplanes would be carrying 81,000 airline passengers (99%), and 800 general aviation passengers (1%). So who is really using the system here? The airlines make profit from fares paid by all those passengers. The taxes that each passenger pays are what currently fund the system, and this is exactly as it should be. Do you think for a second that the airlines will lower fares if the tax is done away with in favor of user fees?

In addition, have you ever tried to fly into a major airport in the US with a general aviation airplane? Airlines have exclusive use of most airports where ATC services are the most concentrated. Most general aviation airplanes can't get into Detroit Metro, or Chicago O'Hare, or Atlanta, or Los Angeles. When we fly out of Mason Jewett and Land in Traverse City, we shouldn't have to pay for Clearance Delivery Services used by the airlines at O'Hare.

There is a good article in the latest issue of Sport Aviation (July 2007, p. 84-86). The author mentions the high user fees just to take an instrument proficiency check in Germany, highlighting the huge impact on aviation in Europe. He goes on to give his opinion that if user fees are implemented here, it will put an end to flying for a lot of people at the grass roots level, who are just barely finding the means to keep flying.

My opinion is that user fees will also have a severe effect companies who build, supply parts, and support the operations of general aviation aircraft. One example is Williams Research in Walled Lake, Michigan. They supply the engines for the Eclipse Jet, the first of the VLJs. The impact on their business alone will be severe, and that's right here at home where the state is already in an economic tailspin.

The article in the Northwest magazine by Andrea Fischer Newman encourages the reader to log onto a website, www.smartskies.com
As you can see, the airlines have developed their own website on this crusade of theirs and if you visit the website, you will find a form letter that they will either send or email to your congressional representative. Very convenient. In addition, AOPA reports that the airlines are emailing members of their frequent flier programs with the same information. Those people are generally business oriented and would be sympathetic to the cause of another business, just like theirs, right? Plus, they know perfectly nothing about general aviation, and are prone to believe what they are told as fact.

I hope I have convinced you that this threat to our right to fly is REAL. The airlines have declared war on general aviation. We cannot afford to sit back and say it will be all right in the end. It won't. We have to unite, and we have to make our voices heard loudly and very clearly to our elected representatives. Do it now. Make it a point at the next meeting to bring in the letters you've written and help the guy eating breakfast next to you get his in the mail. Bring stamps and envelopes! It is going to take that kind of effort, one letter at a time.

I would like to see 100,000 people at Oshkosh march down the main runway in protest of this proposal. It won't do any good to boo FAA Administrator Marion Blakey when she arrives. She is only the conduit that the current administration has used to push the proposal uphill to Congress. She does not make the decision. Congress does. Make your voices heard! This may be the single most important way that you can help your fellow pilot, because right now we all really need it!

Fly safely, too. I received word this morning that a friend of mine had an accident with a Zenith Zodiac a few days ago down in Ohio. He and his son are OK, but accidents are possible, and it's up to us to work hard to avoid them. In my friend's case, it was a short grass runway with tall corn at the end. They don't put the density altitude alert on AWOS for nothing!

AN ABRIDGED CHAPTER 55 HISTORY

In 1959 at the time of incorporation, there were ten members and a nomadic existence meeting here and there. Struggling to put a dime in the coffer, a large trailer was outfitted with a grill and coffee maker. The trailer was hauled to various airport locations providing pancake breakfast and lunch. Members' wives pitched in. This activity added monies and in 1985 with visionary leadership, knowing the Chapter had to have a home to be successful, a loan was obtained and the basic shell of the hangar and clubroom was contracted. Mason-Jewett was selected as the site. Members did all of the finish work, insulation, drywall, cement, septic system, furnace, electric wiring, gas lines and water well.

The first fly-in was made using the trailer to prepare breakfast. At that time, there was no water or sanitary facility. Customers were shuttled to the FBO. Shortly, the grill was removed and installed in the hangar using LP from 100 lb tanks. Additional grills were added and connected to natural gas. The well was sunk providing water usage. Tables were made from cheap doors with legs attached. (New tables later.) A service counter and overhang were built titled, "55's Pancake house."

A notion that membership meeting attendance would increase if a pre-meeting breakfast was offered. The notion worked well. Members from other chapters often fly in for the breakfast.

Membership grew to about 40. Itching for freedom of financial obligation Fly-ins were upped to 3 one summer. "Make it happen," became the motto. The hangar loan was paid off well ahead of time.

In 1989, the first air show was developed called "Mason Aviation Days," (MAD) A single aerobatic act with fly-bys of FBO aircraft. The cost was shared by the Chapter, FBO and the Mason Chamber of Commerce. The Chamber was solidly behind all MAD days that followed. Grants from the Capital Region Airport Authority allowed expansion of MAD into multiple professional acts through 1998. The event is a tradition eagerly attended by pilots and local community.

Meanwhile in 1996 a home builders annex was contracted. Again members did the finish work.

The Chapter became ready to undertake any event. The most ambitious being the Ercoups convention. Four days of meals for a lot of people. Additional help came from family members, friends and neighbors. A coming together and camaraderie not often seen. The Ercoupe folks were very appreciative.

The Chapter has grown to over 100 members and has become a model. Members from other chapters visit to observe the success. How did the Chapter get there? Through aggressive leadership and member commitment. All the while not forgetting the mission to foster and promote general aviation and allegiance to Headquarters EAA. Each year members make the pilgrimage to Oshkosh.

The Chapter history is best told by pictures seen on the flip file in the hangar.

Dear Congressman Rogers,

As you are fully aware, FAA reauthorization legislation titled "Next Generation Transportation System Financing Reform Act of 2007 proposes to fund the transportation system with user fees, mainly from the general aviation sector. If you take a quick look at my current address, you will note that although I maintain a residence and vote in Michigan, I am employed in France. This gives me a unique perspective on the impact of user fees on general aviation activity in Europe.

Personal flying has nearly come to a standstill here. Most small airports have very few airplanes based there, and the few buildings that support flight operations are old and in some cases disused. Fuel prices are significantly higher, mainly due to the high taxes placed on fuel, which is precisely what the FAA Administrator Marion Blakey is proposing.

In the country that invented and perfected the airplane, this will become a US tragedy, if YOU let it. I have paid into the Aviation Trust Fund from its inception in the 1970s. The Trust Fund is currently at record levels, and is expected to grow beyond projected US economic growth levels in the next 5 years. The User Fee proposal would raise \$1B less money over the same period. And this does not factor in the loss of revenue as the general aviation fleet in the US largely grinds to a halt.

General aviation worked hard to get out of a slump through the 90s, and it was accomplished with new products, modern technology, and regulatory reform. The reforms proposed by the current administration will set general aviation back to where it will unlikely recover even to current levels. The economic impact is significant, even in our home state of Michigan, where several aerospace companies depend on unrestricted growth in the general aviation sector. Williams Research in Walled Lake, Michigan that supplies jet engines for the new generation of very light jets would be greatly impacted. Do you really want to add more economic bad news to our state?

Thank you for giving consideration to my letter, Senator, and remember to vote NO to user fees as this legislation makes its way through congress.
