EAA Chapter 55 Board of Directors Meeting, Wednesday, November 6, 2024

The meeting was called to order at 7:02pm by President Rick Laub. In attendance were Rick Laub, Gilda Tucker, Gary Nicola, Drew Seguin, Ken Drewyor, Bob Clark (arrived 10 minutes late), Greg Hover, and Warren Miller. Absent were Dave James, Michael Rosencrans, and John Kuchar. Non board members present were Margie Clark and Joe Madziar. The Secretary's Report was noted. Drew Seguin made a motion to accept the report; seconded by Greg Hover; motion carried. The Treasurer's Report was summarized by Treasurer Drew Seguin. He noted an error in the report due to

failure to include October in the year-to-date final figure amount. He gave the corrected figure amount. Gilda Tucker made a motion to accept the report as amended; seconded by Greg Hover; motion carried. **★**Jeff Shaud was not on hand to give the Young Aviator's r eport, but Gilda spoke in his stead. Jeff will be unavailable to conduct the meeting of the Young Aviators which is to take place Sunday November 10th. His assistant will also be unavailable. Gilda asked if any of the board members would be willing to step up and lead the meeting. (Provided they had a completed Child Protection Policy Form on record.) Bob and Margie Clark agreed to lead the meeting. (Gilda contacted Jeff to inform him that the meeting could proceed as scheduled.) Gabe Blosser was not available to list the slate of candidates for the upcoming board member election. In his stead, Rick Laub listed the slate of candidates (which were written on the white board by Gilda in advance of the Saturday Member Meeting). The candidates are: Gabe Blosser, Bob Clark, Ken Drewyor, Doug Koons, Jon Iversen, Warren Miller, Greg Hover, Gary Nicola, and Jeff Shaud. The Board Member Election will take place Saturday, November 9th, 2024, at the Membership Meeting. Regarding the election, Gilda made a motion that if a member cannot be at the meeting they would, 1) assign someone at the meeting to vote in their stead (proxy) and, 2) inform Rick Laub of the person they selected to vote in their stead. Drew seconded the motion and the motion carried. The float used by the Chapter in the Mason Christmas Parade isn't covered by our insurance. The "Member of the Year" nominations were submitted and a vote took place. The results will be withheld until the presentation is made at the December Member Meeting. Results will be published in the January 2025 WingTips Newsletter. ★Margie Clark requested \$500 from the general fund to cover cost of food for the December 15<sup>th</sup> Chapter Christmas Banquet. Drew made a motion to grant the request; seconded by Gilda; motion carried. \*Ken Drewyor is responsible for the Member Meeting Close Out this Saturday. \*Joe Madziar gave an update on the Newberry Scholarship. Joe was assisted in the process of managing the project by Committee Members Ken Drewyor and John Kuchar. Nominations were open from October 1-19<sup>th</sup>. Five people applied. Of those five, four responded to a call for an interview. Interviews took place on October 30<sup>th</sup>. The results of the interviews will be withheld until the presentation at the December

Member Meeting. Results will be published in the January newsletter. A motion was made by Drew to give \$159 from the general fund to bring the total scholarship amount to an even \$2500; motion seconded by Bob Clark; motion carried. Gilda made a motion that the scholarship fund go entirely toward tuition of the Aviation Program at Lansing Community College. (The Aviation Program consists entirely of Aviation Aircraft Maintenance.) Greg Hover seconded and the motion carried. As there are no written guidelines regarding the Newberry Scholarship, Joe Madziar agreed to write up a set of guidelines.  $\bigstar$  Gilda gave a brief overview of her experience at the recent EAA Leadership Academy in Oshkosh. She and John Kuchar attended in October. All expenses except transportation costs was covered by the Academy. Gary Nicola made a motion that the Chapter cover the cost of transportation to and from the Academy in the amount of \$100; Greg Hover seconded; motion carried. \*Debbie Groh gave a written correspondence to Rick regarding the "Rosie the Riveter" event on March 21, 2025. We have opportunity, as a Chapter, to be a sponsor. No further details were available about the sponsorship. Debbie will be given opportunity to elaborate on this at the Member Meeting this Saturday. \*Mason Area Chamber of Commerce is hosting a fundraising event on December 5th. They are collecting donated items from various businesses and organizations (such as ours) to be auctioned off. Donating is a means of advertising for the donor organization. Rick Laub volunteered to donate wine. Gilda volunteered to donate a basket container. **★**Pat Salow has stepped down as Program Coordinator for our Chapter. Rick appointed Jon Iversen as Pat's replacement. ★The meeting was adjourned at 8:07pm. \*Respectfully submitted, Gilda Tucker, Secretary.



EAA Chapter 55 Membership Meeting, Saturday, Saturday, November 9, 2024

The meeting was called to order at 9:33am by President Rick Laub. After singing the National Anthem, Rick thanked the breakfast team, Steve Houghton and Jennifer Jacob. Next month's breakfast team: Stan Chubb, Nathan User, Allen Jencks, Gordon Hempstone, and David VanderMolen. There were thirty-nine present including two children of members and two guests.

Rick Springer was a guest of Jon Iverson and Joshua Huffman came on his own. Joshua is a veteran pilot desiring to get back into Aviation. Secretary's Report was noted. Joe Madziar made a motion to accept the report; seconded by Greg Hover; motion carried. Treasurer's Report was summarized by Rick Laub in Treasurer Drew Seguin's absence. Dave Trojan made a motion to accept the report; seconded by Jim Spry; motion carried. \*Young Aviator's Report was given by Gilda Tucker in the absence of Aviator's leader Jeff Shaud. Rick mentioned that the float the Young Aviators are decorating for the Christmas Parade isn't sanctioned in that it isn't covered by our insurance. \*Young Eagles Report was given by Rick in Margie Clark's absence. Margie's husband Bob Clark was congratulated on flying 700 Young Eagles! Rick also congratulated Doug Koons on flying 883 Young Eagles. Rick then extended thanks to all the pilots who fly Young Eagles. Jon Iversen asked about the safety record of YE flights. Several members gave basically the same answer. There have been a few fatalities over the years, but accidents are extremely rare. The overall YE safety record is excellent. **★**Doug Koons stated that our chapter has applied for a Ray Scholarship from EAA National. We will find out in February if we have been awarded one. **Bill** Purosky made a motion that the ballot distribution for the board be closed; Connie Bobcik seconded; motion carried. All members had been given ballots including those who arrived late. **Gilda** gave a report of her recent experience at the EAA Leadership Academy in Oshkosh. She attended the October Conference along with John Kuchar (who had attended prior to this conference). She stated that it was a very positive experience and that the conference was enjoyable and informative. Her main take-aways were: 1) being careful not to include copyrighted information in the newsletter without prior permission, and 2)the need to review the chapter by-laws annually. ★Gilda Tucker counted the ballots for the Board of Director's election. Candidates for the board: Incumbents Gabe Blosser, Bob Clark, Ken Drewyor, Greg Hover, Warren Miller, Gary Nicola, and Jeff Shaud; new candidates Jon Iverson and Doug Koons. There were thirty-one ballots counted. The votes were as follows: Doug K. (31), Bob C., Greg H., and Jeff S. (30), Gabe B., Ken D., and Jon I. (28), Warren M., and Gary N. (26). All candidates were elected. Congratulations to all and especially to the new members of the board Doug Koons and Jon Iverson.

The new board assumes leadership at the January Board meeting. \*Kristine Garcia is President of the Greater Lansing Nurses Honor Guard. The organization provides an Honor Guard at the funerals of nurses. Made up entirely of volunteer nurses, they cover the State of Michigan with their services. There are fifteen chapters in Michigan. Kris wanted to make our chapter aware of their services for anyone who may desire an Honor Guard at the funeral of a friend or family member. The organization is also looking for nurses to volunteer to serve as part of an Honor Guard. The service is free. Contact Kris at 517-243-3126 or email lansingmihonorguard@gmail.com. Debbie Groh gave a summary of the "Rosie the Riveter" event next March 21<sup>st</sup>, 2025. The organization honors those women who during WWII worked in factories in the USA building aircraft and tanks and equipment for the war effort. Our chapter was invited to be a sponsor of the event. John Kuchar made a motion that we sponsor an amount between \$250 and \$500; Frank Garcia seconded; motion passed. This will, of course, be at the discretion of the Board of Directors. A few people in our chapter have connections with a WWII pilot named Russell Hilding. Gary Nicola knew him. Elizabeth Kester, a friend of Joe Madziar, knew Russell's daughter. Russ was born in 1921. He flew a B-17 and was shot down over France. He survived and was taken to a German prison camp. Eventually he made it back home and lived in Michigan. The State of Michigan awarded Russell a Certificate of Recognition. Russ passed away in 2021. The plaque fell into the hands of Elizabeth who brought it to the meeting and donated it to our chapter. We also have a framed picture of Russell in our meeting room. ★Terry Lutz made mention of a volunteer-run charity entitled "Operation Good Cheer". This is a Michigan organization sponsored by the Child and Family Protective Services. Toys are collected at Oakland County International Airport in Pontiac. Donated toys are collected largely from organizations. Volunteers wrap and prepare the toys for distribution around the state on December 7<sup>th</sup>. On that day pilots fly in, load the toys and fly to airports across the state to be distributed to needy children in orphanages under the care of the sponsoring agency. Any pilot can participate but must register on line in advance. Pilots are given when to fly into Pontiac and then told where to fly to distribute the toys. Terry is participating this year. Next year maybe other pilots in our chapter may
