

FAA updates BasicMed



The FAA recently updated its <u>BasicMed regulations</u> to allow pilots to operate larger aircraft and carry more passengers.

<u>BasicMed</u>, which took effect in 2017, allows pilots to fly without holding an FAA medical certificate provided they meet certain conditions.

The FAA Reauthorization Act of 2024 required the FAA to expand BasicMed to:

- Increase the number of allowable passengers to six from five, and the number of occupants to seven from six.
- Increase the maximum aircraft takeoff weight to 12,500 pounds from 6,000 pounds, excluding transport category helicopters.
- Allow pilot examiners to conduct flight checks using BasicMed in aircraft that are covered by the BasicMed rule.

Pilots must meet specific conditions to operate under BasicMed, FAA officials note.

Among other things, they must have held a valid medical certificate at some point after July 14, 2006; the most recent medical certificate cannot have been denied, revoked, or suspended; they must complete a medical exam by a state-licensed physician; they must complete an online medical education course; and they must hold a valid U.S. driver's license.

BasicMed also includes certain limitations, FAA officials said. Pilots cannot fly for compensation or hire and are restricted to flying at or below 18,000 feet altitude and at a speed no greater than 250 knots.


Mike Baer - Director

NYPD Taps Drones For Airborne Police Work



Earlier this month, New York City Mayor Eric Adams and Interim NYC Police Commissioner Tom Donlon announced the city's Drone as First Responder (DFR) program. The initiative is now active in five commands (two drones each) within three of the city's five boroughs.

Missions include missing persons searches, alerts from the ShotSpotter gunshot detection system, robberies/grand larcenies "and other crimes in progress as needed." The drones will stage from the 67th, 71st and 75th Precincts in Brooklyn; the 48th Precinct in the Bronx; and the Central Park Precinct in Manhattan.

They will be used to supplement in-person police presence by providing high-definition audio and video in real time to officers' and supervisors' department-issued mobile phones. They can also serve in collecting high-resolution evidence for investigation and documentation; assessing potentially dangerous hazmat incidents without putting first responders at risk; and responding to natural disasters such as hurricanes, floods and earthquakes.

Mayor Adams said, "While the 'Drone as First Responder' program is what precision policing in the 21st century looks like, drone potential is really just taking off. We are leveraging the latest technology to enhance the NYPD's emergency-response capabilities, remotely sending drones to the exact longitude and latitude of where an emergency call comes and sometimes in as little as a minute."


