Old Business:

President Carter advised that he is still working on the 501-3C status for the chapter and in order to do that he will have to change the name to 595 RGV. The reason for the name change is because one of the previous Presidents put the Chapter in the rears fifteen to twenty years ago with the IRS or State. At some level, members of the chapter just forgot about administering the Chapter.

The original Chapter was formed in April 14th, 1948. A second Articles of Incorporation was done almost twenty six years later on April 15th, 2004.

A copy of a letter that EAA has on file for our chapter was found by our Chapter President Robert Carter.

To be a 501-C3 Corporation a certain language needs to be in the Articles of Incorporation. So our intention is to file new Articles of Incorporation to stay on top of it this time. The 501-3C is an IRS classification for the Corporation to get us a Tax Exemption status which allows us to accept donations that are tax exempt from any donors.

Therefore, the new Articles of Incorporation will have that language in it that the IRS needs to see. Once we complete this we should be able to secure a new EIN number for the Chapter. That will be helpful in pursuing other interests that we have for the benefit of the Chapter.

New Business:

President Carter has updated the Chapters' bank account and the Chapter is solvent. There had been some expenditures by Byron Engle (the previous President, who passed away recently), which such expenses were appropriate and documented on the banks balance sheet.

Also, this coming month of June is the International Young Eagles day from June 12th-14th, which we will not be involved due to we don't enough pilots.
