Jerry Gifford spoke to the airport manager about an open house that is being planned at T65 and Debora mentioned that all public use airports will eventually be assigned an all letter designation soon (like Harlingen is KHRL, Edinburg is KEBG, etc.) Pretty soon there won't be any numerical identifiers (except maybe for the privately owned airports/airstrips). The wheels of government (FAA) take their own sweet time to make the rounds, so no date was given, but it is coming, maybe in the next 60 days, or so.

There was some discussion of the destruction of the hangers on the West side of T65, but consensus is that it won't be very soon; maybe in 5 to 10 years, or so.





Debora mentioned that Don Crowe (who is a CAF member) invited one of the CAF's aircraft to the next meeting in Edinburg, which will probably be in February. More discussion was entertained about possibly having a few meetings in other locations, such as Brownsville and maybe even T65. Nothing was decided at this meeting, but will be brought up at another time.

at 10:30 a.m., before the meeting. What has been happening is that the meetings have been starting roughly at the earlier time, usually when everyone who is coming arrive at the venue. No action was taken on his complaint at this time, but something may be voted on in another meeting in the future.
