For our August meeting Bill Wade flew in with his recently back in the air IAR823. He did a couple missed approaches on his way out for us. On September 12th I went on a nice lunch flight to Basin Harbor Club on Lake Champlain. Dean Riggi and I went in my Cherokee and we met three other planes from Saratoga County there. This was my first time there except for a quick landing during my private check ride. No time for lunch then but we enjoyed a meal at the Red Mill just off the runway this time. There were several other planes and a couple of helicopters that came in while we were there. After lunch we took a walk on the grounds and to the lake for a spectacular view of the New York and the Adirondacks across the lake. Take off after was uneventful with a perfectly manicured 3000 feet grass runway. A little bit longer flight coming back but smooth flying both ways. It was nice to have a destination for a change instead of the recent "no particular place to go". The Champlain Valley has to be one of my favorite places to fly because of the great views on both sides of mountains with friendly terrain below.







I have been reading some of the IFR material and borrowed some simulator equipment to go along with what I had. Amazing how realistic things are getting in the home simulator set ups. I attached a photo below. This isn't even the recently released Microsoft Flight Sim which is supposed to be incredible. So advanced that none of my computers would run it because it needs a serious gaming device. This is Microsoft FSX and it works great. Dean Riggi asked me the other day if I had been to Marcy Field. I had not but I hopped in the virtual Tri Pacer and took off from Schroon lake, followed the Northway and then left up the Keene Valley. I flew to Marcy Field, dropped down to 2000 feet and entered the upwind for runway 2, crosswind, then downwind and base to final. All of the surrounding terrain in Microsoft FSX is realistic of what is actually there. I reported back that the terrain on the west side is a little tight but it didn't seem too bad. Very cool.

I was even able to do a custom paint job to replicate my Cherokee 180.
