# Key Discussions

### 1. Youth Aviation Program

- The 2024 Youth Aviation Program Guiding Principles document was distributed prior to the meeting.
- The Guiding Principles document was adopted by the Board with minor changes. Changes included replacing "job" with "responsibilities" and adjusting timing expectations for decision-making.
- The Youth Aviation Program has been on hold, pending approval of the budget.
  - A second bank account will be opened by the second week of January. For administrative purposes, the existing bank account will be used for Youth Aviation, and the new account for the General Fund.
  - \$5,000 will be deposited in the Youth Aviation account. The two 10,000 CDs will remain as-is, until needed.
- Each Youth Aviation Student will be listed as a Project in Quick Books, so that individual expenditures can be tracked.

# 2. Fundraising Initiatives

- Chapter 613 Proposed forming a dedicated fundraising committee, consisting of 3 people.
- Strategies included reaching out to potential donors and using chapter resources like spare airplanes.
- This will be posted in the January newsletter to see which members might be interested in joining the committee.

# 3. New Member Onboarding

- A process for welcoming new Chapter members was discussed.
