FAA Presentation by Jurg Grossenbacher, FAA Safety Program Officer (Milwaukee Regional Office):

Jurg Grossenbacher provided an excellent safety seminar that focused on issues related to aircraft landing accidents in Wisconsin. Last year there were 44 accidents in Wisconsin and 31 were related to landing problems. He makes approximately 80 similar seminars thought Wisconsin and has pioneered a popular and growing program called "Pro Tips." EAA Members are able to attend the program in person, use the RedBird Simulators and qualify for "Wings Credit." Completion of the program qualifies for the Ground Instruction portion of the Biennial Flight Review. Chapter #631 members were offered the chance to enroll in future programs and there is the option to view the programs "online" Saturdays. These FAA programs are designed for CFI's, General Aviation, Mechanics, and Drone Pilots. There is no cost for the Pro Tip Program which is worth from \$600-\$800 and includes a free lunch.

Grossenbacher complimented Chapter #631 noting there were far more "young people" in attendance at this Safety Seminar than any others. An encouraging sign that the Chapter is accomplishing their mission. Thanks Jurg!
