The Chapter extends a very special thanks to Randy Avera, NASA Engineer and FAA aircraft design certification engineer, for stepping up and helping with an extremely timely program on our return to space . . . "An On-Site Report of the Launch of Discovery on STS-114 and Memories of Columbia"

From 1977 through 1991 Avera worked for NASA Kennedy Space Flight Center as Lead Structures Engineer for the Space Shuttle Orbiter. Avera was involved with payloads such as the Space Lab, the Galileo to Jupiter probe and the Hubble Space Telescope.

A Principle Investigator during the Space Shuttle Challenger crash investigation (1986, Vehicle Breakup Analysis Team, Presidential Commission), Avera has written about his experience in "The Truth About Challenger" and the recently released, "Memories of Columbia," a 4-part book of fascinating stories about how Space Shuttle Columbia, the world's first reuseable Space Ship, was built, tested, and flown. Randy will discuss some of the challenges facing NASA and the recent launch of Discovery on STS-114.

A graduate of Georgia Tech's Aerospace Engineering College, Randy is a Safety Analysis Specialist for complex aircraft design certification with the FAA and has earned several FAA Awards for his accomplishments for your air safety. His presentation will be Saturday, August 6, 2005 in the EAA Hangar. Randy will have books available for autographing.

Jamie Hunt has been coming to AirVenture since the mid '90s. He used to fly his T-34 to the event. This year he arrived in a little bit different craft. In the late '90s Jamie had wanted to enlist in the Air Force and fly A-10s. But due to various minimums, he had been told it wouldn't be possible.

Then, at AirVenture Oshkosh 1999, right after another round of rejections from recruiters, Jamie walked up to one of the visiting A-10s whose pilot, call sign "Nomad," was already strapped in for departure. Jamie was pretty knowledgeable about the aircraft, so they talked about the plane. Suddenly Nomad asked Jamie, "Why aren't you doing this?"

Jamie explained about the roadblocks he'd run into, and Nomad said, that's not right, that the limits had been changed.

The ladder of the A-10 was already up, so there was no way for Jamie to reach Nomad in the cockpit.

"So I took my camera case," remembers Jamie, "put my business card in it, and threw it up to him. He replaced it with his card, and threw it back down."

"I called him like that Monday, as soon as I got back." They talked and Jamie began the process of joining the Guard and flying A-10s. Jim "Nomad" Lawrence, a highly decorated, 35-year veteran became Jamie's mentor.

This year, Jamie flew into AirVenture again. But this time, Jamie, call sign "McGruff" Hunt arrived in a Massachusetts Air National Guard A-10 "Warthog." He was accompanied by others from his Guard unit, including Nomad.

"And now, six years later," says Jamie, "here I am taxiing an A-10 into the West Ramp. I mean, that's unbelievable! And I was sitting in the cockpit when I shut down, and people are taking pictures. I know it's corny, but you know there are probably some little kids out there who are in my position and who would love to do this job. And here I am, living proof that AirVenture works. There's always a way to get where you want to be."



# The Washington, D.C. Air Defense Identification Zone

AOPA opposes an FAA proposal released today that would codify flight restrictions in the Washington, D.C..

metropolitan area. The restricted area would be designated as "national defense airspace" and would replace the current air defense identification zone (ADIZ), covering nearly 2,000 square miles and extending to an altitude of 18,000 feet.

"AOPA recognizes the necessity to protect the national assets in the nation's capital. The 15-nautical-mile-radius no-fly zone known as the flight-restricted zone (FRZ) does that," said AOPA President Phil Boyer. "But we take strong exception to the FAA's proposal to make the temporary outer ring of Washington's defensive airspace — the ADIZ — permanent."

The FAA proposal also reiterated the agency's statutory authority to, with the appropriate evidence, pursue criminal prosecution against anyone who "knowingly or willfully violates" national defense airspace. Current law provides for fines or imprisonment for up to one year.

Since the September 11 attacks, the government has made numerous upgrades to security systems around

the nation's capital, including a new visual warning system (VWS) that uses lasers to warn pilots away from restricted airspace, anti-aircraft missile batteries, and greatly improved radar coverage. Such measures significantly enhance the protection offered by the FRZ, making the ADIZ unnecessary. To read more on the proposed permanent ADIZ visit www.AOPA.com.

The news of the proposal had barely crossed the wires when AOPA President Phil Boyer and the AOPA media relations team began once again to explain to national and local media why a permanent ADIZ wasn't necessary, why it hurt pilots, and why there were better solutions to the problem.

"The ultimate penalty already exists," Boyer told reporters. "A pilot who wanders into restricted airspace could get shot down."

AOPA pointed out that a GA airplane has never been used in an act of terrorism, and the government admits that it has no intelligence to suggest that terrorist groups are currently planning to use GA aircraft in attacks against the United States.

The restricted airspace is cumbersome and inefficient, an operational failure. The FAA has never devoted the resources needed to make it work. It's hurt businesses, pilots, and controllers.

"If there's any good to come out of this proposal, it's that the public will finally have 90 days to comment on it," Boyer said.



# FAA Wants Changes to Funding Structure




a call that sent a chill through many of those attending her Meet the Administrator session at EAA AirVenture last week. In Oshkosh, she used the phrase "User pays also means user says." In a discussion with reporters in Washington, she again raised the specter of user fees. "I think it is very realistic and very important to look at a different set of structures of taxes and fees that ties the cost of the system more closely to the revenue that is coming in," she said, according to The Dallas Morning News.

It will be up to Congress to decide what, if any, changes are made but the FAA is acting to help members in their deliberations. Blakey told the reporters that a study is underway to determine how airports and FAA services are used and by whom. The results will be available as the legislators get ready to ponder the bill to reauthorize the agency. Blakey maintains that the Aviation Trust Fund, which is derived from airline ticket revenue, is being depleted because of fare reductions, and that there's a fundamental disconnect between those who finance the fund (passengers) and the FAA. The National Air Traffic Controllers Association (NATCA) did its own study of the fund and determined that it's healthy, but that policy makers had shifted more of the burden for funding the FAA from general revenue to the fund.


