# Nancy Causey to Speak at February Chapter Meeting

John Reitz, Chapter 690's new Vice President, has announced that our guest speaker for the Chapter Meeting on Friday, February 13<sup>th</sup>, will be Nancy Causey, Support Specialist at the Macon Flight Service Center.

Nancy has held a variety of job positions - clothing buyer, store decorator, newspaper reporter, secretary, and school teacher. In 1978 she started her Federal government career as a supply clerk at Kings Bay Naval Submarine Support Base, where she was the first civilian hired. In 1979 she transferred to Jacksonville Center (ARTCC) at Hilliard, Florida where she was a secretary to the Personnel Director.

During that period Nancy took the air traffic control test. After the Professional Air Traffic Controllers Organization (PATCO) strike in 1981, she got a job with the SSI Flight Service Station (FSS). When the smaller flight services were consolidated into larger Automated Flight Service Stations (AFSS), Nancy elected not to transfer to Macon and went back to school and obtained her real estate salespersons license and brokers license.

After a year Nancy went back to the government, working for the Department of Treasury, with the Federal Law Enforcement Training Center. She was offered an opportunity to come back to the FAA and air traffic control at MCN AFSS in 1991. Nancy became the Support Specialist for Training in January of 2002. Some of her duties are to ensure that the facility training program is planned, conducted, assessed, and revised on a continuous She develops lesson plans, conducts basis. classroom training, and provides oversight and direction to operations supervisors to ensure compliance with training directives. Nancy assists employees with individual development plans by locating resources for their training.



# The President's Pitch

Winter is almost over and springtime flying is just around the corner. Let's start our planning for the Sun'n Fun Fly-In which startsTuesday, April 13. It looks like the Sport Pilot License will be reality by then and we'll see even more products and services aimed at the Sport Pilot as well as a strong focus on our continuing Young Eagle Program. The theme of Airventure 2004 later in the summer at Oshkosh this year is "Launching the Next Century of Flight." The AirVenture planning guide will be available soon.

We had a good turnout for the January meeting, with a total of 58 attending, including 7 visitors and several new members. If you missed meeting, you missed outstanding presentation by Robert Ormsby on flight prior to the Wright Thanks to those who Brothers. renewed their chapter membership at the meeting. If you haven't renewed yet, see Membership Chairman Glenn Clark at the pancake breakfast or at the February meeting. You can also renew online with a credit card at our web-site (www.eaa690.org). have another super program for our February meeting; don't miss it.

Marc Stewart, Aviation Artist and friend of EAA Chapter 690, has recently opened an art exhibit at the Museum of Aviation at the Robins Air Force Base in Warner Robins Georgia. Several EAA 690 members attended Marc's opening reception at the museum and had a few hours to tour the facility. If you haven't visited the museum in the last few years, you will be impressed with the new 60,000 square foot Century of Flight Hangar as well as the Eagle Building and the entire facility. Almost 100 aircraft are on display including 20 fighters, 17 cargo, 8 bombers and 10 helicopters. They also have on display various missiles, drones, trainers and others ranging from an Aeronca Champ to the U2 and SR71. I plan to go back to spend more time at the museum soon; maybe we can plan a chapter fly-out to Macon this year. By the way, Marc's exhibit is open through March 14, 2004. The museum has a neat

web-site with lots of graphics and sound (<u>www.museumofaviation.org</u>) and admission to the museum is free.

The second century of flight is off to a good start with many local and national youth education programs under way. A planning meeting was held at PDK on January 19, with representatives from various aviation organizations, schools, local aviation busineses and representatives from EAA Oshkosh. EAA 690 members Debi Huffman and Duane Huff are participating in the new Georgia program called GCASE; we'll ask them to give us an update at the February meeting. This is an exciting program and fits right in with our Young Eagle and youth education programs.

An important regulatory issue in the works now is FAA's Notice of Proposed Rule Making (NPRM) 4521 regarding the National Air Tour Safety Standards. This rule, if approved as written, will significantly impact air tour companies, charitable sightseeing flights, charitable medical transport flights and vintage aircraft demonstration flights. Due to pressure from EAA and others, the comment period for the NPRM had been extended to April 19, 2004. I would like for everyone interested in this important issue to send a comment to the FAA. It only takes a few minutes and I'll show you how to do it at the February meeting.

Good news on the regulatory front is that, thanks to EAA's efforts, the Department of Transportation (DOT) has approved the Sport Pilot rules. This is a major milestone for general aviation; we are almost there. The Office of Management and Budget (OMB) has up top 90 days to review the package and upon their approval, it becomes a file rule!

Georgia Wings Weekend will be at LZU again this year from Friday, April 30, through Sunday, May 2. If you are a pilot, check it out now and sign up at <a href="https://www.wingsweekend.com">www.wingsweekend.com</a>. If you attend the program and fly with one of the instructors you will not only improve your proficiency, you will satisfy your flight review requirement. Be sure to

# CBS NEWS PIECE IRRESPONSIBLE TOWARD GA

EAA has reacted strongly to the CBS Evening News segment aired Wednesday evening, January 14th regarding the lack of security within general aviation, spotlighting residential airparks in particular.

"We thought that the CBS Evening News had higher integrity and better news judgment than what they aired as their so-called investigative piece, which lacked balance or even basic fact-checking," said Bob Warner, EAA Executive Vice President, in communications to the network Thursday morning. "CBS completely ignored the security improvements throughout general aviation over the past 30 months and presented a sensationalistic piece that will do nothing to inform its viewers or solve any issues."

Among the specifics that EAA called to CBS' attention were:

\* More than a dozen direct security improvements have been recommended for general aviation since September 2001, many of which have been adopted;

- \* EAA has learned that CBS declined an interview with the Transportation Security Administration (TSA) that outlined the security improvements in GA since 9/11, despite TSA requests for an interview with their agency, which is directly responsible for aviation security, or with aviation groups such as EAA;
- \* No apparent contact was made with any aviation organization for background. EAA was not contacted prior to airing of the segment;
- \* The only official interviewed was a retired NTSB representative, with no indication to his aviation security knowledge or background;
- \* A complete lack of context as to the extremely low security threat posed by GA aircraft when compared with cars, trucks, boats and other forms of transportation;
- \* A misguided definition of airparks, which are rarely used for flight training.

"Residents of airparks create no more security risk than people who keep cars in garages in residential neighborhoods," Warner said. "In fact, the average SUV or small truck has more payload than a typical general-aviation aircraft. To indicate that small aircraft present a potential threat larger than any other type of transportation is not only wrong, it is an irresponsible scare piece." # EAA DISCUSSES AVIATION SECURITY AT GAO

(From WWW.EAA.ORG) EAA Vice President of Government Affairs Doug Macnair recently briefed General Accounting Office (GAO) officials in Washington, D.C., on EAA and its role in helping assess general aviation's security needs and solutions. Macnair addressed a statement made by a GAO official late last year that "GA is far more open and potentially vulnerable than commercial aviation" and that "TSA (Transportation Security Administration) has taken limited action to improve GA security." In reality, much has been done to address GA security.

Immediately following the 9/11/01 attacks, 12 recommendations to enhance GA security were developed and widely distributed by members of the GA Coalition. In addition, Airport Watch, a program developed by the Aircraft Owners and Pilots Association (AOPA), provides common sense security recommendations for people at airports, including a TSA hotline to report suspicious activity or people, 866/GA-SECURE. (An EAA version of the Airport Watch videotape was distributed earlier this year to EAA's vast network of more than 1,000 Chapters, including comments from EAA President Tom Poberezny.) The National Association of Flight Instructors (NAFI, an affiliate of EAA) also developed a series of security recommendations and best practices for flight schools and flight instructors that have been distributed widely throughout the flight training

community. NAFI is also working with TSA to develop a security awareness training syllabus for flight schools and FBOs.

More recently, the Aviation Security Advisory Committee (ASAC) submitted to TSA the General Aviation Airport Security Working Group report, which outlines airport security recommendations going forward. Response to security at a GA facility should come from and be coordinated by a local community with what assets they have available, the report states.

"It's not about spending \$100 million on airport fences," Macnair continued, "It's about leveraging the assets and integrating the monitoring and response into the local plan that encompasses everything in the community, not just the airport, but all infrastructure. Focusing single-mindedly on airport security isn't a viable solution."

"GA has been repeatedly criticized for being vulnerable to misuse but this, in isolation, does not pose a threat," he added. "GA aircraft simply have not proven to be an attractive choice for terrorist activity when compared to other readily available personal conveyances. Boats and automobiles have a long history of being used in terrorist activities worldwide because they can carry more payload, have similar access to sensitive areas, and can do far more damage with greater predictability than a light general aviation aircraft. Yet, in the marine and automotive security world, the focus is on large ports and the protection of sensitive facilities, with the recognition that you cannot make recreational boats and personal automobiles secure in every location they exist. Similar logic needs to be applied to recreational aircraft."

Mike Stewart called the meeting to order. The aforementioned chart (less election results) was presented to those in attendance. The trustees left to elect their officers and conduct their own meeting. The directors then elected their. Election results were added to the above chart.

Other attendees included: Frank Wilcox, Joel Levine, Lnor Levine, Dave Haskell, Lee Craymer and Jeff Gwathney.

#### Reports

Mike Stewart gave a treasurers report. The proposed budget is a "duplicate" of the 2003 budget, as both revenues and expenditures are expected to be similar. The discussion was tabled pending a vote next month.

Mike North has posted a signup sheet for Pancake Breakfast tasks. He's asking for volunteers to spread the work load. Mike requested a notice of the signup sheet be placed in both the NavCom and the website. Mike had to purchase warming trays to replace those on loan to the chapter by a member that needed them back. This prompted a general discussion regarding building security, which will be handed off to the trustees.

Glenn Clark, the new Membership Chairman, is expected to be at Friday's chapter meeting. Mike Stewart will take dues any way he can. Lee Craymer suggested we put a drop box in the hangar to make collection easier. Lnor Levine says we can insert a bill for dues in each member's NavCom. National insists on having the national membership number.

Joel Levine says publicity is in good shape with everyone except national. They want copies of our insurance policies before they will publish any of our activities. Larry Bishop sent the necessary documents to national, and will copy Joel for reference. If anyone finds any publicity item(s) in any Gwinnett publication (newspaper, etc.), please make sure Joel receives a copy.

Mike Stewart raised the question of the chapter library. Barney Barnes, our postmaster and librarian, is leaving us for Ohio. Larry Bishop has a new "volunteer" already in mind. We expect to revisit this topic next month.

Lnor tells us all is well with the NavCom. It was late getting out last month due to the holidays. The question was raised regarding publication/distribution of the NavCom in electronic format, either via e-mail or web link. (The topic was moved to New Business.) There are no paid ads, but no one is adverse to the idea as a form of revenue generation. Guidelines for classified ads by members already exist and are published in the NavCom.

Mike Stewart tells us the chapter web-site is now hosted by an ISP... for free. We are getting great feedback from a Linux based open source piece of contact management software. Mike says we regularly receive hits from all over the world. Mike also brought up the GAFI question: do we do it again, and if so, when? Dave Haskell suggests we define a date now so we can start working with vendors/sponsors now, rather than later. We need to charge a fee to the vendors, as a revenue source and as a way to get them to respect the event. September 18 was tentatively set, which matches last year's third Saturday in September, pending a review for conflicts with other events.

Mike asked about fly-outs. Tim Fulmer is no longer the fly-out chairman. Is Greg Jannakos still "taking over?" Larry Bishop will investigate. Fly-outs were very successful in 2002, but 2003 had weather problems. Larry suggested we use IFR capable aircraft and plan to go farther. Lee Craymer suggested Sun N' Fun in Florida. Once a chairman is identified, the discussion will resume.

Mike asked about the project visit program. Do we want to continue the idea? If so, who will chair it? Do we want to expand the Chili Cook-Off by adding an Open House and Friendship flights?

#### **Old Business**

Larry Bishop has investigated the leasing situation. Our current lease is for a period of 25 years. We may be able to extend that to 40 years if we, with Astron, are willing to accept responsibility for the vehicular security gate. Other airport leases are being examined to determine if there is a way to obtain the extension. At this time, the Airport Authority is not interested in leasing any more land to us for additional hangar space.

Larry also reported on the insurance situation. The main chapter hangar's coverage is okay. The question is for the remaining hangars leased to chapter members. National will not quote insurance for them. The owners need to obtain "slip and fall" insurance from their current carriers in order to meet National's requirements. In Larry's case, all this took was a phone call. Larry will approach the other lessees to get this done. We will maintain a file in the main hangar for audit purposes.

#### **New Business**

Larry Bishop will propose a plan for committees to the Board for review next month. Joel Levine proposed we honor our past presidents with something like a piston gavel. There are 10 past presidents eligible for the award. Joel and Frank Wilcox will investigate the costs.

The Trustees returned, with the election results as shown in the above chart. David Posey will focus on the water line problem, followed by the air compressor hookup. The Directors requested a membership renewal drop box. Lee Craymer tells us the hangar phone responsibility must change as Don Roberts, the current "owner," no longer wants the responsibility. Mike Stewart and Duane Huff will resolve the issue.

Duane is concerned about the Young Eagles. We plan to fly

them on January 17, but Duane wants Debbie Huffman's input prior to setting any mores dates. After some discussion, a plan was set to continue flying Young Eagles on the first Saturday of each month, so long as they were twenty or fewer in number. Any "overflow" would be flown the third Saturday of the month. This will enhance safety, and provide the YE volunteers a chance to sit in on the presentations following the Pancake Breakfasts. As chairman of the YE effort, Duane Huff now has the authority to schedule YE events outside of the aforementioned schedule without Board oversight.

Duane has been approached by the Cub Scouts to use the hangar for two Pinewood Derby races in March. Frank Wilcox will get a calendar posted in the hangar to track these and other events, including the annual Chili Cook-Off set for March 20<sup>th</sup>.

The NavCom was discussed. Do we stay with paper or move to electronic distribution, or both? Paper is believed to be more likely to actually be read, but electronic is cheaper. The web-site contains the NavCom before actual print publication, and is in color. Lee Olson came up with a compromise: Joel Levine will include a link to the web-site for the NavCom in his NOTAMS to the membership as we continue the printed version. Mike Stewart will check the web-site's usage stats to determine if the strategy drives more visits to the web. We'll reevaluate after giving the NOTAM link a chance to work.

Lee also is concerned with the annual Hangar Dance. He believes we should begin planning now, since this major event requires substantial management. He has a proposed process flow for Larry's review before bringing it to the Board.

Per his plan from the last meeting, Larry asked us all to review last year and think about this year. What did we do right last year? Young Eagles, scholarships, Pancake Breakfasts, GAFI and operating "in the black" were all deemed "good." The "bad" included leaving members behind in terms of interactive engagement, a lack of Young Eagle follow-up, and the Chapter answering machine out-going message. Ideas to improve one or more areas included more youth outreach and education, such as a day camp, or assisting Scouts with their aviation merit badge. Duane plans to investigate a mentoring program as a form of YE follow up. Encouraging each other to meet and greet everyone at the social events may alleviate the "left behind" syndrome. And a permanent sign on the road pointing our way would be a big help.

After the "good, bad and ugly" discussion wound down, Mike Stewart adjourned the meeting.

Old Business
Mike Stewart made a treasury report. We have made so much money, we have to file with the IRS. We're in the black. The major issue seems to be access control over the water supply, which is a trustee issue. Major revenue generators include membership dues, pancake breakfasts, and the annual hangar dance. A visit by the EAA B-17 also generates a significant amount of revenue. Will we see it next year?

Is there a new lock on the alternate gate? Is there any possibility of making that route an all-weather road? Someone (not clear who) needs to get with Matt (who?) about this.

The chapter now has 501c(3) status. This is not an issue to Oshkosh in general, but since we did it, they want the details for their records. Larry Bishop & Mike Stewart will handle this off-line. This is an advantage should someone wish to make a large tax-deductible donation to the chapter.

New Business
According to Larry Bishop, a former member is paying the phone bill. Lee Olson will check with Bellsouth for alternatives.







# The March 1st Saturday Pancake Breakfast & Program to Feature An Alaskan Adventure

Chapter 690 member Ted Rabenko will share pictures and stories of his trip to the Arctic Circle in a Cessna Skylane.

During a lunch conversation in Marietta between Ted and Herb Williams, Herb was describing his trip to Alaska the previous year in his Skymaster. Herb wanted to repeat the trip and Ted had been thinking about such a trip. And so it began. While Ted was visiting family in Connecticut he described the Alaskan adventure to his cousin Ray Navage. This filled out the trio that made the trip to Alaska.

The plan was to fly Ted's Cirrus SR20 to Alaska, but after a weight and balance calculation, it was found that three people and baggage-in the SR20 left room for only 20 gallons of gas. The SR20 would need to be on the ground every hour for refueling. They needed a different airplane! They found a 2000 model Cessna Skylane for rent. The Skylane could be loaded with all the people and gear plus enough fuel to fly for seven hours. Perfect for this mission!

The adventure began north of Atlanta on May 25, 2003 and was completed in Atlanta on June 5<sup>th</sup>.
