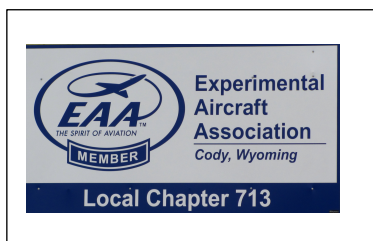

EAA Board Meeting Minutes EAA Hangar, Cody, WY Tuesday, March 22, 2022 at 9 AM

Karl opened the meeting with all members present except Ken Foote. The February minutes were read and accepted as read. The treasurer's report was given by Karl in Ken's absence. As of February 28th, we have \$11,778.11 in the Pinnacle checking account, \$10,000 in the Leroux scholarship fund, and \$1,012.06 in the Hawk scholarship jar collection. Then Karl shared exciting news! We have just received a \$1,000 anonymous donation to our Hawk scholarship fund. Next month will show that increase. Thank you to our donor for such generosity. You are a blessing to our club. The treasurer's report was accepted as presented.

Old Business: Our March club meeting showed 20 present with 3 of those guests. The members enjoyed a presentation on Stinger missiles and VA benefits by Brad Cline.

Next fund raising for 2022 was discussed. No definite news concerning the Choice Air Fair or Powell Air Show is known yet, but the board feels we could put together a fly-in/car show and Young Eagle event if these other ideas do not move forward.

The rental use of our club room by another aviation group will cease. They have found another venue that is free. A thank you to Karl and Ken for the installation of the new blinds. A comment made about them was “perfect.” They add to the finishing of the room and will be useful to be able to close them as needed at meetings.

New Business: Tom reported that there are no new scholarship applicants. Karl reported that he consulted Mike about concrete work at our hangar door. Mike will assist greatly in the concrete upgrade and may be able to take advantage of residue concrete from other jobs to complete our job. Additional research and coordination with the airport are needed. The club would need to cover the cost of the rebar at this time. Estimates are in work and no firm dates for start or completion have been determined. Karl will obtain approval through email when a firm estimate is available.

Chuck had no GA information to report from the YRA Board meeting. He did report that we have 51 paid members to the club.

Next club meeting, April 12th, will be another discussion from Dave Gianakos on the lunar module that he worked on at the Smithsonian. We may also have the airport manager from Greybull come to tell his plans for upgrading the Greybull airport. Tom also told us that he will need a replacement as VP for the 2023 year. Our food for the April meeting will be lasagna and salad.

With several of our Board and Officer members gone in April we will not have a board meeting. The next board meeting will be May 24th at 9:00. Planning for the May club meeting was discussed so we will be ready.


I will not be in attendance at the April club meeting. There is nothing to report for this month’s newsletter. Regarding membership, there are no new members to introduce.

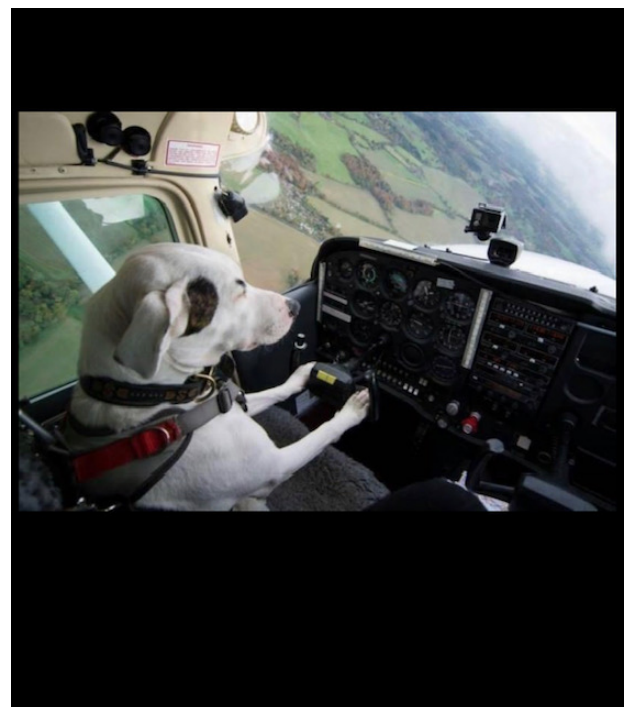
