News from the YRA Board:

The old rental car wash facility across from the fuel storage area has been leased to Cowboy Farm LLC for a five-year period for non-commercial purposes and will be used primarily for vehicle storage. At the end of the lease term, the Board will review whether the property is needed for aeronautical purposes. There are a number of utility junctions next to the lot that prevent it from being a candidate for hangar development. For the present, this lease seems to be the best use for the buildings.

SkyWest Airlines, flying as United Express, has their lease expiring at the

end of 2022. They lease space in the terminal building for office space, counters and common areas. With the terminal undergoing expansion and remodeling, the decision was made to extend their current lease for a year. A long-term lease will be negotiated at the completion of the building project.
