October 25, 2022

Karl opened the meeting with all present except John Leroux. The September minutes were read. Two changes were noted. The scholarship program will be a rewrite, not a final copy this month and the old manuals we received from Choice

include *technical* and *parts* manuals. With these corrections the minutes were approved. Our last club meeting was well attended with 27 members and Bill Schneider's presentation on accident investigation and safety was well done including photos for clearer explanation. Thanks Bill!

Ken gave the Treasurer's report. Currently we have \$14,210.75 in the checking account including \$1,522.00 in the scholarship jar and \$10,000.00 in the Leroux scholarship. This past month we did purchase 22 used chairs for \$80. The treasurer's report was accepted as presented.

Old Business – Karl presented new copy for our 2 scholarship programs. There were a couple obvious changes and then we each received a copy to read and return next month with any other suggestions. Next Karl asked for some help to remove the concrete slab at the hangar door. Once removed a decision will be made as to whether to dig deeper and replace it or just add some stone as a temporary fix. There are now filing cabinets in the hangar for those manuals we received. Those manuals placed in the filing cabinets will enable anyone to better refer to the material we received.

New Business – Cebe presented the information she learned from The Ivy concerning having an **Hors d'oeuvres Christmas party.** Working with their

menu we feel we can do this for \$24 per person. Karl also had some information about catering it at The Terrace, but at a higher cost. 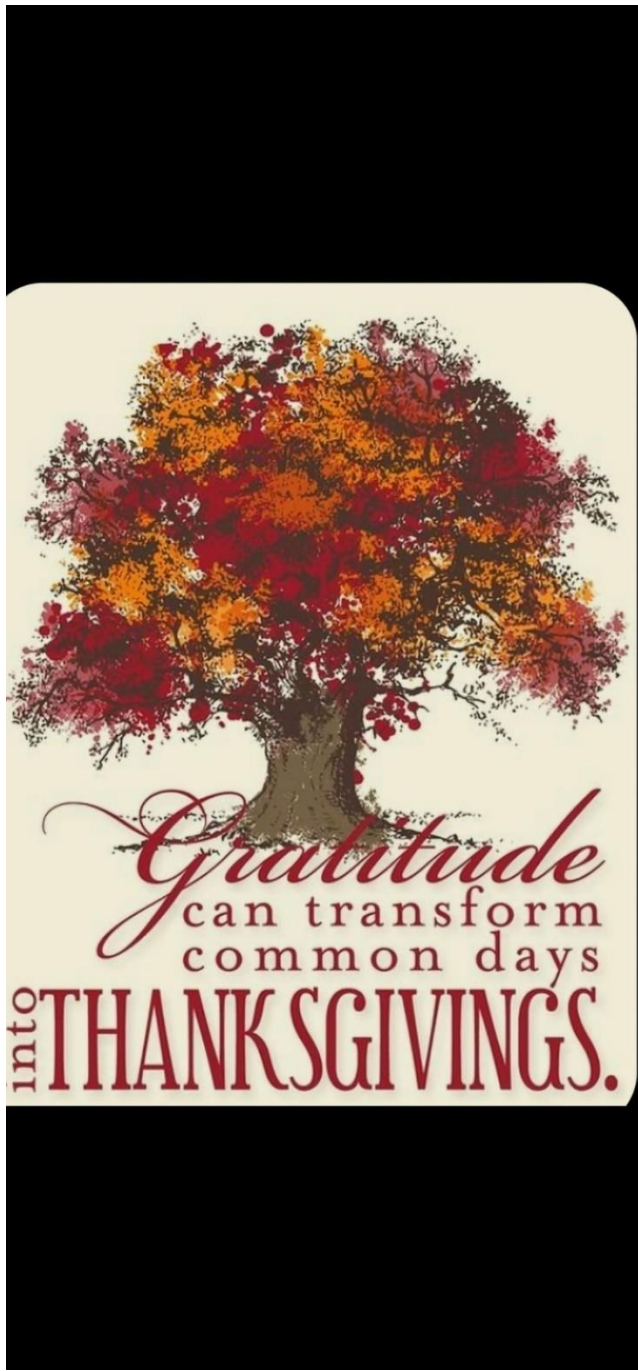

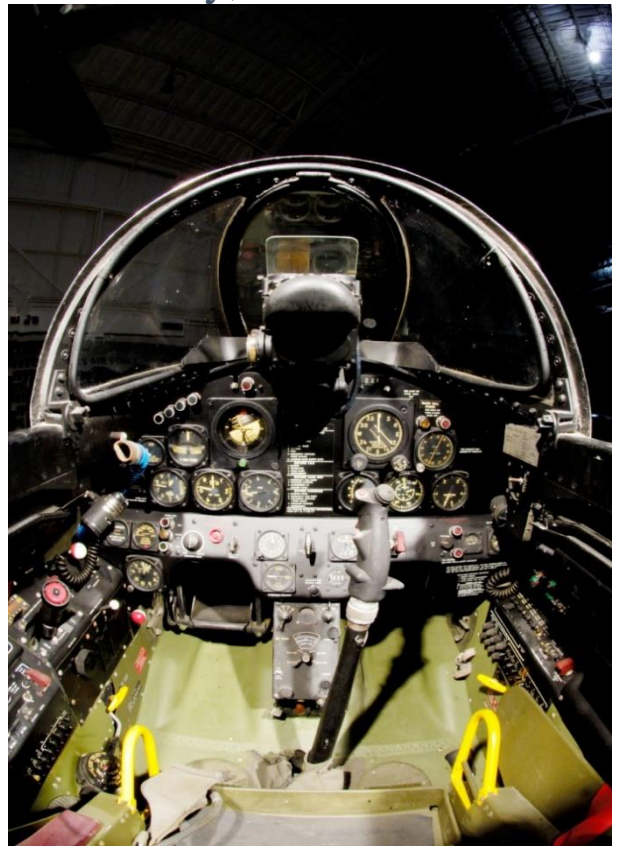
