Around the Airport

<u>County</u>

Environmental Services Associates has been selected as the Aviation Planning Services Consultant to conduct the Environmental Assessment required to support all short term improvements recommended in the recent Grants Pass Airport Master Plan Update including the proposed runway extension. The specific scope and fee of the EA will be determined in close coordination with the consultant and personnel of the FAA's Seattle Airports District Office.

Two federal grants distributed by the FAA have been received under the Coronavirus Response and Relief Supplemental Appropriations Act. Grants Pass Airport received \$23,000 and Illinois Valley \$13,000. The press release states they are for Coronavirus relief, but the legal language allows them to be used for any legitimate operational or supply expense. Larry extends a heartfelt "Thank You" to the American taxpayers.

Two Airport Day planning meetings have been held to date via Zoom, the latest just this last Thursday. It was noted that the original proposed date of June 26 would be problematic because the removal of the underground fuel tank and rebuild of the fuel island will be underway at that time. Lena Traeger suggested we consider early fall to hopefully put us past fire season. After much discussion, Oct. 16 emerged as the preferred date with Oct. 9 as a possible alternate, dependent on a full review of possible conflicts. A final decision will be made at the next meeting to be held Mar. 25. The format will be similar to past years, but ideas for additional participants and events are being solicited. Several pertinent issues we have had to deal with in the past were discussed including parking, one of the most critical concerns. Previous years' parking issues will be exacerbated due to the likely unavailability of the Armory parking lot due to ongoing construction activity there. Off-site parking with shuttle bus transportation seems to be the favored solution, and potential locations have been identified. Follow up will include contacts to determine availability and obtain permission.

- The "Medford Wing" is now fully operational with the Seminole and a 172 assigned. They have signed up 7 students for instruction at that location.
- Chad Shultz has officially joined the instructor staff.
- The Cherokee 140 previously owned by Ed Lee is now available for instruction and they're looking for another 172 or similar aircraft for the coming summer so they won't run short of available aircraft in the event of a maintenance grounding.
- Four checkrides are coming up in March, 3 private and 1 commercial.

Future Happenings
