I moved to the area from Beaver Dam a year and a half ago after starting a new job at American Orthodontics in Sheboygan. I am an instrument rated pilot and part owner of a Cherokee 235 Charger which is based at Dodge County Airport. I decided to get my pilots license while in college after taking a flight with a co-worker on a summer job (long before Eagle Flights were a thing!) I delayed getting started until after I had finished college but after starting to build an ultralight, I thought it would be a good idea to learn how to fly before attempting to fly the ultralight.

**November 11th- The Red Baron:** A 2008 film about the Red Baron, Manfred von Richthofen.
