## Dario G. Brisighella Passed Away

DARIO G. BRISIGHELLA, SR. OAK CREEK - Passed away peacefully in his home on September 27, 2020. A resident of Oak Creek, WI, he was 88 years old. Dario addressed our Chapter Aug 21, 2017 and was met with great warmth & respect. Had the distinct pleasure of meeting Dario at the AHC in July of that year. You may not remember this gentleman but he is without a doubt a great craftsman and you have all seen his work. Al Schafer

He was a Master RC aircraft builder and some of his work hanging above the Mezzanine. It is incredibly detailed. When he puts in the RC servos they don't directly operate the surfaces using rods. He actually uses them to operate the bellcranks & cable systems that should be in the aircraft. He did pioneering work in the development of RC Helicopters, one of which is in safe storage on the mezzanine.

The DeHavilland Hornet is also one of his projects. These were all flying aircraft. He also has 1/8th scale fully operational locomotive in the National Railroad Museum in Green Bay.







As described by his friend Dr Michael Becker, Dario "Brisighella was a unique and extraordinary man. As his Cardiologist of many years, I had the privilege of knowing him up close, first as my patient, then as a friend and later as an inspiring self-educated genius. His diminutive and cantankerous physical appearance belied the extreme intelligence and expansive imagination he carried within. His accomplishments, inventions and intellectual concepts made him famous and were more than ten men typically accomplish in a lifetime. I had the pleasure of sharing many close moments with him and those memories will continue to inspire me. Dario, I am going to miss you"


