Transition Training with Modified Aircraft

Notice Number: NOTC2789

If an aircraft has been modified, consider the following before the first flight:

- Regardless of any testing the installer may have done, your first flight in a modified aircraft will be a test flight. Advisory Circular 0-89B, *Amateur-Built Aircraft and Ultralight Flight Testing Handbook*, Section 4 (https://www.faa.gov/regulations_policies/advisory_circulars/index.cfm/go/document.information/documentid/1027429) provides excellent guidance on test flying.
- It's a good idea to engage a flight instructor who's familiar with the aircraft and its modifications to assist you in your transition.
- Give yourself plenty of altitude.
- Take it slowly – don't try to win a short field landing contest or demonstrate ultimate performance right away. Ease into the altered performance envelope. Make sure you have good VFR weather, plenty of altitude, and long runways for the test flight(s)

Here are some tips and tricks to help you avoid a loss of control accident when transitioning to a new or modified aircraft:

- **Give yourself some room**
- **Manage distractions**
- **Fly by – not around**
- **Document your personal performance**
- **Seek regular refresher training**
