I won't go into all the items discussed but of particular note is that for June, July, and August, chapters and pilots will receive double credits for any young eagles flown. With that in mind on June 19th we'll be conducting a small rally for a Tallahassee Boy Scout troop. Larry Pesek's co-worker Harald Aagaard is the Scoutmaster and is also a helicopter pilot for Air Methods. He has informed me to expect 8 scouts who are working on their Aviation Merit Badges. I realize that June 19 is the third Saturday and is our monthly pancake breakfast but in discussing it with Christina, we felt that it would be a great opportunity to introduce some young people to our chapter activities. We should also have a number of pilots and planes available to fly the kids.

If we have pilots that haven't flown young eagles in the past and would like to please contact me at phancock54@gmail.com and I'll get you up to speed on the required paperwork. It will be necessary to complete the youth protection training online at the EAA website. The course can be located by logging onto the EAA website and selecting Youth and Young Adults, Free Young Eagle Flights then scrolling down to Pilot Volunteer Information and Resources. Select read more and you will be directed to the page with a great deal of information regarding the Young Eagle program.

The Youth Protection training is the first choice. Once the course is completed, you'll be sent an email with

your completion certificate. I will need a copy of that to keep on file. It's good for 3 years. Our ground volunteers should complete the course and be current as well. Pilots, we also have a Chapter 797 Young Eagle pilot information form to be completed that contains aircraft, insurance and pilot information.

One last point, individual EAA pilot members can fly Young Eagles on their own outside of scheduled rallies. You can order the registration materials at the EAA website or contact me and I have the materials and the logbooks on hand for you. Just remember to mail the signed registration forms into EAA national so that the kids can access all the benefits from participating in the program and so that Ch 797 will get credit for flying them. If you would like, get the forms to me and I'll mail them in. That way I can also keep a copy in my files.

Azalea Aviation Happenings:

Some of the most stressful and exciting times in one's life are when they have to move...for work, new home, state, family....a myriad of reasons. Well its that time for us. As many of you know, Azalea Aviation has been located at Cook County Airport (15J) for the last 5+ years. Many of you have visited us during one of our many BBQ and FLY-IN weekend events. Some have come to be a part of our Engine and Composite Workshops. We

have grown and expanded while we have been there and progressed in the sales and build up of our Saberwing Aircraft and Spyder Engines. However, in order to progress to the next level of our focus, it looks like we will need to do more. As with many small airports, Cook County won't allow the kind of person to person training, camping, and manufacturing we planned to do anymore. When you lease buildings and property you are obligated to follow the limits imposed by the owners. Therefore, we have decided to move to a more suitable location where we can own our own buildings that will allow for the development we need.

Beginning in May, Azalea Aviation will be moving to Quitman Airport (4J5) in Brooks County Georgia. It is actually a little closer to our home in Valdosta and the drive will be less stressful than I75. They have a 5000+ foot runway and 3500 foot grass runway. On the weekend you may see a few sailplanes out for training and practice. We are planning to start building a 12,000 sq/ft hangar and Builders Assist Center on the airport as well as have space and amenities for campers...tent and RV. This building will also house much of our aviation related tooling and equipment that will be set up to provide a learning environment for young and old alike to take advantage of. We hope to be using the Young Eagles Program as well as our own internal courses to encourage the youth in the area to become involved in aviation. This facility would also have the ability to help builders with some of their projects through the use of tools and expertise available. We want to provide a welcoming environment to all who could use such a place to improve their aviation dreams. Of course Azalea Aviation is a business so there would be costs involved in the courses we will be teaching and use of the facility and employees. More information on that will follow or will be available on our website as time progresses.

Azalea Aviation is also purchasing a 2 acre lot and building just south of the airport where we will be setting up our new Main Production Facility. This building will have offices, composites, wood, and engine production capability. We start remodeling and preparing this building within the next couple weeks. We will post some of our progress on Facebook and on the website. There will be a lot of work to do. If anybody would like

to volunteer and help out we have a variety of jobs to do. There will be a lot of property cleanup and maintenance to do to be ready. The building will need some masonry work, bathrooms and offices remodeled, interior work spaces set up, electrical, lighting, painting and more. If you have time and ability to help please let us know. We can buy the food!

If you wish to be a part in our new growth and endeavor through volunteer actions, prayer, and financially please let us know.
