Ray Scholar Update:


Our current Ray Scholar, Doug Tytko, has completed all of his

Finally back in the air... Fall 2024 flying

As many know, my plane was down for maintenance for a few months after Oshkosh due to the valve issues. Once completed and test flown in the pattern, I was ready to burn some fuel!

The first flight was for Young Eagles day #1 on 9/28. I did 4 flights with kids and had great day all around. The second flight was Young Eagles day #2 on 10/05. Another 4 flights and another great day. I'm seeing a pattern here... Flying = a

great day!

I took Friday 10/11 off to fly to Cheat River (56WV) in West Virginia. Took off around 1300, got on flight following with Akron and 1:46 later was at Cheat. ATC warned me of traffic opposite direction about 15mi North of Cheat and a Blackhawk flew below me! That was a fun call back to ATC "7019T has that traffic in sight. The Blackhawk flying under me is no factor." Eric McWilliams had beaten most everyone there and was the first camper set up.





I arrived in early afternoon and reserved a spot next to me as I knew **Paul Lutz** would be joining us. As Paul wrote in his story, more than 50 planes had set up by Friday night. I made a steamer dinner for Eric, Paul, Bridgitte and myself. It is always great to hang out with friends, eat some food and enjoy being surrounded by planes.

Saturday dawned cool with fog capping the valley. This was the same as last year but new this year was Randy circling overhead waiting for it to clear! He made it in about the time I was finishing getting the pancakes done. Rain was scheduled for Cleveland Saturday night and Sunday so we departed separately after lunch for the flight home. We skirted some light showers between Akron and Skypark

but all landed safely. Here is a shot from my tail cam on takeoff.





Thankfully I have a great job so also took the next Friday 10/18 off to fly to Roger's International (62KT) in KY. I departed at 1000, crossed the OH river just before 1200... and landed at I50 around 2:30 to turn on my cameras. :-) Rogers is just a short hop south of I50 and they have a great video on YouTube walking you in by landmarks from there. I had pre-flown the path on Google Earth and entered points in Foreflight for good measure. I was high on my first attempt

so did a go-around.

But the next time around I had the site picture I wanted and settled in between the trees.





Two friends from Detroit flew down in an RV6 so I set up camp next to them. The camping are is called "The Library" as it is supposed to be quieter, marginally... The hangar end of the field is called "The Disco" as it is party central to 2AM.







It is the first time I've camped and didn't have to cook! Although I did make coffee and restart the fires each morning as the first one up. They did have a shower trailer which was partially functional as the heat circuit kept popping. They made enough in funds this year that the owner said he will be able to put in a permanent shower house. They earned a lot of those funds with an auction Saturday night for donated goods. Bring your checkbook as all the goods were above my paycheck. \$400+ for a special bottle of bourbon was too much for me but it was fun to watch.

The flight home was wonderfully uneventful. The op, and slowly come back down the hill before adding

takeoff consists of taxiing up the overrun, turning around at the top, and slowly come back down the hill before adding full power to lift off and exit to the right out the valley.

Here is a bad cell video screen capture of me beginning my T/O run. A bit over the OH river I got on with Indy Center

for flight following home. They passed me off and all kept me covered passing Columbus as I saw a couple heavies cross my path. I was home by 1330.



After that trip there were several 846 flyouts and a couple solo runs: **10/26** - A quick breakfast trip to Swank.

10/27 – I was one of several planes that flew out to Marysville (KMRT) for BBQ. Dave Manning joined me so I finally wasn't flying alone!

11/2 – Flew to Swank for breakfast, then Put-In-Bay for their FBO opening and lunch. The morning mists were beautiful and it was my first time flying out to 3W2.

11/9 – Dave joined me again and we did a group flyout to Swank for breakfast. Paul and Paulie Hancheck and Dave and I then flew down to Zanesville (KZZV) for Vintage Chapter 22's Ham and Bean soup

11/17 – Dave and I joined around 8 other members for the Chapter Fly out to Carroll County for breakfast. I have to say it's a lot more

lunch. We had a private tour of their facility which is filled with

amazing motorcycles, a car and oh yeah, many planes!



fun with Dave in the right seat! LOL

So that's 23.2hrs since 9/28, a pretty good run at making up for lost time. Next year I want to hit North Fox Island and fly the Hudson Corridor in addition to other campouts.



The Wait...

A few of you know that I have been patiently awaiting the development of a new aircraft kit called the "Aquilae". It is a slight variation of the G1 airplane (2place, all aluminum, high wing) that is quite prevalent in France where the factory is, and about 5 are flying in Canada, but none in the U.S. I originally ordered a G1 kit in March of 2022. But almost immediately, a house next door to where my son's family lives became available to purchase, and that summer, my wife and I moved in and restoration of the house became top priority.

Meanwhile, the fellow I ordered the kit from (he lives west of Chicago), and his partner in Canada, lost their

distribution rights to the G1 in December of that same year. But they also subsequently launched an effort to produce a nearly identical aircraft, the "Aquilae", in the U. S. and Canada, and I accepted switching my order to it. They had also partnered with another fellow in Florida who would actually produce the U.S. kits, while the partner in Canada would make the kits for his market. After attending Oshkosh 2023, they got about 4 orders besides my own. All three of these guys have worked very hard on marketing, designing, and getting production ready, all with the best intentions, and they continue with that goal. However, it has quite predictably taken longer to produce a prototype or subsequent kits than they originally anticipated.

Work on our new house and my shop has continued. Just before Thanksgiving, a couple weeks ago, I finally got

around to calling about aircraft insurance, first with the EAA, then a couple of others. My main concern was my age; I am now 67 and I have heard that age becomes an issue once you're into your 70's. Well, I was right about that, but if I can get my plane flying before I turn age 70 (or by 75, depending on the insurance company) then I can get insurance, and likely keep it into my late 70's with a likely hard cutoff at age 80. And of course, I will also need to become current again and build up some hours before this time as well.

However, the big surprise came when I described the airplane kit that I was waiting on, the Aquilae. They told me point blank that it would likely not be possible to get insurance for a new production aircraft until there were perhaps 20 of them flying in the U.S., and likely for many years. This was a shock. When I discussed this matter with the Aquilae team, they too seemed to be uninformed. But they later stated that they knew the process of getting insurance would be more arduous and expensive, but it was possible. Given this new information, and my age, it suggests that I need to get building ASAP, and plus it would be best NOT to be a first builder of a new airplane. With the restoration to my home shop near completion, an insulated and heated 30' by 40' pole barn, I decided to depart the Aquilae flight pattern.

I made a call to Roger at Zenith aircraft and started asking questions specifically about the obvious alternative that I have always been aware of, the CH 750 Cruzer. I immediately got a good feeling about this aircraft and the company. Some guys in our chapter certainly agree with my choice, and I've started watching some of the many related YouTube's (and I have tons more to go). I will be placing an order for a kit soon, and I will likely be driving to the factory in late January to pick up my kit on a borrowed trailer, and to attend one of their nearmonthly rudder building workshops. My excitement level has been restored; I am now back on track to finally start building an airplane and fulfilling a lifelong goal!
