bushings for damage or wear. If necessary, these parts must be replaced with approved ones.

Some 16,000 Lycoming engine models manufactured between January 2009 and February 2017 will be affected by this rule. Meanwhile, the FAA estimates costs to U.S. operators to be \$3.76 million for oil inspections, \$1.36 million for connecting rod bushing inspections and roughly \$12.19 million for necessary replacements.



# New Airworthiness Directive (AD) affecting Lycoming Engines

The Federal Aviation
Administration (FAA) issued
an <u>airworthiness</u>
<u>directive</u> (AD) targeting
specific Lycoming engines that
are equipped with certain
connecting rod assemblies.

The AD was issued in response to multiple reports of connecting rod failures that led to serious engine issues and in-flight shutdowns.

According to the agency, the AD requires regular oil inspections to check for bronze metal particles, and if any are found, further checks of the connecting rod

Chapter 846 of the Experimental Aircraft Association (EAA) is offering two full scholarships to attend the EAA Explore Aviation Camp in Oshkosh, WI, in July, 2025, to deserving area youth who have an interest in aviation. The EAA Camps are fun-filled nine-day aviation camp experiences for youth ages 16-18. Since 1984, experienced instructors and dedicated staff have shared their knowledge and love of aviation through hands-on workshops, classrooms, and outdoor experiences.

The Scholarships will cover the entire cost of each camp (\$1,650) as charged by EAA, which includes room and board. The recipients of the scholarship will only need to provide his/her own transportation to and from Oshkosh. More information about the Explore Aviation Camp can be found at <a href="https://eaa.org/airacademy">https://eaa.org/airacademy</a>. There are two camp sessions that can be applied for. The Session 3 camp runs from July 15-23 and Session 4 camp runs from July 25-August 2. One scholarship is available for each camp session. Applicants may apply to both camps but only one scholarship will be awarded for each session. Do not apply on-line. Deadline is February 1, 2025.

- The applicant must be between the ages of 16 and 18 at the beginning of the camp.
- The applicant must reside in the northeast Ohio area.
- The applicant must complete this application.
- The applicant may attend the February 13, 2025, Chapter meeting to speak to the members prior to vote.
- After the camp, the scholarship recipient must be willing to attend a meeting of Chapter 846 and give a presentation about his/her Air Academy experiences.
- The applicant must provide two letters of reference from unrelated individuals.
- The applicant and parent must confirm that the applicant will have transportation to/from Oshkosh, WI.


#### Mission Accomplished!!

#### Hartzell Propeller Factory Tour, October 7, 2024

On 7 Oct 2024, Karl Aber and I had the opportunity to take part in a tour of the Hartzell Propeller factory in Piqua, Ohio. The tour was organized by EAA Chapter 5 and they were gracious enough to open up the tour to other EAA Chapters.

Karl and I flew our planes to Piqua Airport, arriving within a few minutes of each other. The factory reps met us at the airport and transported us to the

factory. There were about 35 in the group, including folks who drove. After a short presentation on the history and current operations of Hartzell, we

broke up into 4 groups for an upclose walking tour of the factory. It was very interesting to see the manufacturing

process from start to finish. Hartzell uses a large number of CNC machines and robots in their factory that greatly improves their efficiency.

I was struck at how large the facility was—they now employ over 400 people in the company that includes propellers, hubs, deicing components, engine preheating, and engine accessories. They recently acquired Whirlwind Propeller and Reiff (that makes engine pre-heating components). Also, they have purchased a 300,000 sq ft building adjacent to the



current manufacturing plant that will be used for customer support, Whirlwind Propellers and other
