



# FAA extends aircraft registration to seven years.

In a direct final rule published in the Federal Register Nov. 22, 2022, the FAA is extending the duration of aircraft registration certificates from three years to seven years.



The new rule, which was required by the 2018 FAA Reauthorization Act, provides two types of relief for aircraft owners.

First, the change to a seven-year registration period will reduce the number of applications for aircraft ownership renewals awaiting FAA approval at any given time, reducing the agency's administrative burden, and expediting the approval of renewals.

Second, the rule expands authority for aircraft owners to operate beyond the registration renewal date from 90 days following expiration to 12 months, a timeframe that should cover any renewal delays stemming from agency

backlogs.

In summary, the FAA is extending the duration of aircraft registration certificates from three years to seven years. Initial Certificates of Aircraft Registration will expire seven years from the month issued. In addition, the FAA is applying this amendment to all aircraft currently registered under existing FAA regulations governing

# **Garmin GFC 500 Autopilot Notice-**

**Notice Number: NOTC2741** 

Garmin has identified an issue with GFC 500 autopilots with optional auto trim installed in certified, experimental and Light-Sport Aircraft, including certified installations installed with optional GSA 28 pitch trim in accordance with Garmin STC SA01866W. This issue may result in an uncommanded automatic trim runaway when the autopilot is first engaged. This condition could result in a sudden and significant deviation from the intended flight path.

Garmin Service Alert 22109 Revision A requires operators of certified installations to pull and collar the autopilot circuit breaker and placard the autopilot as "inoperative" prior to further flight. Operators may contact a Garmin dealer regarding reactivation of the GFC 500 autopilot with the optional pitch trim configured off in accordance with recommended service bulletin 22110 Revision A.

Garmin is working to fix this issue for certified installations in a future software update expected in Q4 2022.

Garmin Service Bulletin 22112 Revision A requires operators of Experimental and Light-Sport Aircraft to update system software or disable the autopilot or trim control prior to further flight.



### **Dayton Dreaming...**

After attending the fly-in at My Place, Karl Aber and I flew in his RV-14A to Moraine Air Park, just south of Dayton, to pick up his Cessna 172 so that he could perform the annual inspection on it. The weather was beautiful, and it was interesting flying over an area

beautiful, and it was interesting flying over an area that I had called home for almost 10 years. I had only flown in and out of Dayton International Airport, on commercial airlines a few times, but those approaches and departures avoid flying over the city.

As we approached the Miami Valley from the northeast, we could see a large plume of smoke in the distance. We flew over Wright Patterson Air Force Base, where a row of C-17 Galaxies were lined up on the ramp, and where the Wright brothers had performed some of their early flights at Huffman Prairie. On the southern end of the base, we saw the enormous structures that make up the National Museum of the U.S. Air Force.

Continuing southwest, we flew past my alma mater, The University of Dayton. Located about 10 miles from the threshold of runway 05 at Wright-Pat, I saw many different aircraft fly over that campus. By the end of my four years at UD, I could name the type of airplane flying over as well as if there were multiple in formation, just by the sounds of their engines. I remember one late afternoon senior year, as I was about to walk out of one of the buildings on campus, I heard an engine roar that I

had never heard before. I ran outside just in time to see a B-1 Lancer fly overhead on approach to the base. I would not hear that distinct sound again for more than 20 years. When the B-1 came to AirVenture in 2018, I recalled the sound, and a smile grew on my face, just as it did to that younger version of myself so many years ago.

Further south, we flew over my first house located in Kettering. Again, many memories flooded my mind about that time in my life. We then turned for a straightin final for runway 26 at the Moraine Airpark. Moraine Airpark is nestled in the middle of a U-shaped bend in the Great Miami River. It was a place that I had driven past many times while driving on I-75, but at that time in my

life I was just a dreamer, watching the planes take off and land there, and now I was living that dream.

Back to the plume of smoke, it now appeared much larger as we were closer to it, and it was only about a mile from the departure end of the runway. We later found out that the source of the plume was a fire at a metal recycling plant.

Karl and I swapped out the planes and preflighted 985KA. Karl let me take the left seat in the 172. Upon departure off runway 26, we made an immediate left turn to crosswind to avoid the plume of smoke that was blowing toward the airport. After gaining some altitude, we proceeded on course back to Elyria.

I appreciated Karl's invitation to join him in flying to My Place and to Dayton. I came out of the experience appreciating the opportunity to relive some fond

memories of a younger man living in the birthplace of modern aviation.

The EFIS has been tested and powered up with no issues. The radio caused me some headaches at first. I had no audio or voice. After days of troubleshooting I finally found the problem. I had wired up the headset jacks backwards. I had the mic jack going to the audio side and vice versa for the audio. After a few minutes of resoldering the jacks the radio tested fine. With the wiring done we are now installing a glovebox and then we will be ready to build the engine mount.

# **Chapter Meeting Minutes of November 10, 2022**

President Chris Oehlers called the meeting to order at 19:05. He welcomed everyone and thanked them for their attendance.

Guests Present: Sam Bohner. Sam is a student of Dana Paden's and is interested in aviation.

Secretary's Report: Greg Cantrell asked the members present if there were any additions or corrections to either the October 13, 2022 Chapter meeting minutes or the November 2, 2022 board of Directors meeting. With no additions or corrections suggested, a motion was made by Chris Oehlers and seconded by Randy Brooks to approve both minutes as written. The motion passed by a voice vote.

Treasurer's Report: Gary Baker reported there are sufficient funds in the treasury for Chapter business. He also reported the \$10,000 Ray Scholarship for Logan Cohara is fully paid up through Avit Flight Academy. There is still \$2000 due from EAA for Logan's training, but it will not be released until Logan passes the written exam.

**Young Eagles Update:** Gary Baker reported he is planning two dates in 2023 for Young Eagle flights. The dates are May 20, 2023 and June 24, 2023. These will be held at Wayne County Airport. (KBJJ)

Ray Scholarship Update: Chris reported he had no recent update on Logan Cohara's progress. He also stated Logan had exhausted all his funds available from EAA until he passes the written exam. After passing the written exam, the final \$2000 will be made available.

Chris announced the application window is now open for 2023 Ray Scholarships. He asked the chapter whether to apply for a 50/50 or full Ray Scholarship for 2023. The unanimous consensus of the members present was to apply for the full Ray Scholarship.

Chris also discussed the fact that due to rising costs of flight training; \$10,000 may not be an adequate amount to fully fund a student's private pilot training. Logan is facing this possibility as are students in other EAA Chapters. Chris asked for ideas on how to reduce costs of training. He also reported that EAA is aware of the problem and may look at making additional funds available in 2023 to students who are in this situation.

**Deck Update:** Chris reported the construction done so far passed the framing inspection. We are waiting on delivery of the flooring sheathing and good weather to continue the work.

**PA22 Acquisition:** Chris reported the airframe is in his hangar and the engine is in the Chapter hangar. We have the log books and bill of sale. The registration will be applied for putting the project in the Chapter's name. Chris asked for help in selling the aircraft. This will involve taking pictures, arranging the aircraft for display, placing ads in various publications, and fielding calls from inquiries about the aircraft.

Chapter Christmas Party: Chris reported the Knights of Columbus Hall in Wadsworth is available for rent. The cost for an evening would be \$130 plus a \$100 refundable deposit. After some discussion about available dates, it was decided by a show of hands of the members present to have the party on Saturday, January 7, 2023.

Tom Dus, a longtime aviation insurance broker, presented a very interesting and informative program on the various aspects and considerations of aircraft insurance, as well as reasons the cost of this insurance has increased recently. Monthly Safety Topic: Risk Management- Greg Cantrell Greg presented an informative and interactive program on the various aspects of risk management in aeronautical decision making. Much candy was distributed with all of the correct answers offered. Thank you, Greg.

LightSpeed Headset Program: Gary Baker detailed a new program for EAA Chapters participating in the Ray Scholarship. The program from LightSpeed Aviation will allow chapters the opportunity to earn money from the chapter's sale of headsets.
