Award part of annual \$1.8 million Ray Aviation Scholarship program

(Butler, PA) — (20 May 2025) — Adeline Barrett of Columbiana, OH received a unique full-scholarship opportunity for flight training, thanks to EAA Chapter 857 of Butler, PA. This Ray Aviation Scholarship program is administered by the Experimental Aircraft Association (EAA) in Oshkosh, Wisconsin.

The Ray Aviation Scholarship program provides up to \$12,000 scholarships to young people who are seeking to learn to fly. The Ray Foundation has provided \$1.8 million to fund the scholarship program, which seeks to improve the flight training success rate from the current industry standards of 20 percent to 80 percent for program participants. Local EAA chapters are responsible for identifying youth for the Ray Aviation Scholarship program and mentoring them through flight training. The Ray Foundation is furthering the legacy of James C. Ray, an EAA lifetime member who was dedicated to aviation and youth education.

Since its introduction in 2019, the EAA Ray Aviation Scholarship program has allowed over 350 youths to complete their flight training and receive their pilot licenses. This is the fourth Ray Aviation Scholarship received by Chapter 857 thereby bringing thousands of dollars in flight training to our local flight schools. In addition to this scholarship, Chapter 857 has, for over a decade, offered EAA Air Academy Scholarships to area youth. These scholarships offer an aviation-focused, summer-camp like experience in Oshkosh, Wisconsin. There is no better way to expose youth to Aviation and Aerospace opportunities than by participating in an EAA Air Academy event.



Adeline will be training at Haski Aviation based at New Castle Airport, PA. The scholarship is designed to support a flight student through both written and practical segments of flight training that are part of successful FAA pilot certification.

EAA Chapter 857 is gearing up for two youth-oriented events at the Butler Regional Airport. During these events known as Young Eagle Rallies, kids between the ages of 8 and 17 can register to receive their first flight in a general aviation aircraft by a local pilot. Participants can also meet our scholarship recipients to discuss their future for pursuing aviation as a career. Chapter 857 will also present information to participants about youth scholarships available to everyone in the community.










The Tower Bridge

This was by far one of the most enjoyable tourist spots we went to. We climbed the stairs, skipping the elevator to the top and walked across the bridge. The bridge features signage along the way to shed light on the history of the bridge. I won't spoil it for future travelers but trust me this is worth the short line you'll experience to see it.





The Prime Meridian was interesting to see. You had to climb a big hill to get to the small museum featuring some historical information on observatories. The view was well worth the climb. The staircase comes from the Queens House, a free museum/castle tour. In the same vicinity was the National Maritime Museum. All of these were inside of a rather large park. This was outside of the city. This was the most at home I felt during the entire trip. I am very much used to open area to roam. I found the London city streets to be over stimulating.











Did you know there is such a thing as a Royal School of Needlework? Yeah, me either... My mother ventured to the Royal School of Needlework while I visited the aviation museums, but I had no escape from visiting Liberty... the 5-floor department store. Thankfully they had a lovely sit and wait area with free Wi-Fi. My mother, the self titled queen had a blast.





FINALLY, the museums! I visited the Brooklands Museum first. The most remarkable thing about this one was the Concorde Experience. Paying an extra few bucks got you a boarding pass, certificate saying you were there and to get inside of the Concorde and sit in the seats. This airplane is one of 20 that remain in the world. I enjoyed the experience and would say this alone makes it worth it to go. They get you on the plane in your seat. They play a video for you about the plane and its history. They've added some special effects that take you "into the air". This experience was immersive and wonderful.

I connected with another aviator because of venturing out to see this Concorde. Scott MacLean flew on the Concorde. He is a local based out of Medina 1G5. He flies a Cozy MKIV (Phil, I hope you see this). He and I chatted at length after connecting on social media. He is awesome! He has volunteered to offer a presentation for us on Canards. I would love to make this a larger event. I was thinking a combined chapter event with both Butler and New Castle chapters putting this on at New Castle Airport in the hangar. I should also mention this museum is also home to cars considering Brooklands was a famous racetrack. Brooklands had other airplanes as well, many of which you could get on board and walk through. Each plane had a volunteer with a history in aviation that told you all about that airplane. I found myself taking many pictures of things for students.






The Royal Air Force Museum

This museum was so large it was an all-day affair. Pictures don't do it justice. There were seven buildings, with hundreds of aircraft and it was all free to explore. The one drawback to this museum was that you didn't connect with the history as well because there was limited interaction. One of the reasons this trip happened was British Airways non-stop direct flight from Pittsburgh to London-Heathrow. As we returned from across the pond, I was lucky enough to see a second Concorde. G-BOAB was the 3rdConcorde to be delivered to British Airways on Jan 14th, 1976. It's final flight was on August 15th, 2000. I personally love a good mystery! What are they doing with this retired aircraft at London-Heathrow?



I think that British Airways is sentimental and can't get rid of it. Supposedly, they wanted to turn this one into walk under piece and hang it from the ceiling in the British Airways terminal at the airport. They've cleaned up the aircraft over the years on a few occasions for British Airways family day. One of the other plans presented for G-BOAB was to place her at the entrance to the terminal somehow so that she would become the gateway guardian for British Airways. She has been moved into and out of the hangar and therefore out of public view several times over the past several years. Her future is still uncertain, but I thought it was cool to see her on the departure. This wrapped up the trip nicely for me. The window seat is always worth the view!



TECHNICAL ADVISOR COLUMN:

If you are a pilot and owner of a regular certificated aircraft, or a pilot or sport pilot with a light sport category aircraft (any of these), you can perform preventive maintenance yourself on the airframe, engine(s), propellers, appliances, and certain component parts. This could result in your saving lots of money, vs. having these chores performed at an FBO.

Also, the aircraft must have a Standard U. S. Airworthiness Certificate, and not be used for Part 121, or Part 129 or Part 135 operations.

Who is eligible to do the maintenance work, and which items may be performed, and by whom, and the performance standards are all framed within FAR Part 43, MAINTENANCE, PREVENTIVE MAINTENANCE, REBUILDING, AND ALTERATION.

Part 43 also defines the various categories of work which fall under the category of "preventive maintenance", provided it does not involve complex disassembly/reassembly operations of structure or operating systems on your aircraft:

1. Removal, installation, and repair of landing gear tires.

2. Replacing elastic shock absorber cords on landing gear.

3. Servicing landing gear shock struts by adding oil, air, or both.

4. Servicing landing gear wheel bearings, such as cleaning and greasing.

5. Replacing defective safety wiring or cotter keys.

6. Lubrication not requiring disassembly other than removal of nonstructural items such as cover plates, cowlings, and fairings.

7. Making simple fabric patches not requiring rib stitching or the removal of structural parts or control surfaces.

8. Replenishing hydraulic fluid in the hydraulic reservoir.

9. Refinishing decorative coating of fuselage, balloon baskets, wings tail group surfaces (excluding balanced control surfaces), fairings, cowlings, landing gear, cabin, or cockpit interior.

10. Applying preservative or protective material to components where such coating is not prohibited or is not contrary to good practice.

11. Repairing upholstery and decorative furnishings of the cabin, or cockpit.

I will provide further details in coming newsletters. Finally, if there is interest, I am willing to present more about owner performed preventive maintenance in future Chapter meetings.
