
• FLIGHT TO SUCCESS by Greg Thomes, Chapter President

- (d.) perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned by the President or by the Board of Directors.

Note: While not strictly addressed in the Bylaws, the Secretary also takes minutes of each general chapter meeting and distributes them to the membership. Our current chapter membership size has not to this time justified a separate “Board of Directors” meeting (by consensus the general meeting and Board of Directors meeting are considered equivalent) so there is only one meeting per month at which minutes are required.

And, my "Thank You" to our chapter members...

I want to thank everyone who has supported me as newsletter editor over the years. It has allowed me to become more involved in the chapter, the local aviation community, and the entire EAA community. I have personally benefited greatly, and I hope that in some small way each of you have as well.

I have served as Newsletter Editor of EAA Chapter 878 for a long time...and in all honesty, too long. I began in July 1988 and, except for three other persons who served as editors in 1997 through August of 2000, have continued in that capacity...almost 29 years.

In August 1986 I read a notice in the Wright County Journal-Press newspaper, calling for persons who were interested in forming a new EAA chapter to attend a meeting at Wright Aero on the Maple Lake airport. I went to that organizational meeting and thus became a charter member of what would become EAA Chapter 878. At that time, all of the chapter officers were responsible for input to a monthly "Maple Lake Flyer" newsletter which Bonnie Mavencamp would type and mail (in addition to her real job as the business manager of Wright Aero). Before the start of the June 1988 meeting I approached the chapter president, Glen Morrow, and volunteered to take over the publication of the monthly newsletter for the chapter...if the rest of the chapter members approved. Glen gave me one of those "looks" of his and assured me that the rest of the members would approve! So with the publication of the July 1988 newsletter, my journey as a chapter newsletter editor began.

I would not have served this long if I hadn't enjoyed the work. But, it has been a load and I wouldn't recommend anyone in the future stay in this, or any other, position for such a length of time. There is a benefit to continuity, but every organization also needs a variety of leaders on a regular basis. And, each leadership position should be shared so that the "tribal knowledge" is not centered upon one person.

The end of the year will also see the conclusion of my "AvBits" emails. I had recognized there were times when information needed to be distributed to the membership more punctually than via the monthly newsletter, as well as things that were interesting but not necessarily newsletter material. I believe those emails served that purpose (and I thought the name was catchy enough to assure it would be noticed in your inbox). Ray will determine what works best for him as a communicator to the chapter.

And as a last note, you will find there is no cartoon with this newsletter. That contribution of mine is also ending. My first cartoon ("The Funnies") appeared in August 1989, and the final one was last month. That's approaching 350 original works, though occasionally I did use a "re-run" when I ran into a time crunch. I enjoyed creating them, but this too was becoming a load. It was strictly a personal contribution to add some character and uniqueness to the newsletter, and I hope you found a least a couple that caused you to smile.

EAA 878 Flight Club Proposal

Following proposal is submitted by member Dick Borrell for a 5year lease of his 1968 Cessna 172I, N46201 for use as the EAA 878 Flight Club aircraft and revenue generator for the chapter.

I. ADMINISTRATION: EAA 878 Executive Committee would either Administer The Club or setup a Committee to manage the day to day operations, scheduling, maintenance, training and finances of The Club. This group would be known as The Club Administration.

II. MEMBERSHIP: Membership in the EAA 878 Flight Club, would be limited to [30]

III. INITIATION FEE: Initiation Fee of \$1,000 would be paid upon acceptance by administration into The Club. Funds would be held in a separate account for use by The Club Administration. If a member resigns from The Club 50% of their initiation fee would be returned if they request it in writing.

IV. MONTHLY FEE: Each member will pay a monthly Administration Fee of \$25 to cover the costs of Insurance, Annual Inspection, Scheduling, Legal, Maintenance and Administration. At the option of the member they may pay in one lump sum a year's worth of fees for \$275, one month free!

V. USAGE FEE: The aircraft usage fee shall be \$80/Hobbs hour wet, rounded to the nearest 1/10hr. Calculated as follows:

A. Fuel at \$4.38/gal and 8 gal/hr burn rate = \$35/hr

B. EAA 878 \$10/hr with stipulation that if average fuel costs exceed \$4.38/gal in any calander month the \$10/hr rate will be adjusted downward.

C. Lease payment to Dick Borrell (the leasor) \$35/hr, paid from The Club funds.

VI. COST SHARING WITH LEASOR:

A. Annual Inspection. 100% paid for by The Club (N46201 comes with fresh annual)

B. The Leasor pays the monthly Administration Fee \$25 or annually \$250.

C. The Leasor pays only \$35/hr for his use of this aircraft (fuel only).

D. Upgrades: The following Proposed upgrades would be cost shared as follows only upon a majority vote of the members and approval by The Club Administration:

1. Avionics would be shared 50% by The Club and 50% by the Leasor.

2. Auto Pilot would be shared 75% by The Club and 25% by the Leasor.

3. Paint would be shared 90% by The Club and 10% by the Leasor.

4. Engine Overhaul would be shared 25% by The Club and 75% by the Leasor.

NOTE: The Leasor maintains ownership of N46201 and must give 1 year notice to terminate this lease. If Leasor terminates this lease all members get FULL refunds of their initiation fee. If this lease is terminated by the Leasor any upgrades will be prorated any paid back to The Club for the time of use vs time of lease.

VII. AIRCRAFT BASE AND TRAINING: The Club would be based at KMGG in a hangar. There is currently one Flight Instructor at KMGG, Donald Hanson, CFI who we may certify as our checkout and trainer pilot and Karsten Nordby, CFII from Glencoe/Hutchinson is also willing to instruct in our 172I. It is my wish that we use the aircraft for Private Pilot, Instrument Pilot, Currency, Fun and Cross Country flying. Clearly more "legal detail" will need to be done to set up this club, but this gives us a framework to start from.
