July meeting of EAA Chapter 878 was held in the hangar of Harold and Lynne Greseth on their farm. A picnic dinner at 6:00 p.m. featured pulled pork sandwiches, beans, coleslaw, soft drinks and water, all provided by the chapter. This was accessorized with side dishes and desserts contributed by chapter members. A huge thanks to Harold and Lynne for volunteering their time to acquire the main dishes and the generosity of their home and hangar! Meeting called to order at 7:12 p.m. with 17 members and 6 spouses in attendance.

### **REPORTS:**

Secretary's Report by Wayne Flury for June, as printed in the July newsletter; motion to approve by Dick Burns, second by Tim Bond; no discussion; approved.

Treasurer's Report by Dick Burns from May as printed in the July newsletter. Motion to approve by Harold Greseth, second by Fred Jude; no discussion; approved. Report for June was presented verbally by Dick with no questions or comments. June Treasurer's Report to appear in August newsletter. Noted that the Buffalo Pancake Breakfast report was final and the same as the preliminary report printed in the July newsletter. See the summary of the general treasurer's report and the final pancake breakfast report at the end of these minutes.

### **COMMITTEES:**

**Young Eagles:** Chapter Young Eagles Coordinator Tim Bond noted has a YE flight scheduled for

Friday after the meeting, and is working on flights with Boy Scouts. More info to

follow.

Chapter Website Update: New Website Coordinator Dan Hanson not present. Wayne to follow up.

**Chapter PIC Hours:** Chapter President Greg Thomes passed around the PIC sheet for attendance

and for record of chapter member flying hours to date. He added a column for

"Hours spend on home building."

**RV-4 Build Project:** Tom Rammel summarized that the chapter has purchased the RV-4 project

materials from the Glen Morrow estate sale. This is currently stored in Tim and Carla Bond's hangar at the Maple Lake Airport. Tim reviewed on the materials

included, with some discussion about additional parts or kits needed.

Chapter President Greg Thomes reviewed Tom's proposal from June:

- a) chapter purchase the required materials
- b) members work on the build, with record of hours worked
- c) subassemblies built at members shops or homes
- d) sell the airplane when completed. Material expenses paid back to chapter. Half of profit goes to Chapter 878 and other half split with members according to hours worked.

### Tom noted:

- a) not all members will want to work on building an airplane
- b) project may attract more members
- c) many members already own the necessary tools
- d) need a place to store completed assemblies

After general discussion, Greg called for a show of hands of those interested in working on this project. The initial committee will be chaired by Tom Rammel, with Dale Bodine, Dick Burns and Fred Jude as members. They will meet to inventory the materials and decide upon possible courses of action.

### **TABLED BUSINESS:**

Chapter Build or Acquire a Structure (Hangar or Garage) at Maple Lake Airport: Currently tabled. Greg

Thomes noted that one open front hangar is being demolished by the city; Jason Erickson may be building a hangar; and the hangar currently owned by Larry Rosine is for sale and, while it has a great location, it would be much more expensive than the chapter could currently afford.

**Jump Club:** Fred Jude – no update.

### **OLD BUSINESS:**

Maple Lake Fly-In: Chairman Kurt Pennuto presented an update. The City of Maple Lake is donating

brush for a Saturday night bonfire...will require closing the runway during that event. Ascend Aviation has arranged for a bluegrass band for the Sat. night music. Connie Erickson is arranging for the chili for that evening. Three, and possibly four, ambassadors representing the military are confirmed. Will be

asking for volunteer sign-up at the next meeting.

STEM Programs: Kurt Pennuto advised that he will be continuing his work at the Rockford Middle

School with Corina Sarsland, and is hoping for more schedule time this year (only had 35 minute segments last year). He will promote Young Eagles and

other activities through EAA to these 7<sup>th</sup> grade students.

Yellow Cub Club: Mike Wiskus not present – no update. This is a Mike Wiskus / West Metro

program, using a J-3 Cub as an intro to aviation for youth.

**KOSH, 7/25 – 7/31:** Approximately 10 members indicated they would be attending AirVenture

Oshkosh 2016, traveling in on various dates. Greg Thomes floated the idea of trying to get together at some time, possibly for a group photo. Wayne Flury offered the Announcer's Stand as a gathering point. Greg will coordinate.

**Griddle Purchase:** Tim Bond noted that he had purchased a griddle that the chapter can use for

events (same type of griddle as we get from the Rockford Fire Department for use at the pancake breakfast). This was a suggestion arising from the pancake

breakfast report. Cost is approximately \$300.

### **NEW BUSINESS:**

**I.M.C. Club:** Local representative of the IMC Club, David Wendt not present during meeting.

(Note: see discussion at end of minutes, under "Program.")

**Tree of Hope:** Elaine Morrow was not in attendance, but Greg Thomes had posters and info on

this year's event, on December 3. Greg noted that this was a "heads up" on the

event, and called for members to put this on their schedule.

Fred Jude made a motion for the Chapter 878 financial contribution to the Tree of Hope to not exceed \$250. Seconded by Dave Swanson. Discussion: Fred's point is that he feels our past contributions of \$500 were excessive and we should be saving money for possible chapter projects or acquisitions. Noted by Dick Burns that we have more money in our treasury now than at any time in the past. Our contributions to Tree of Hope have been: 2015 - \$500, 2014 - \$500, 2013 - \$450, and 2012 - \$450. Called for vote, motion failed by show of

hands, 6 to 5.

**Checking Account:** Noted by Greg that the bank currently has Dick Burns and Marv Sikkila (past

treasurer) listed on chapter checking account. Called for a motion to add names to the account. So moved by Kurt Pennuto and seconded by Tom Rammel. Discussion – add the name of the current president, motion amendment

approved. Motion passed.

**Adjourn:** Meeting adjourned at 7:50 p.m.

Program: Our guest, David Wendt of the IMC Clubs arrived a few minutes after

adjournment, so Greg reopened the meeting.

David reviewed the history of IMC Clubs and his participation in it. They are now a subsidiary of the Experimental Aircraft Association and local Clubs need to affiliate with an EAA chapter.

Per the EAA website, "The IMC Club's purpose is to promote instrument flying, proficiency, and safety. The intent is to create a community of pilots willing to share information, provide recognition, foster communications, promote safety, and build proficiency in instrument flying. IMC Club chapters offer monthly meetings in which pilots can network and share knowledge and experiences."

David would like Chapter 878 to allow members of IMC in the Minneapolis area to join us, which provides them the affiliation with EAA. According to David, there is no liability to the chapter, nor any commitment. Chapter 878 members would automatically become IMC members.

After discussion, Joe Simmon moved to tentatively approve this request, seconded by Tim Bond. Wayne Flury and Greg Thomes will do some research and review at AirVenture. Dick Borrell will attend the next IMC meeting.

Meeting re-adjorned.

### MEMBER PROJECTS by Steve Waddell

My next project is a Fisher Flying Products Tiger Moth, and as of mid-July it was almost ready to ship. They sent me a picture of the crate as proof!

I had contacted them about status of the shipping, and about bringing the crate to Oshkosh for pickup. Here is their reply: "We have your Tiger Moth kit completed and, as you can see, we are crating it up.

"We are waiting for the nose cowl and 2 aluminum fuel tanks from my supplier. He has promised the end of the week.



"I have attached a photo of the crate as filled thus far. To save you some money on shipping, we are going to raise the lid on the crate a bit to accommodate the nose cowl and tanks if possible. It will reduce the usual 2 crates down to one.

"I will not be able to bring the kit to Oshkosh for a couple of reasons.

- 1. They are super strict at the border. What I bring to the show has to return or I pay tax on the whole works.
- 2. If I deliver the kit in Wisconsin, I have to charge the Wisconsin state sales tax and you would have to recover it.

It basically turns into a TOTAL tax mess!

I will get it delivered to the nearest trucking depot which will save you a bunch over having it delivered to your door.

"I am also going to be drop shipping the components from Matco. This is the wheels, axles, tires, tubes and brakes. No use bringing them into Canada and then shipping them back out again. You will also be receiving some custom wire assemblies from Aircraft spruce if you haven't already.

"I will be printing the plans out this week and when the other components arrive we will be closing it up.

"I will have it weighed and get the shipping costs and then contact you with the final payment numbers."

A few years ago a friend of mine noted that he wouldn't be able to attend our event because he had a previous dinner engagement for that night. I had to explain to him that, in sort-of-rural Minnesota, dinner is still a more common term for the <u>noon</u> meal!

Many new things are being added to the fly-in this year which should make it a very special event both for us and attendees. All chapter members will be needed for help. Please put this on your schedule and help to spread the word by printing out the flyer from this email and posting it at airports during your travels, or pick one up at either Ascend Aviation at Maple Lake or West Metro Aviation at Buffalo.

### IMC CLUB by Wayne Flury

As noted in the minutes of our July meeting, David Wendt appeared at our meeting to discuss the IMC Clubs, which are now a subsidiary of the Experimental Aircraft Association. With this association, local IMC Clubs must affiliate with an EAA chapter, and he proposed that EAA Chapter 878 and the west metro area IMC Club join forces.

IMC Clubs ("IMC" is the acronym for Instrument Meteorological Conditions, in which a pilot must have an Instrument Flight Rules, or "IFR" rating) were originally formed to provide instrument rated pilots a means by which they could share their experiences and build individual proficiency by discussing real-world flight scenarios. And, while the focus is still on instrument rated pilots, they encourage non-IFR rated EAA pilots to participate in their meetings for the purpose of learning about IFR flight and for possible skills upgrades.



While the chapter voted to tentatively approve such an association, it was done on the basis of doing some additional research. At AirVenture Oshkosh 2016, Greg Thomes and I met with Radek Wyrzykowski, the original founder of the IMC Club and currently on EAA staff as Manager of Flight Proficiency for IMC Clubs. Radek addressed our questions about integration of the chapter to the IMC Club and how they can and should work together.

As expressed by David, and confirmed by Radek, the chapter would gain members, the IMC Club would gain the affiliation they need, chapter members would be able to avail ourselves of the resources of the IMC and, hopefully, the IMC members will share in our programs and activities. There is no cost nor liability to the chapter for this association or affiliation.

Both Greg and I came away from that brief meeting with the feeling that this would be a win-win for both parties and would recommend that the association be fully approved.

While there may be some feeling by IMC members that they are not "into building" and there may be some feeling by Chapter 878 members that they are not "into IFR flying," in reality we are all part of this great brother and sisterhood of aviation. While I may no longer desire to get my Instrument rating proficiency back into currency, I certainly can (as well as probably should) do at least some partial panel or hood work to make any flight that strays into less than desirable VFR conditions more survivable, or least less stressful. And, just because a pilot is an IFR type doesn't mean that he or she isn't equally likely to consider the personal challenge and reward of building an airplane, a process for which EAA chapters are uniquely qualified to disseminate that knowledge. I expect that the IMC Club will function as a "committee" of the chapter, with chapter members from both backgrounds able to opt in or out as they desire. Even with limited "crossover" I see benefits available to all. As with any other program of the chapter, it's now up to you to take advantage of that benefit.
