Chapter Chatter



Dennis Lord is our current Chapter 96 President, executive producer of the <u>EAA 96 Fly-In</u> and <u>Model Expo</u>, and a member of the LA County Aviation Commission overseeing five County airports including Compton.

I received a call this week from Chapters at National and they were inquiring into who did our website. It soon became clear that they had reviewed our website and liked it, as do we. I mentioned it was the work of Dave Bristol and the next thing they said was that he was going to receive the Web Editor's Award at AirVenture later this month. While Dave is unable to attend this year, Rhon Williams has agreed to represent the Chapter and stand in for Dave. Check out the new website! And, then thank Dave for a job well-done.

For those pilots not attending AirVenture, like me, there will be a Young Eagles rally on July 26 at Hawthorne in support of the ACE Summer Camp students. This is an annual event for us and it is on a Friday, which is different. Come and support us if you can. We will need pilots and ground crew.

The upgrades we did to the LiveATC feed seem to be working. The audio is outstanding and with the outside antenna, I've heard RNAV approaches into Redlands who uses the same frequency! That is 65 miles away. I heard Keith Spreuer in the air today from home and it's good to see he is back flying again. Today, July 13, we have gone four weeks without any downtime on the feed. Something is working and we may tweak it just a bit more. I know, if it's not broken, don't fix it! If you have not listened to it, do so and let us know what you think.

I may have mentioned that our C-182P has developed a crack in the leading edge. So, we took it out for an estimate and the best number came back at \$5300. We approved the repair conditional upon a deeper inspection. Following that inspection, the price went to \$23.5K for both wings! Oh, the joys of aircraft! In a nutshell, parts of two ribs must be replaced which requires cutting off the leading edge, replacing the forward section of the rib, then fabricating a replacement leading edge and instead of bonding, rivet everything. The factory installation bonds the rib to the leading edge. That bond disintegrated on two adjacent ribs, intergranular corrosion set in and cracked the leading edge. While the beginning of the same condition is visible on the right wing as well, it can wait for a while. \$11,500 for now and likely the same the next time.

For those interested, the County has initiated a study on rental rates for hangars. While this has not been done for years and a group of tenants have proposed their own rent study, in the interest of transparency a well-known third party aviation group was hired to conduct this. Some participated in a recent meeting at CPM. On July 18, there will be a conference call for those interested enough to call in. I, for one, do not believe that much will change and that it will result in a ratification of existing rents. I've done the math on my hangar and am paying \$0.45 sq. ft. TOA charges \$0.63 and will not rent to non-aviation. They have vacant hangars, we (CPM) do not and rent them to non-aviation at about 55% of the market price for storage outside the fence. Again, the policy is, show us an aircraft and we'll show you a hangar. Even if it means terminating a non-aviation lease. This is an airport, not an industrial park.

Hangar security is starting to become an issue. Several, including me, have come to the hangar and find it open or unlocked. This needs to cease and all members need to assume the responsibility of locking it up if you are the last person out. We cannot afford to lose tenant belongings.

I recently hired one of Wilbur Owens' aircraft and Donovan Burns brought out his Boeing PT-17D to an 8th annual event I produce in Long Beach. Wilbur was remarking how many were on the beach watching them above. Something around 10,000 attendees. Van Wagner gets top billing with a Flag banner tow. We raise about \$100K for Children Today which provides educational services to homeless children in a safe environment. After the patriotic aerials and ribs buffet, we blast off about \$50K in fireworks and go home. Always on July 3, we then can sleep all day on the 4th!

Lastly, it goes without saying that the weather is warming up. Watch that density altitude and know the limits of your aircraft. Places like Big Bear ply you with inexpensive (and subsidized) fuel prices and you load up only to discover you cannot break out of the ground effect on a warm day. Be smart and you'll be safe.


