The CALF Meeting Minutes

November 3rd, 2021: Ted Forman, President and Meeting Note-Taker

Zachary Chattler a new member introduced himself. He flies a light sport Cessna 162 Skycatcher out of Carroll County Airport and is a member of the EAA chapter there. He is a podiatrist retiring at the end of the year. His son flies Apache helicopters for the US army.

Old Business

Last September, we filed what we hope to be the last form in setting up our non-profit Corporation to the IRS. We are a 501-c7 non-profit Corporation in the state of MD, we have our federal ID number, and this last form makes sure the IRS recognizes us as a non-profit.

New Business

1. **2022 Officer Elections** - All officers have agreed to stay on 2022 with a few caveats.
 - **Michael Bishton**, who wears a lot of hats would like us to fill the newsletter editor role with someone who will write it. He will still format and distribute it, do the Fly-in bulletins, the membership roster and website/Facebook. We had no volunteers at the meeting. We will keep recruiting.
 - **Bruce Miller** will remain as Vice President until he retires and moves to WV.
A motion was put on the floor to accept the continuation of existing officers. The vote was a unanimous yes.
2. The annual renewal process for EAA has begun. Deadline end of December which is a month earlier than we are used to. Our relationship with EAA in 2021 has been very positive. It has brought new members and helped to protect us for our six fly-ins this year.
3. We discussed and decided that the December meeting and Christmas Party will be combined to take place on **Saturday, December 4th** at the hangar starting at 5:00 pm. This is subject to Betty's agreement, will ask her later this week. (The heating system worked well during the meeting and can keep it quite warm. Flying Section

We successfully pulled off 6 Fly-ins this year, consisting of: Baughers in May, Shreveport in June, Eylers in July, Harrisons in August, Shoestring in September, and Keymar in October.

The consensus was that a chapter that does not fly is a dying club and this year we were able to attract and retain members with our well attended Fly-Ins. **Well Done!**

There are no upcoming Fly-Ins/or Fly-Outs sponsored by our chapter with the cold weather now coming upon us. We look forward to Spring and more flying activities.

Presentations

A video was shown of the all-aluminum Merlin Ultralight they call the [ElectroLite](#). They are experimenting with mounting electric motors *in the wing* for additional thrust on takeoff to greatly reduce takeoff distance, and reverse thrust on landing to greatly reduce landing roll. It has amazing cruise performance from a 37hp 2-cycle PPG engine that burns a little more than 1.5 gallons per hour, giving it an approximate 180 mile range on one tank. We discussed benefits and concerns we would have this design. Most thought it was very interesting.

Meeting Agenda - Gift Exchange!

This is a CALF tradition! Please bring one of your wonderful Christmas gifts that wasn't quite the perfect fit for you. (Don't bring junk). Here are the rules.

1. When you arrive, everyone puts a wrapped gift on the table and gets a ticket with a number. Bring one gift for each member of your party so that we will have enough gifts to go around.
2. We draw ticket numbers from a bowl. The person whose number is selected first starts the game by selecting any wrapped gift from the table. As soon as a gift is selected, it is unwrapped and shown to everyone.
3. Every following person may either select a wrapped gift from the table or take someone else's gift.
4. When a gift is taken from its current owner, the person who lost the gift can chose to take a wrapped gift from the table or take someone else's gift.
5. A gift can be taken away from the current owner a maximum of **one** time. The gift belongs to the person after that grab and cannot be taken again.

6. A person cannot take back a gift that the person previously owned at any time.
7. If a child or young adult is happy with his or her gift, please don't take it away.
8. After the last gift has been taken from the table, the first person can trade with any other person who has a gift that has not yet been retired.
