Last month I threw my hat in the ring to expand my aviation endeavors to include becoming an EAA Young Eagles pilot. I have recently taken and completed EAA's "Youth Protection Policy and Program", which will allow me to fly Young Eagles. It seems like a win\win opportunity for me to get some air time, and for a neophyte in aviation to experience the wonders of flight for the 1st time. The bonus of participating in the program is knowing that you may be providing the vital link to a youth that will trigger their quest to make aviation their future, or just a memorable day of a dream coming true. Or perhaps, even just a slight nudge past the fork in the road of opportunity that is labeled, "would have, could have, should have"! Until now, my experience with flying young people has only been my flying of my younger children and grandchildren. It's fun to witness their facial expressions, listen to the excitement in their voices, and see exactly what stimulates their experience of flight. The thrill of flying can have different effects on different people, and young peo-

ple are more spontaneous to open with their emotions, making them more "readable". At times, flying the kids is like opening a direct path to your own emotional responses to your initial flying experiences. Unrealized Success of Giving Revealed

More Than 8 years ago I chaperoned a field trip for a Waupaca Elementary School third grade class to partake in a young Eagles event Sponsored by EAA chapter 444. My granddaughter, being a member of this class, took her first plane ride at the event at Poppy's Field. The teachers had taught the students the principles of flying as a class project prior to their flight day. The teachers had made this Young Eagles flight part of their class curriculum for a number of years prior to even my son's being in 3rd grade at the school. Bringing a part of the past to the future, a Waupaca teacher, Mary Richards... (From Chapt. 444 Treasurer)... In early May, I

received a phone call from a woman by the name of Mary Richards. Mary wanted to make a donation to the chapter. The back-story to this donation is that Mary's son Chad Richards had a birthday coming up later in May, and when Mary called him to ask what he wanted for his birthday, he told his mom that he didn't really need anything and he was good. But wanting to do something for her son, Mary decided that she would make a donation to EAA Chapter 444 for him, and sent the card to her son, along with a certificate of appreciation from Chapter 444. Now, the reason Mary picked us for her donation is that her son received his first airplane ride many years ago at a Young Eagles event put on by Chapter 444. That light sparked a lifelong interest in aviation for Chad. He is now Lieutenant Colonel Chad Richards and he's flying jets for our U.S. Air Force". Sometimes it's hard to realize what effect our thoughts and actions may have on people, how those people may influence events, and how those events may affect history. 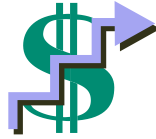

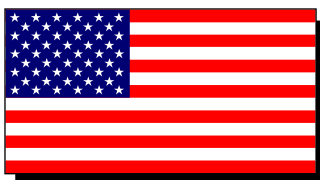
