### Editorial Notes by Larry Gordon

Time Flies

Four years ago, this 1st Tuesday of November, 2020, I spent the day flying solo to a few of the remaining airports that I needed to complete my Wisconsin Airport Passport. It was a beautiful fall day that added to my enjoyment of overflying the topography of the western part of the state, extending upstream from La Crosse, in and over the mighty Mississippi River Valley. This year's 1st Tuesday will be IFR, as per the forecasted weather, so I will be grounded from flying, but hoping to recreate in another activity.

Learning From Others Is Easier Than Self

While I was in North Dakota last week, I stopped at an airport for some newsletter inspiration after hearing of a non-flying airplane incident. Having unsuccessfully searched the airport for evidence of the accident, I spotted someone parking at the FBO in Washburn, ND(5C8), who appeared to be a good

source of local knowledge. Bingo! The fella was the local pilot for the North Dakota Game and Fish Dept. A picture being worth a thousand words, upon my asking the officer about the rumored incident, he grabbed his phone and began scrolling through his photo library, while acknowledging that the rumor was indeed fact, and that the plane was recently removed from the airport. The photo showed a Cessna 150 lying upside down on the concrete tarmac, with extensive structural damage to the both wings, landing gear, empennage, tail, and rudder. The prop also appeared to be damaged. Attached to each wing strut in the foreground of the picture were straps, too small to be lifting straps, so I curiously asked if the plane was tied down at the airport when it was damaged. Yes, was the answer leading to my second question, as to whether the tie downs were ratchet straps? That answer was also yes. The officer explained the incident and its



outcome to me while shaking his head in disbelief that someone would do that, knowing that the "winds in North Dakota are considered calm, if they are under 20 kts"! In another life, I used ropes and knots in my line of work, but I had seldom seen or tied the combination of tautline and half hitches used to tie down planes. They aren't the most straightfor-

ward combination of knots for infrequent users. Ratchet straps are more user friendly, but they are not appropriate for all applications. A rough rule of thumb when using ropes is, breaking strain equals 3 X the safe working load. Certain knots can reduce the safe workload by as much as 50%. I have seen some 4-paks of ratchet straps (Wal-Mart) that have a safe workload of 175 pounds, probably rated on a dead load, not a bouncing and straining 800lb fueled up Rams S6 in a 50-60 mph squall. You get what you pay for. It might end up looking
