# The Building Column

The building column this month is a summary of the Building Committee report that will be presented at the October chapter meeting. Each member is encouraged to review this information and attend the meeting for a more in depth report of this important chapter project.

### BUILDING COMMITTEE CHAPTER BUILDING REPORT

AND

RECOMMENDATIONS

(Summary)

For the past six months the Chapter Building Committee has actively worked toward finding a feasible way to construct a facility that EAA Chapter 690 can call its "Home". This summary highlights the major accomplishments of this effort and also presents recommendations for future action by the chapter membership concerning this project.

#### **BACKGROUND**

The Gwinnett County-Briscoe Field Administration has offered an option for lease of an area  $60^{\circ}$  x  $420^{\circ}$  to EAA Chapter 690 at very favorable lease terms. This is a significantly larger area than needed by the chapter. Because of the favorable lease arrangement chapter members individually and in groups requested the sublease of portions of this area suitable for construction of private hangers. This has resulted in firm commitments by these parties to construct six  $50^{\circ}$  x  $60^{\circ}$  hangers. Bids have been received and a contractor chosen. The building committee has worked with this group and considers the building, contractor and cost to be suitable for the chapter facility. The private hanger group is very anxious to proceed with their program. Therefore, it is necessary for the chapter membership to take action by November 1, 1994 if the chapter is to join in this multiple building procurement program.

#### **BUILDING SITE**

The site plan for the chapter building is to have an 80' frontage on the west side of the new aircraft tie-down ramp on the northwest side of the airport. This location is the southern most portion of the 60'x420' leased land and directly faces the active taxiway/runway areas. Water and sewer services are nearby. Electrical service is also readily available. Fire protection is provided by a hydrant directly adjacent to the leased land. The building will be located at the edge of the newly constructed tie-down area. A new auto parking area with direct road access to Airport Road is adjacent to the north end of the leased land.

The layout of the entire hanger cluster has been reviewed with the Gwinnett County Fire Marshal and all fire code requirements can be met.

#### BUILDING

The building is a hanger type clear span design. It is 50' wide x 60' deep of all metal construction; steel framework with aluminum sides and roof. Other features include concrete floor, one or more personal doors, and 3" white vinyl faced insulation in roof and walls. Internal utility connections will be provided for sewer, water and electricity. The eve height is 16' which will accommodate a 12'x49' hanger door opening facing the tie-down ramp. A 4'x4' roughed in area in the upper rear wall will accommodate a vent fan (future). Gutters and downspouts will be provided at the eves.

#### INTERIOR (projected/future)

Finishing of the building interior is not included in the present phase of the building program. A preliminary study has been conducted, however, primarily for the purpose of utility service location. This preliminary layout locates the following facility areas along the rear wall of the building;

- a. Restroom (handicap accessible) 6'6" x 8'
- b. Food preparation Area 10' x 18'6"
- c. Tool storage area 10' x 10'
- d. Lounge/library/office 15' x 20'
- e. Bulk storage (tables, extra chairs, etc.) over tool storage and lounge areas with pull down stair
- f. Large meeting area remainder of the building

Only the lounge/library area would be heated and cooled but the restroom is heated.

#### COST

<u>Construction</u> - Six contractors were solicited for bids to construct seven identical individual hanger buildings. Five responded. The low bid was submitted by AEC Buildings, Lawrenceville, GA. for \$25,106.00. The hanger doors were not included in the bid request. This was intentional since the doors for the private hangers would not be as suitable for the chapter building uses as other designs. Also electrical service installation was unintentionally overlooked and will require negotiation.

Hanger door costs have been independently investigated and they vary from \$3500 to \$5000. It may be practical to design and construct our own doors. An immediate alternative is to "wall" the opening with the matching building siding already contractually supplied by the builder for covering the door.

Operation - Chapter building operating costs were determined from discussions with the Airport Administration, the Gwinnett County Tax Department and insurance agents. From this information a total annual operating cost of \$3080. (\$257. monthly average) was determined. Items included in this cost are land lease, county ad valor em tax, insurance, electricity and water/sewer.

#### **FINANCING**

<u>Construction</u> - Construction financing is presently available from four sources - the already established building fund, chapter member underwriters, contributions and the chapter treasury. Funds on hand from the building fund and contributions together with firm underwriter commitments total \$16,700. Funds from members willing to become underwriters if personal finance or other conditions permit total \$2,500. A transfer, with chapter membership approval, of funds from the chapter treasury total \$906. The total of the above funds is \$20,106.

Soliciting funds up to now has been handicapped because firm contract costs were not known and no goal could be set. The building contract cost is now known to be \$25,106., funding efforts to date have resulted in \$20,106 so we now have the need for an additional \$5000 in construction funds.

To realize the economic benefit of including the chapter building in the contract for the six private hangers, the \$5000 balance must be secured or firmly committed by November 1, 1994. Following are ways that this can be achieved:

- 1. Thirteen members are committed as underwriters in amounts of \$500. to \$1000. each. In addition, contributions from several members totals \$1500. The chapter membership is now 65. The remaining members not already committed need to become financially involved as underwriters or commit to a significant contribution.
- Presently committed underwriters may make an outright contribution or increase the amount of their commitment.

3. Members may know of individuals or business firms that would be interested in financially supporting the chapter building program. These members should make an effort to solicit contributions from these sources. These sources and all contributing members will receive recognition as supporters of this program through some permanent, highly visible means in the finished chapter building.


Operating - Financing the operational cost of the chapter building is dependent upon continuing, achievable funding sources available to the chapter throughout the year. Our current major funding sources include dues, pancake breakfasts and air fairs. Utilizing just these three programs with some additional effort in each, a total of \$4080. can be realized. To do this the membership must increase to 76 with dues established at \$30. per year(\$42280.); eight pancake breakfasts netting \$100. each, (\$800.); and one or more air fairs netting a total of \$1000.


This income of \$4080 exceeds the building operating cost by \$1000. This is funding remaining for all of the other annual chapter operating expenses from these sources. The chapter building, because of its size and location provides opportunities for rental to groups for meetings, dinners and other similar income producing activities not currently available to the chapter.

#### RECOMMENDATIONS

The Building Committee recommends the following:

- 1. Reserving the southernmost 80' of the land lease for use by EAA Chapter 690.
- 2. Join the private hanger owners in contracting for a 50' x 60' building as described herein, provided that on or before November 1, 1994 funds in the amount of \$25,106. have been secured or firmly committed.
- Planning should continue for finishing the interior and when approved, completion of these facilities be accomplished as soon as materials and manpower are available.
- Following completion of the initial building contract all responsibility for financial planning, implementation
  and accounting for the chapter building be assumed by the chapter officers.
