President Trump Announces Plans For ATC Privatization

The President Harshly Criticizes The FAA For 'Wasting' Billions Of Taxpayer Dollars

President Donald Trump has announced his plan for shifting Air Traffic Control from the FAA to a private, nonprofit corporation in a speech from the East Room of the White House, though few if any details were revealed

In the 11 minute speech, Trump criticized the FAA for continuing to use a system that is "stuck painfully in the past", and the billions of dollars he said have been "wasted" on its modernization efforts to bring NextGen online. The FAA has "totally failed ... they didn't know what they were doing," Trump said. "The FAA has been trying to upgrade our nation's air traffic control system for a long period of years. But after billions and billions of tax dollars spent, and the many years of delays, we're still stuck with an ancient, broken, antiquated, horrible system that doesn't work. Other than that, it's quite good

"We are proposing to take American air travel into the future," Trump said. "Our plan will get where you need to go more quickly, more reliably and affordably."

Trump said that the infrastructure for the new system will be bid out, with the expectation of selecting "one great company that can piece it all together. Not many companies all over the United States like in the past when it came time to piece it together, it didn't work."

Trump said that the nonprofit formed to run Air Traffic Control would be "self financing." A "new entity that will not need taxpayer money" for its operation. He said that the plan would mean a reduction in airfares, because 20 percent of the price of a ticket would not be going to the federal government for air traffic control. He added that the plan would mean more stability and growth opportunities for the controllers themselves, as the "best equipment in the world." He also promised continued support for smaller airport, and that the privatized system would support the thousands of jobs associated with aviation in the U.S.

Transportation Committee Chairman Bill Shuster (R-PA) and Transportation Secretary Elaine Chao were among those joining Trump on stage for the announcement. There were also several airline executives in the room, as well as representatives of passenger advocacy groups and controller and pilot unions, all of whom, he said, strongly support privatization. Noticeably absent from the East Room stage was FAA Administrator Michael Huerta.

"If we adopt these changes, Americans can look forward to cheaper, safer and faster travel," Trump concluded. "And ... you won't have to sit on the tarmac or circle for hours and hours over an airport, which is very dangerous, before you land."

The FAA will continue to "focus firmly on what it does best ... safety."

EAA Joins Other GA Groups Opposed To White House ATC Privatization Plan

User Fees A Main Funding Pillar Of Plan That Is 'Solution In Search Of A Problem'

EAA has joined other general aviation groups in opposing the measures outlined by the White House for reform of the nation's air traffic control system, telling the administration that dismantling the current system will devastate GA while not accomplishing the desired goals of efficiency and technological improvements.

A letter to President Trump opposing the "Principles for Reforming the U.S. Air Traffic Control System" was signed by EAA and 15 other general aviation organizations. The letter states the groups' "very real and long-standing concerns, which include but are not limited to user fees. These concerns are based on our operating experiences in these foreign systems and impact they have had on general aviation."

The White House principles statement supports removing air traffic operations from Federal Aviation Administration control and giving them to a new, non-profit entity that would be exempt from congressional oversight. In addition, the principles statement advocates for ending fuel excise taxes and creates a system that would make it self-sufficient through the collection of user fees to cover both the costs of operation and recapitalization expenses.

The statement also specifically bars review or relief by Congress or the courts regarding any user fees that might be imposed by the ATC corporation. EAA has long been opposed to user fees for general aviation.

"The White House principles make a gross misrepresentation that the air traffic control system is broken, but the facts don't support the claim," said Jack J. Pelton, EAA CEO/Chairman. "This proposal is a solution in search of a problem. EAA supports modernization of the American airspace system, and progress is happening with the input of all the system's stakeholders. This new plan would do nothing to solve any current technology or efficiency issues, while undermining the world's most extensive general aviation system and disrupting the world's largest and safest air traffic control system. It is a bad idea, and EAA will continue to state that to those in aviation, Congress, and the public."

The GA group letter notes that the U.S. air traffic control system is the best in the world, moving more aircraft, more safely and efficiently, than any other country. Working with Congress, aviation stakeholders have been able to ensure that the ATC system operates for the public benefit, providing access for all stakeholders to airports, heliports and airspace, and encouraging competition and innovation. The letter also asks for ample opportunity for all stakeholders and citizens to carefully review, analyze and debate any proposed legislation changing the governance and funding for air traffic control.

Many of the White House principles are based on the Aviation Innovation, Reform, and Reauthorization (AIRR) Act that was shelved by the full House of Representatives and never taken up in the Senate last year. In April, EAA board member Joe Brown testified to the House Transportation and Infrastructure Committee that privatizing air traffic control services was "deeply troubling" and would not benefit the public.



Total Solar Eclipse from Coast to Coast August 21, 2017

On Aug. 21, a total solar eclipse will sweep across the continental United States for the first time since 1918. Astronomers are calling it the Great American Eclipse. Beginning at 10:15 a.m. Pacific Daylight Time on the Oregon coast and heading east like an accelerated sunset-in-reverse, what's known as the path of totality will cut a 60-mile-wide arc across Idaho, Wyoming, Nebraska, Missouri, and Tennessee before crossing the South Carolina coast an hour and a half later. Within this arc, the moon will pass before the sun, and day



will suddenly become night. Temperatures will drop, birds will stop singing, and stars will become visible. Solar astronomers stationed at strategic locations at the center of the arc, where totality will last about two-and-a-half minutes.
